

I along with associates looked at a piece of land which we understood belongs to the City in the South en of Africville known as the Tulley Lot.

We think thispiece of land could be suitably used for the purpose of constructing small ships Providing we could get it from the City along with the Water Lot which they own in front of this Land.

If the City would let us know under what conditions we could have it, we would have a survey made of the Water in front of the land, so that we would be sure there was sufficient depth of water to launch the ships without going to too great expense preparing launch ways

our idea would be to commence immediately the construction of some ships and in all probability would be able to give employment to fifty or sixty hands including the necessary number of ship carpenters if we could get them and we know of no reason why this should not be possible in Hallfax.

We trust you will give us an early answer as we would like to get to work.
