# SUBJECT: 2020 Regional Watersheds Advisory Board Meeting Schedule

### <u>ORIGIN</u>

It is the practice for the Regional Watersheds Advisory Board (RWAB) to adopt a schedule of meetings for the upcoming year.

#### LEGISLATIVE AUTHORITY

Administrative Order 1, *Respecting the Procedures of the Council,* Regional Watersheds Advisory Board Terms of Reference:

The Board shall meet monthly or as required to conduct the business of the Board. Additional meetings may be schedule at the discretion of the Chair in consultation with the Clerk's Office.

#### RECOMMENDATION

It is recommended that Regional Watersheds Advisory Board approve the proposed 2020 meeting schedule as outlined in Attachment 1 of this report.

#### BACKGROUND

In accordance with the Regional Watersheds Advisory Board Terms of Reference, the Board shall meet monthly or as required to conduct the business of the Board. The Board meets the 2<sup>nd</sup> Thursday of each month from 5:00 p.m. to 7:00 p.m. in the HEMDCC Meeting Space, Main Floor Alderney Gate, 60 Alderney Drive, Dartmouth.

#### DISCUSSION

The proposed 2020 schedule provided as Attachment 1 of this report, proposes 11 regular meetings and takes into account statutory holidays, March Break, meetings of Federation of Canadian Municipalities (FCM), Nova Scotia Federation of Municipalities (NSFM) and Halifax Regional Council. The approval of this schedule will allow members of Council, staff and the public to be notified and plan in advance for meetings. The Chair of the Board, with input from staff, has the authority to cancel a scheduled meeting should it be deemed necessary. A special meeting for a time sensitive matter may be called with appropriate notice, provided it is done in accordance with the HRM Charter and Administrative Order One.

#### **FINANCIAL IMPLICATIONS**

There are no budget implications associated with the recommended course of action.

#### **RISK CONSIDERATION**

A delay in approval could result in additional delays for other HRM Committee meeting schedules, as the Regional Watersheds Advisory Board schedule may impact the timing of other Committee meeting times and dates.

The 2020 meeting schedule for the Board, once adopted, is posted to the HRM calendar at Halifax.ca to enable members of the public and media to have access to the meeting schedule, agendas and reports.
