# **COVID-19 Update**

Please **DO NOT call 9-1-1 for non-emergency purposes**. Residents can **call 3-1-1** and police non-emergency line at **902-490-5020**.

Access **211** to find non-municipal community and social services available in your area. This service is available 24/7 in 140 languages.

Nova Scotians should not leave the province and **only leave home for essential items and services**. If possible, one person per family should be designated to do these tasks.

Nova Scotia will now offer COVID-19 testing to anyone who develops a fever, or a new or worsening cough. People must still call **811** to arrange a testing time.

A temporary assessment centre has been opened in North Preston to serve the communities of North Preston, East Preston, Lake Loon and Cherrybrook. People must still call **811** to arrange a testing time.

### **Key Activities Underway**

- All Nova Scotia public schools will remain closed until at least May 1<sup>st</sup>.
- There is a **Province wide** burn ban in place.
- There are virtual special meetings of Regional Council on April 9<sup>th</sup>, April 14<sup>th</sup> and April 28<sup>th</sup>, each starting at 1:00 p.m. The purpose of these special meetings is to deal with matters as determined by the CAO and Mayor. Residents can click the video link on Halifax.ca to "watch on web" and enter the webcast by selecting 'join anonymously'.
- All customer service centres and Planning & Development counter services are closed to the public.
   Services continue to be available online.
- Legal documents and appeals will no longer be accepted in person at City Hall. Residents are asked to fax these documents to 902-490-4208 or send by email to clerks@halifax.ca.
- All Halifax Public Library branches are closed until further notice.
- On weekdays, a 30 percent reduction in bus service is being targeted. Regular weekday schedules will continue on some routes, while other routes are operating on their Saturday schedules during weekdays. Three routes have no service. Weekend service will not be impacted. Details regarding route changes can be found here.
- Safety-related aspects of the Nova Scotia Motor Vehicle Act continue to be enforced.

- Parking fees at meters have been waived and HotSpot fees will be set to zero until further notice.
- All municipal parks, beaches, playgrounds, sports fields/courts, and many trails are closed until further notice.
- All municipally owned recreation facilities, community centres and arenas are closed.
- Applications for Rezoning, Municipal Plan amendments, Development Agreements, or Downtown Halifax Site Plan Approvals can be submitted via email to Carl Purvis

- An <u>online form</u> has been created for all permit and sub-division application intakes.
- Halifax Water will maintain critical services.
- Halifax Water Customers facing economic impacts due to the COVID-19 situation that will cause them to struggle with paying their accounts are asked to please contact Halifax Water's Customer Care Centre at customercare@halifaxwater.ca or 902-420-9287 to discuss payment arrangements.

## **Emerging Issues and Next Steps**

- The application deadline for Community Grants Programs as well as the Tax Relief for Non-Profit Organizations Program have been extended until May 15<sup>th</sup>.
- The municipality is currently looking at alternative payment options related to property taxes due April 30, 2020.
   Decisions will be communicated to taxpayers in advance of the deadline and

will focus on addressing the needs of businesses and residents. Questions can be sent to proptax@halifax.ca.

- The 2020 Volunteer Awards are postponed until further notice.
- The Youth Live Enviro Depot at 947
   Mitchell Street is closed until further notice.
- The application deadline for Grants to Professional Arts Organization program has been extended until April 15<sup>th</sup>.
- The collection of residential refrigerant gas removal (CFCs) service has been suspended until further notice.
- Otter Lake Waste Facility is not accepting cash as a payment method at this time.
- Halifax Regional Police will proactively release updates each Monday and Friday to the public and media in relation to violations under the Nova Scotia Emergency Management Act and Health Protection Act related to COVID-19.

#### **Under the State of Emergency**

Nova Scotia borders will tighten to travellers and all entry points (land, sea, air) will be closely managed. Anyone entering the province will be stopped, questioned, and told to self-isolate for 14 days. Exemptions for cross-border travel include healthy workers in trades and transportations sectors who move goods and people (e.g. truck drivers); healthy people going to work (e.g. health-care workers); and people travelling into the province for essential health services (e.g. chemotherapy treatment).

All municipal and provincial parks, beaches, and tourist attractions are closed.

If Nova Scotians and businesses do not practice social distancing and self-isolation, they will face

fines of \$1,000 for individuals and \$7,500 for businesses. Multiple fines can be given each day an individual or business fails to comply. Police can also enforce offences under the Emergency Management Act. For example, fines for charging higher than fair market prices for goods and services.

Landlords are not permitted to change locks or seize property of businesses who cannot pay rent, if the business closed directly because of COVID public health orders.

There are several groups who are essential and exempt from gathering limits but must still maintain social distancing and other public health protocols.

Law enforcement enforce orders under the Emergency Management Act and Health Protection Act. If you are aware of someone not following provincial direction, have a conversation with them first – they may need help.

# **April 8<sup>th</sup> Municipal Update**

## **Municipal Budget**

 A number of measures the municipality has taken to protect our staff and the public, as well as support businesses, has resulted in a decrease to revenue. Bus fares from Halifax Transit alone are around \$3 million per month. By adding forgone parking revenue and rent

deferrals we are seeing material changes to the budget.

 Finance staff are assessing the operating and capital budget to see what can be delivered this year, and what can be deferred. We are also continuing to have conversations with the province about infrastructure spending and the possibility of stimulus programs. It is anticipated that staff will be back with a recast budget in late May, but as with all things COVID-19 related, that timeline is subject to change.

#### Tax Deferral

- The municipality continues to work the Nova Scotia Federation of Municipalities and the Association of Municipal Administrators on options for a tax deferral program to help businesses and individuals that have been impacted by COVID-19. Finance staff will present a report to Regional Council for consideration on April 14.
- It is critical that those who can pay their taxes continue to do so in a timely fashion. Tax revenue makes up 82% of the municipality's revenue. Operating expenses total approximately \$100 million per month and, while the municipality is financially sound, a significant amount of cashflow is required to provide services, pay vendors and suppliers and continue with capital projects that support the economy.

#### **Domestic Violence**

 The municipal Public Safety Office is advising residents that help is available for those experiencing or at risk of domestic violence. Following public health direction to stay home is crucial,

- but we know, that home is not always safe for everyone.
- Available help for women and their children takes many forms, from supportive connections and outreach over the phone, information about safety planning and resources, to provision of emergency shelter and second-stage housing. In Halifax, organizations serving women continue to offer a wide range of support, guidance, and shelter to women and their children during this time.
- If you are experiencing domestic abuse, know that you are not alone. There's help available to you.

# Municipal Services on Easter Long Weekend

The Halifax Regional Municipality is advising residents of the following municipal service level adjustments over the upcoming Easter long weekend:

## **Solid Waste Collection and Facility Hours**

No municipal solid waste collection services will take place on Good Friday, April 10. Curbside collection of garbage, organics or recyclables normally scheduled for Friday, April 10, will occur instead the next day, Saturday, April 11. Residents are reminded that collection services can begin as early as 7 a.m.; to ensure pick-up,

residents may place materials curbside the evening prior to collection day.

Regular curbside collection services will occur on Easter Monday, April 13.

The Otter Lake Waste Management Facility, the municipal recycling plant and municipal composting facilities will be closed on Good Friday, April 10 and Easter Sunday, April 12, but will be open for regular operating hours on Saturday, April 11 and Easter Monday, April 13.

The Household Special Waste Depot in Bayers Lake is closed until further notice.

#### **Halifax Transit Bus and Ferry Services**

Halifax Transit buses will be operating on holiday service on Good Friday, April 10, as well as Easter Sunday, April 12. Please note there will be no ferry service in operation on Good Friday, however, holiday ferry service will be provided on Easter Sunday. Halifax Transit will operate on its current, reduced weekday service on Monday, April 13. ## We urgently need your help.

Additionally, thanks to the donation bin business, more than 100 million pounds of textiles are diverted from landfill annually.
