

### **2. Architectural Importance**



- In the late 1800s, an unprecedented number of new homes were needed
- The Late Victorian Plain (1880-1915) style was a popular design choice
- Emergence of the Halifax Box style
- Subject site is a good representation: two-storey box shape, bay window, asymmetrical façade, wood shingles and modest detailing




