SUBJECT: Tax Relief for Non-Profit Organizations: Fiscal Year 2020-2021. Part 1 –

**Proposed Amendments to Schedules** 

# **ORIGIN**

March 18, 2014 – Implementation of Administrative Order 2014-001-ADM Respecting Tax Relief to Non-Profit Organizations. The application for additions to the program is advertised as November 30<sup>th</sup> to accommodate the annual budget process and the deadline for renewals is March 31<sup>st</sup>. In response to the COVID-19 pandemic the deadline was extended to May 15<sup>th</sup>, 2020.

May 12, 2020 – Approval of Administrative Order 2020-009-ADM Respecting Recommendations for the Allocation of Grants and Withdrawals from Reserves During COIVID-19. The purpose of the policy is to expedite the approval process by temporarily suspending the need for Council to receive recommendations from those Standing Committees named in the policy's schedules, including the Grants Committee which is a sub-committee of the Audit & Finance Standing Committee.

## LEGISLATIVE AUTHORITY

- Halifax Regional Municipality Charter, S.N.S. 2008, c.39
  - **79A** (1) Subject to subsections (2) to (4), the Municipality may only expend money for municipal purposes if
    - (a) The expenditure is included in the Municipality's operating budget or capital budget or is otherwise authorized by the Municipality...

- Administrative Order 2014-001-ADM Respecting Tax Relief for Non-Profit Organizations.
  - **5A** If the lease or license respecting the real property that is the subject of an application for the renewal of tax relief has expired,
  - (a) The lease or license must have been expired for no more than three (3) years as of the March 31 immediately preceding the start of the fiscal year for which tax relief is sought; and
  - (b) The applicant must provide to the Municipality written confirmation from the licensor or lessor that
    - (i) the lease or license contains a provision allowing the lessee or licensee to remain in possession after the lease or the license expires, or
    - (ii) the lessor or licensor consents to remain in possession of the real property.
  - 7C (1) If an application for the renewal of tax relief is late a late application and the application for the previous year was on time, the amount of tax relief for each property that was filed late shall be reduced in accordance with subsection 2 of this section.
  - (2) If the subsection 1 applies, the amount of tax relief for each property that was filed late shall be reduced as follows:
    - (a) if the application is received on or before June 30th, there shall be no reduction: or
    - (b) if the application is received after June 30<sup>th</sup> and on or before September 28<sup>th</sup>, there shall be a reduction of 1/365 for every calendar day such application is later after June 30<sup>th</sup>, to a maximum of two thousand five hundred dollars (\$2,500) per property; or
    - (c) if the application is received after September 30<sup>th</sup>, there shall be a reduction 1/365 for every calendar day such application is late after June 30<sup>th</sup> to a maximum of five thousand dollars (\$5,000) per property.
  - (3) If June 30<sup>th</sup> or September 28<sup>th</sup> falls on a Saturday or Sunday, the deadline shall be extended until the next business day.
- Administrative Order 2020-009-ADM Respecting Recommendations for the Allocation of Grants and Withdrawals from Reserves During COVID-19.
- Administrative Order 54 Respecting Procedures for Developing Administrative Orders(Administrative Order 54)
  - **5.** All Administrative Orders, amendments to Administrative Orders, and repeal of Administrative Orders require at least seven (7) days notice to all of Council Members in accordance with subsection 59(1) of the *Halifax Regional Municipality Charter*.

## **RECOMMENDATION**

It is recommended that the Grants Committee recommend that Regional Council:

 Suspend the rules of Procedures under Administrative Order One, the Procedures of the Council Administrative Order, under Schedule 2 the Audit and Finance Standing Committee Terms of Reference;

- Approve renewal of tax relief for 763 properties as listed in Schedules 26 to 30 as itemized in the Information Report "Tax Relief for Non-Profit Organizations Program – Fiscal Year 2020/2021 Part 2 Proposed Renewals" dated July 31, 2020, effective April 1, 2020 unless stated otherwise, at an estimated combined cost of \$4,295,800 from Operating Account M311-8006;
- 3. Approve an increase in level of tax relief for two (2) properties at an estimated incremental cost of \$4,600 from Operating Account M311-8006;
- Approve the addition of forty-six (46) properties to Administrative Order 2014-001-ADM as detailed in the Discussion section of this report at an estimated combined cost of \$96,700 from Operating Account M311-8006;
- 5. Approve a grant equivalent to the award previously received under the tax relief program for three (3) properties at an estimated combined cost of \$30,100 from Operating Account M311-8006; and
- 6. Adopt the amendments to Administrative Order 2014-001-ADM as set out in Attachment 2 of this report, including
  - (a) adopting Attachments A through E attached to Attachment 1 to repeal and replace Schedules 26, 27, 28, 29 and 30 of the Administrative Order; and
  - (b) temporarily suspending the pro-rated deductions for late renewals in fiscal year 2020/2021 due to Covid-19.

# **BACKGROUND**

Under the Non-Profit Tax Relief Program (Administrative Order 2014-001-ADM), eligible non-profits and charities can apply for tax relief and be placed on one of five schedules for tax relief. The five schedules provide tax reductions at the following levels:

- Reducing the commercial tax rate to the residential tax rate (Schedule 29).
- a 25% reduction in property taxes, at the residential rate (Schedule 30),
- a 50% reduction in property taxes, at the residential rate (Schedule 28),
- a 75% reduction in property taxes, at the residential rate (Schedule 27), and,
- a 100% reduction in property taxes (Schedule 26),

In accordance with *Administrative Order 54*, any amendment to an Administrative Order requires a Notice of Motion to Regional Council at least seven (7) days prior to debate.

# **DISCUSSION**

#### SUMMARY OF PROPOSED CHANGES

In addition to the proposed renewals, there are changes proposed to the Schedules in fiscal year 2020 included as Attachment A, B, C, D and E in Attachment 1 of this report. Further, there are three (3) awards proposed for expired leases removed from the program.

 The removal of the Dartmouth Family Centre, 107 Albro Lake Road, Dartmouth and the Halifax Transition House Association, Halifax, from Schedule 27, Harbour Lodge #53 Royal Andeluvian Order of Buffaloes, 2 Wentworth Street, Dartmouth, from Schedule 29, and Central Dartmouth Housing Cooperative, from Schedule 30 effective April 1, 2020, as detailed in Table 1 of this report;

- 2. The removal of the **Atlantic Marksmen Association**, 2965 Old Guysborough Road, Devon, from Schedule 26 and recognize tax relief for the mandatory public safety zone under Schedule 29;
- 3. The removal of the **Community Care Network**, 2425 Maynard Street, Halifax, from Schedule 28 and the addition of this same property on Schedule 26, effective April 1, 2020, at an estimated additional cost of \$4,300.
- 4. The removal of **Sheet Harbour Ground Search and Rescue**, 44 Behie Road, Sheet Harbour, from Schedule 28 and the addition of this same property on Schedule 26, effective April 1, 2020, at an estimated additional cost of \$300.
- 5. The addition of **Fall River Minor Football Association**, 1018 Fall River Road, Fall River; **Kinap Athletic Club**, a Portion of PID 4049884 181 Greenborough Drive, West Porters Lake and **Riverline Activity Centre Association**, 80 Dutch Settlement Road, Dutch Settlement to Schedule 26, effective April 1, 2020, at an estimated combined cost of \$11,600.
- 6. The addition of **Yarmouth Association for Community Residential Options**, 33 Barbara Drive, Dartmouth. to Schedule 27, effective April 1, 2020, at an estimated cost of \$2,500.
- 7. The addition of the **Sheet Harbour and Area Chamber of Commerce**, a Portion of PID 40328528 22404 Highway 7, Sheet Harbour, to Schedule 28, effective April 1, 2020, at an estimated cost of \$5,900.
- 8. The addition of MusGo Riders Cooperative Limited, 325 Porters Lake Station Road, Porters Lake; the Nova Scotia Nature Trust, 81 Prince Albert Road, Dartmouth; Nova Scotia Regional Tennis Development Association, 50 Verdi Drive, Bedford, and the Sable Island Institute, a Portion of PID 00001248 5718 Point Pleasant Drive Halifax, to Schedule 29, effective April 1, 2020, at an estimated combined cost of \$54,200.
- 9. - 10. A grant equivalent to awards previously received under the tax relief program to the Association of Special Needs Recreation, 82 Cobblestone Lane, Musquodoboit Harbour; Sackville NS Lions Club, 101 Old Beaver Bank Road, Lower Sackville; and the South End Daycare, 5594 Morris Street, Halifax, at an estimated combined cost of \$30,100 from Operating Account M311-8006.
- 11. Records management changes.

If approved, the level of tax relief for three (3) properties would be amended and a combined total of forty-five (45) properties would be added to the program in fiscal year 2020.

# **REMOVAL FROM TAX RELIEF PROGRAM**

In 2020, there are sixteen (16) properties to be removed from the tax relief program as listed below in Table 1.

The Halifax Transition House Association's new premises located in Dartmouth remains in the tax relief program.

# **AMENDMENT TO SCHEDULE 26 - 100% Exempt**

#### Atlantic Marksmen Association, 3967 Old Guysborough Road, Devon

The property leased by the Association from the Nova Scotia Department of Natural Resources is used as an outdoor shooting range. The property is assessed both Commercial (clubhouse) and Resource. When added to the tax relief program it was recognized that the acreage assessed as Resource was required by legislation to create a public safety zone for the outdoor shooting range and this portion of the property was tax exempted on Schedule 26 while the clubhouse was awarded a Conversion from the Commercial to Residential rate on Schedule 29. The presentation of one (1) property with only one assessment account number on two schedules has resulted in confusion and distorts count. Therefore, if approved, the proposed removal from Schedule 26 is considered a housekeeping matter and the club will continue to receive the same level of tax relief as originally awarded but listed in only one Schedule.

It is recommended that the exemption from Resource tax for the Atlantic Marksmen Association, 3967 Old Guysborough Road, Devon, be recognized and reported with their tax relief under Schedule 29.

## RECOMMENDED CHANGE IN LEVEL OF TAX RELIEF

The 2020 tax relief program received two (2) applications requesting an increase in level of tax relief. These properties are already in the tax relief program and included in the tally of renewals. If approved, the <u>additional</u> cost (the cost of an increase over the existing tax grant) is shown in the individual recommendations.

# 1. Community Care Network Society, 2425 Maynard Street, Halifax

Two (2) properties owned and operated by the Society were added to the tax relief program under former By-law T-200: the food and furniture bank operating out of 2415 Maynard Street was added to Schedule 26 and the abutting property located at 2425 Maynard Street used for employment training was added to Schedule 28. The Society has requested that the level of tax relief for 2425 Maynard Street be increased because the government-funded employment training program ceased, and the facility is now used in relation to the food and furniture bank. The property located at 2425 Maynard Street, Halifax, is assessed Commercial and total tax is \$25,900.

It is recommended that the Community Care Network Society, 2425 Maynard Street, Halifax be removed from Schedule 28 and added to Schedule 26, effective April 1, 2020. The estimated <u>additional</u> cost is to the tax relief program is \$4,300.

# 2. Sheet Harbour and Area Ground Search and Rescue, 44 Behie Road, Sheet Harbour

In 2019, the property owned by the volunteer search and rescue team was added to Schedule 28 pending construction and operation of a storage garage for vehicles owned by the society. The undeveloped land did not provide any program or service to the public. The land is assessed as Resource (total tax \$600). The garage has been constructed but an inspection and occupancy permit could not be issued due to COVID-19 public health restrictions.

It is recommended that the Sheet Harbour Ground Search and Rescue Team, 44 Behie Road, Sheet Harbour be removed from Schedule 28 and added to Schedule 26, effective April 1, 2020. The estimated additional cost to the tax relief program is \$300.

**Note:** As of the date of this report the property has not been re-assessed to reflect the value of the building and the classification amended from Resource to Commercial. The cost of municipal tax relief is expected to increase.

## PROPOSED ADDITIONS TO THE PROGRAM

In 2020, there are forty-six (46) proposed additions to the tax relief program. A summary by proposed level of tax relief is shown below in Table 2.

# 3. Fall River Minor Football Association, 1018 Fall River Road, Fall River [Referred from 2019]

Incorporated in 2005, the club provides instruction and competition for children and youth. Operations are primarily sustained by player registration fees and fundraising. In 2017, the society acquired the property from HRM under Administrative Order 50 at less than market value for use as a clubhouse. Hourly rentals are available, and the venue hosts a local seniors club and a popular "Fall River Community Jam Session". In 2019 the Association made application for a relief program but it was deferred to 2020 because the conveyance had not closed the applicant was not the title-holder and the property remained tax exempt on the municipal tax roll. In 2020 the property is assessed as Commercial (total tax \$4,400).

It is recommended that the Fall River Minor Football Association, 1018 Fall River Road, Fall River be added to Schedule 26, effective April 1, 2020, at an estimated cost of \$4,400.

# 4. <u>Kinap Athletic Club/Halifax Regional Municipality, a Portion of PID 40469884</u> <u>181 Greenborough Drive, West Porters Lake</u> – Lease Expires: 30/10/2027 [Referred from 2019]

Incorporated in 1984, the Club offer seasonal recreational and competitive canoeing and kayaking on HRM park land abutting Porter's. In 2018, the Club entered into a 10-year less than market value land lease agreement which clarified ownership of the on-site infrastructure, the area of land

to be leased, and public access to the waterfront<sup>1</sup>. The Club applied for tax relief in 2019 but as of the date of application the subject property was not assessed as taxable on the municipal tax roll: the application was deferred to the 2020 program. The lease includes a clubhouse building and approximately 8,047 square feet of land. The leased premises are assessed Commercial (total tax \$3,950) and Resource Exempt.

It is recommended that the Kinap Athletic Club, a Portion of PID 40469884 -181 Greenborough Drive, West Porters Lake be added to Schedule 26, effective April 1, 2020, at an estimated cost of \$3.950.

## 5. Riverline Activity Centre Association, 80 Dutch Settlement Road, Dutch Settlement

Incorporated as a society in 1994, the Association operates a community hall used primarily for leisure activities and private rentals. In 2018, the Association acquired title to the property from HRM at less than market value under Administrative Order 50. The property has been assessed Commercial (total tax \$3,250).

It is recommended that the Riverline Activity Centre Association, 80 Dutch Settlement Road, Dutch Settlement be added to Schedule 26, effective April 1, 2020, at an estimated cost of \$3,250.

# Schedule 27 - 75% Reduction in Property Taxes, at the Residential Tax Rate

# 6. Yarmouth Association for Community Residential Options, 33 Barbara Drive, Dartmouth

Incorporated in 1989, the Association is a registered non-profit society and Canadian charity that provides community-based residential services for mentally and physically challenged persons on behalf of the Nova Scotia Department of Community Services. In 2019, three (3) residential properties were granted tax relief under Schedule 27<sup>2</sup> each accommodates 3 to 4 persons. In 2018, the Association acquired a small residential property which is assessed Residential (total tax \$3,280).

It is recommended that the Yarmouth Association for Community Residential Options, 33 Barbara Drive, Dartmouth be added to Schedule 27, effective April 1, 2020, at an estimated cost of \$2,500.

## Schedule 28 - 50% Reduction in Property Taxes, at the Residential Tax Rate

# 7. <u>Sheet Harbour and Area Chamber of Commerce/Halifax Regional Municipality, a Portion of PID 40328528 - 22404 Highway 7, Sheet Harbour</u> – Lease Expires: 31/12/2029

Incorporated as a non-profit society in 1982, the Chamber's purpose is to promote and support the economic and social development of the area from East Ship Harbour to Ecum Secum on the Eastern Shore. The organization's revenues are primarily government grants supplemented by fundraising and membership dues. Occupancy of the MacPhee House (c.1875), a municipally registered heritage property, dates back to the mid-1980's when the property was moved to its current location to avoid demolition. In 2004, HRM acquired title to the premises from the Province of Nova Scotia and executed a Memorandum of Understanding with the Chamber to

continue operation of a seasonal Visitor Information Centre. The premises also accommodate a small collection owned by the Sheet Harbour Historical Society. In November 2019 Council approved a 10-year less than market value lease agreement that includes MacPhee House and accessory buildings. The MacPhee House and accessory buildings are assessed Commercial (total tax \$7,070) Partial tax relief is recommended to reflect the property's partial use for a seasonal community museum.

It is recommended that Sheet Harbour and Area Chamber of Commerce, a Portion of PID 40328528 – 2204 Highway 7, Sheet Harbour be added to Schedule 28, effective April 1, 2020, at an estimated cost of \$5.900.

**Note:** The proposed addition of the Sheet Harbour and Area Chamber of Commerce is recommended in relation to the operation of a community museum operated by the Sheet Harbour Historical Society under a sub-lease agreement with the Chamber. If approved, the addition of the Sheet Harbour Historical Society to HRM's Interim Community Museum's Grant Program in 2020 would result in a modest operating grant and the Society's proportional share of property tax is an eligible operating expenditure.

## Schedule 29 – Conversion to Residential Tax Rate

## 8. MusGo Rider Co-operative Limited, 325 Porters Lake Station Road, Porters Lake

Incorporated in 2012, the cooperative provides wheelchair accessible transportation and charter services along the Eastern Shore. Operations are sustained by municipal and provincial transit subsidies with modest earned revenues from charters, grants and rentals. In 2018, the cooperative purchased a former residence in Porters Lake. The premises serve as an administrative office for the coop, the MusGo Rider Valley-Sheet Harbour Co-operative (#3296525), the Eastern Shore Musquodoboit Valley Literacy Network (#3095221) and a for-profit private practice, Nova Salutum. In 2019, Property Valuation Services Corporation corrected the assessment classification to Commercial to reflect a non-residential use (total tax \$9,530). Because the premises serve primarily as an office building, including leases to unrelated third parties, a Conversion from the Commercial to Residential rate is recommended.

It is recommended that MusGo Riders Co-operative Limited, 325 Porters Lake Station Road, Porters Lake be added to Schedule 29, effective April 1, 2020, excluding any portion of the premises leased, licensed otherwise occupied by a private or business interest, at an estimated cost of \$6,400.

**Note:** An area of 105 sf representing approximately 5% of the total building area is occupied by a private/business interest and excluded from tax relief.

## 9. Nova Scotia Nature Trust, 81 Prince Albert Road, Dartmouth

The Trust is a registered Canadian charity that acquires lands and conservation easements to provide stewardship in protecting such lands from development or neglect. Operations are sustained by donations, membership fees, grants, fundraising, and investment earnings. In 2016 the Trust acquired a former residence a portion of which that has been converted for office and meeting space. Property Valuation Services Corporation has corrected the assessment

classification to reflect the use of the premises: the property is assessed Commercial tax (\$7,010) and Residential (tax \$2,480). Although the premises are used exclusively as an office building the assessment classification of a former rental unit has not been changed.

It is recommended that the Nova Scotia Nature Trust, 81 Prince Albert Road, Dartmouth be added to Schedule 29, effective April 1, 2020, at an estimated cost of \$4,600. In 2020 the tax relief will exclude that portion of the premises assessed as Residential.

**Note:** In 2021, it is anticipated that Property Valuation Services Corporation will correct the Residential assessment to Commercial to accurately reflect the property's non-residential use: therefore, the cost of HRM's operating grant will increase in subsequent years.

# 10. Nova Scotia Regional Tennis Development Association, 50 Verdi Drive, Bedford

The Association incorporated in 2017 for the purpose of acquiring a private tennis facility. The former domed indoor tennis facility has been re-developed and expanded to accommodate instructional programs, recreational and competitive tennis, coaching certification, and tournaments. In 2020, the total tax is \$61,240<sup>4</sup>. The Association requests full exemption (Schedule 26) based on an assertion that the facility is comparable to that owned by Soccer Nova Scotia. The staff review concludes that HRM's relationship with the Association is not the same as the Municipality's relationship with Soccer Nova Scotia:

- HRM owns the land and has executed a long-term land lease agreement with Soccer Nova Scotia wherein the building reverts to municipal ownership in the event of termination or upon expiry with no renewal;
- HRM owns the abutting all-weather field and has executed a Management Agreement with Soccer Nova Scotia to schedule and service this public amenity; and
- HRM and Soccer Nova Scotia exchange access to both the indoor and outdoor amenities by mutual agreement.

In contrast, the Nova Scotia Regional Tennis Association has a Contribution Agreement wherein the Municipality has negotiated a discounted facility rental agreement for HRM tennis programs in exchange for a one-time capital grant. The concession to HRM is not in perpetuity but rather is to be commensurate with HRM's capital grant. If approved, the Association would pay an estimated \$18,920 in tax for fiscal 2020 (See: Table 2 for comparison with other tennis clubs).

It is recommended that the Nova Scotia Regional Tennis Development Association, 50 Verdi Drive, Bedford be added to Schedule 29, effective April 1, 2020, effective April 1, 2020, at an estimated cost of \$42,300.

**Note:** Once an occupancy permit is issued a re-assessment of the property is anticipated and may increase substantially in value based on the scale of capital investment.

# 11. <u>Sable Island Institute/Halifax Regional Municipality, a Portion of PID 00001248 - 5718 Point Pleasant Drive, Halifax</u> – License Expires: 28/02/2025

The Institute is incorporated as a not-for-profit corporation under Industry Canada<sup>5</sup>. The group's mission is to support and promote the protection and conservation of the natural and cultural values

of Sable Island through collaborative research and education. Operations are sustained by donations, fundraising and project-specific grants. In 2018, the Institute entered into a one (1) year rental agreement with HRM that was extended for a further year and expired February 28, 2020. In November 2019 Council approved a 5-year license agreement but has also requested a staff report to determine the best use of the Lodge in relation to the goals of the Point Pleasant Park Comprehensive Plan<sup>6</sup>. As noted in the staff report the building has limited space for programming and operates primarily as an office. The licensed area is assessed Commercial (total taxes \$1,340).

It is recommended that the Sable Island Institute, a Portion of PID 00001248 - 5718 Point Pleasant Drive, Halifax be added to Schedule 29, effective April 1, 2020, at an estimated cost of \$900.

Further, it is recommended that municipal tax relief be reviewed pending Council's decision with respect to the <u>Point Pleasant Park Comprehensive Plan</u> and any change in the use or occupancy of the subject property.

# 12. Affordable Housing Association of Nova Scotia, 100 Pinecrest Drive, Dartmouth

Incorporated in 1990, the Association's mandate is to promote access and support to affordable housing throughout Nova Scotia and provides research and consulting services. The organization is sustained by federal and provincial funding. In 2019, the Association purchased a 12-unit apartment building. The property is assessed Residential (total tax \$6,400).

It is recommended that the Affordable Housing Association of Nova Scotia, 100 Pinecrest Drive, Dartmouth, be added to Schedule 30, effective April 1, 2020, at an estimated cost of \$1,600.

## 13. Compass Nova Scotia Co-Operative Homes Limited, Dartmouth and Lower Sackville

Incorporated in 2019, the cooperative was formed by the Community Housing Management Network<sup>7</sup>. The new cooperative's portfolio of properties was acquired through the merger of four (4) cooperatives located within HRM: Central Dartmouth Housing Co-Operative Limited, Chameleon Housing Co-Operative Limited (Lower Sackville), Lake City Co-Operative Limited, and Capeland Housing Co-Operative Limited. The cooperative has applied for the addition of thirty-three properties assessed Residential (combined total tax \$67,200). It is recommended that one (1) property be declined based on vacancy. If approved, acceptance of thirty-two (32) properties on Schedule 30 represents a combined total of sixty-six (66) dwelling units.

It is recommended that Compass Nova Scotia Co-Operative Homes Limited be added to Schedule 30, effective April 1, 2020, at a combined estimated cost of \$16,800.

**Note:** One (1) property located at 60 Spar Crescent, Dartmouth, is excluded from additions – the land is vacant and the recommendation is to decline in fiscal 2020.

# 14. Fallout Housing Co-Operative Limited – Halifax

Incorporated in 1982, the cooperative own and operate a portfolio of properties in Halifax. The properties are all assessed Residential (combined total tax \$16,400). If approved, acceptance of four (4) properties on Schedule 30 represents a combined total of eight (8) dwelling units.

It is recommended that Fallout Housing Co-Operative Limited 6187 Lawrence Street, 6193 Lawrence Street, 6023 Willow Street and 6326 Pepperell Street, Halifax, be added to Schedule 30, effective April 1, 2020, at a combined estimated cost of \$4,100.

# PROPOSED AWARDS BY RESOLUTION OF COUNCIL

The following organizations previously accepted into the program whose lease or license agreement with the Municipality have reached the end of the term. While these agreements generally meet the intent of the program's policy, they do not meet the technical requirements of Section 5A of Administrative Order 2014-001-ADM and have been removed from the Schedules that form part of the Administrative Order as required under Section 18. As an interim measure, Regional Council has approved the provision of tax relief by a resolution of the Council in the form of a grant.

# 15. <u>Association of Special Needs Recreation/Halifax Regional Municipality, 82 Cobblestone</u> Lane, Musquodoboit Harbour

The Association lease land for the purpose of a seasonal summer camp. The land license expired April 20, 2013. Although the Association has expressed interest in ownership there is an issue with access to the site over private property (the easement is in HRM's name). Negotiations continue but a long-term land lease may be the only viable option in the short-term. The total tax is \$810.

It is recommended that the Association for Special Needs Recreation be awarded a grant equivalent to full exemption under Schedule 26 of the tax relief program for fiscal year 2020. The estimated value is \$810.

# 16. <u>Sackville NS Lions Club/Halifax Regional Municipality</u>, 101 Beaver Bank Road, Lower Sackville

The Club lease land from HRM for the purpose of clubhouse which is also rented to local community groups and private parties for meetings and assorted fundraising and social events. The lease expired May 31, 2004. Subsequent to the lease expiry the development of a public multi-use trail (Sackville Greenway) alongside the Sackville River to the rear of the premises has implications in terms of public access. Negotiations are in progress with respect to the development of a trailhead and accessible public parking. The property is assessed Commercial (total tax \$13,610).

It is recommended that the Sackville NS Lions Club be awarded a grant equivalent to full exemption under Schedule 26 of the tax relief program for fiscal year 2020. The estimated value is \$13,610.

The abutting parcel of land leased from the Province of Nova Scotia by the Sackville NS Lions Club (Lot 2 Beaver Bank Road, Beaver Bank) is on Schedule 26.

# 17. South End Daycare/Halifax Regional Municipality, 5594 Morris Street, Halifax

The lease for the South End Daycare expired March 31, 2013. At their meeting of February 16, 2016, Regional Council deferred a decision with regard to negotiating a lease with the South End Daycare to transition the rental rate to market value pending: "...the preparation of a staff report regarding the opportunities and financial implications of establishing a Child Care Policy similar to Richmond BC to support the integration of not for profit daycares at below market rent into new and existing recreation facilities" (Minutes, Item 14.1.3, p. 7). The renewal of the lease is in abeyance pending the findings of the report and Council's decision. The property is assessed Commercial (total tax \$17,170).

It is recommended that the South End Daycare be awarded a grant equivalent to partial tax relief

under Schedule 27 of the tax relief program for fiscal year 2020. The estimated value is \$15,680.

## APPLICATIONS NOT RECOMMENDED

## South End Lawn Tennis Club, 949 Young Avenue, Halifax

Prior to amalgamation the Club received partial tax relief under the City of Halifax Ordinance 170. With the introduction of HRM By-law T-200 the Club was added to Schedule 29 in 1997 which applies the Residential tax rate to the entire tax bill, with any exclusions noted (eg. commercial tenancy). In correspondence to HRM dated November 4, 2019, the Club has requested an increase in level of tax relief with a further reduction to 50% (Schedule 28). The rationale provided by the Club was that in 2019 "...realty taxes absorbed 96.4% of the club's total revenue". Further, the Club drew attention to the fact that with only three courts and no lighting to support night play they are "markedly different" from other non-profit tennis clubs in HRM such as Waegwoltic and St. George's. The lower tax paid by St. George's was deemed to be "...a huge inequity, only magnified by the SELT's much smaller size and restriction to daytime play".

In correspondence dated November 8, 2019 staff indicated that the level of tax relief for the three (3) non-profit tennis clubs in the program was identical – all are listed in Schedule 29 and that the difference in the amount of tax paid after the rebate is a function of the location, scale, and market value of the property. In 2019, the Club's property had an assessed value in excess of \$1 million. Also, the Club's revenues are constrained by limited amenities as compared to other clubs, private and public facilities.

The financial information included with the application from the South End Lawn Tennis Club confirms that property tax paid after municipal tax relief has been deducted represents approximately 75% of expenditures and contributes to a small but recurring operating deficit. The estimated additional cost to the tax relief program is \$6,250.

As all other Tennis facilities (including the Nova Scotia Regional Tennis Development Association as of 2020) are on Schedule 29, it is recommended that the South End Lawn Tennis Club not be removed from Schedule 29 and added to Schedule 28.

# <u>City of Halifax Non-Profit Housing Society 2421 Creighton Street, Lot 13 North Street, Lot 11-2555</u> <u>Gottingen Street, and Lot 46-2559 Gottingen Street, Halifax</u> [Referred from 2019]

In 2019, the Society applied for tax relief for four (4) parcels of vacant land located on the corner of Gottingen and North Street that have been used for private parking. Tax relief was declined because title was not held by the applicant and there was no lease or license agreement on file. To date, the staff review has confirmed that title was incorrectly listed with the Nova Scotia Land Registry and HRM is the owner. Further, a lease agreement executed by the former City of Halifax with the City of Halifax Non-Profit Housing Society in June 29, 1987, has been located. The lease remains in effect on a month-to-month basis.

such, the lands have been correctly assessed as taxable but the lease does not meet the tax program's technical requirements under Section 5A of Administrative Order 2014-001-ADM. Real estate staff have contacted Canada Mortgage & Housing Corporation to confirm if the federal government has an ownership interest pursuant to any prior urban revitalization or housing demonstration program and on December 13, 2019, met with a representative of the Society to confirm their interest in the properties and to share the initial results of the review. Once title is clearly established in HRM's name the Municipality will have the option to license, lease or sell these lands.

It is recommended that City of Halifax Non-Profit Housing Society be declined tax relief for vacant lands leased from HRM pending the execution of a new lease or license agreement that meets the program's eligibility criteria or a decision regarding the surplus status of these holdings and their potential disposal.

It is recommended that City of Halifax Non-Profit Housing Society, 2421 Creighton Street, Halifax be declined tax relief based on a prior to commitment o consolidate this land holding with an abutting apartment building.<sup>9</sup>

# Compass Nova Scotia Co-Operative Homes Limited, 60 Spar Crescent, Dartmouth

The subject property formerly owned by the Central Dartmouth Housing Co-operative Limited is a vacant lot. There are no immediate plans for development of the site and as such the property does not provide a public benefit. The new owner, Compass Nova Scotia Co-Operative Homes Limited, can make application to a future tax relief program once the property's used has been confirmed. The site is assessed Residential (\$1,514).

It is recommended that Compass Nova Scotia Co-Operative Homes Limited, 60 Spar Crescent, Dartmouth be declined tax relief in 2020. The cooperative could make a future application to the program pending confirmation of a development timeline and occupancy of the subject property.

# Covenant Place Support and Renewal Organization/M. Sharpe, 7044 Highway 207, West Chezzetcook Lease Expires: 01/10/2024

The society received tax relief for two (2) privately-owned properties under the former Halifax County Bylaw 51 which was replaced in 1997 by HRM By-law T-200 following amalgamation. In 2006 the organization voluntarily relinquished their charitable status and society status defaulted in 2007 leading to a recommendation to remove the organization from the program in 2008<sup>10</sup>. In 2016, charitable status was obtained, and application made in relation to a lease for two (2) privately-owned properties located on Highway 207, West Chezzetcook<sup>11</sup>. Successive applications have been declined or deferred pending confirmation of referral sources; the operation is volunteer-led and appears to be small-scale and not widely advertised with some activities taking place off-site such as drives to appointments and home visits. Further, the property is owned by a member of the Board of Directors. The applicant requests full exemption (total tax \$2,110).

It is recommended that the application for tax relief from the Covenant Place and Renewal Organization be deferred to 2021 pending a review of the relationship between private property ownership and governance.

and that the review also encompass the Bread of Life Ministries which is currently included on Schedule 29 of the program.

# <u>Easter Seals Nova Scotia/Granville Developments Incorporated, 22 Fielding Avenue, Dartmouth</u> Partial Occupancy Lease Expires: 02/05/2043

The applicant has entered into a 25-year lease agreement with a private property owner. Under the agreement "additional or service rent" includes "real property taxes" plus HST which is charged back annually at the discretion of the property owner. The applicant is a partial commercial occupancy and not billed taxes directly by HRM.

It is recommended that Easter Seals Nova Scotia be declined tax relief based on a commercial lease agreement.

# <u>Hospice Society of Greater Halifax/Atlantic School of Theology, 618 Franklyn Street, Halifax</u> Land Lease Expires: 01/04/2036

In 2015, the society entered into a 20-year land lease with the Atlantic School of Theology for the purpose of constructing a hospice complex. The lease has successive renewal options that if exercised add up to 99 years. The complex includes 10 private patient rooms for persons who are terminally ill, a family/guest room, living/dining room, medical and administrative offices. Operations are sustained by donations and bequests, fundraising and government operating funds. As of the date of application the subject property is Commercial Exempt<sup>12</sup> and the society pays only the fire protection levy.

It is recommended that the Hospice Society of Greater Halifax be declined and referred to Property Valuation Services Corporation to determine the subject property's taxable status.

## Nova Scotia Nature Trust PID 41102096 Gerard Island and PID 40051476 Frederick Lake, Hubley

In February 2019, the Trust acquired a parcel of vacant land on Gerard Island, off the coast of Shad Bay on the Eastern Shore. The land is assessed Resource (total tax \$1,057). In March, the Trust acquired a parcel of vacant land on Frederick Lake which is assessed as Resource Exempt (tax \$0). In September 2019 the Trust made application to the Nova Scotia Department of the Environment for exemption under the *Conservation Property Tax Exemption Act*, S.N.S c.36, 2008. An application to the municipal tax program for exemption in relation to these same lands is essentially a stop-gap measure pending a decision under the provincial program. Addition to the municipal tax relief program is not recommended based on the following:

- nominal tax due on only one (1) property and an ability to pay pending a decision pursuant to the Conservation Property Tax Exemption Act;
- administrative inefficiencies resulting from pro-rating during fiscal 2020 if both properties are accepted into the provincial exemption program; and
- the Nova Scotia Department of the Environment has confirmed receipt of the Trust's application and deem the land holdings eligible for consideration.

It is recommended that the Nova Scotia Nature Trust be declined based on eligibility to pursue tax relief under the Conservation Property Tax Exemption Act.

## Tourism Industry Association of Nova Scotia, 6589 Chebucto Road, Halifax

The Association is an advocacy and educational organization serving the tourism industry in Nova Scotia. Individual, company, and organizational memberships include transportation, travel agents, the hospitality

industry, food and beverage industry, event, conference and trade show organizers, and tourism labour representation. Operations are primarily self-funded through project revenues, conferences and membership dues. In 2002 the Association applied for tax relief under former By-law T-200 for premises leased from the Halifax Port Authority. The application was declined based on the Association's mandate in serving the needs of industry and professional affiliates <sup>13</sup>. A subsequent appeal with respect to programming was also declined. In 2019 the Association purchased a property located in Halifax and relocated its operations. The property is assessed Commercial (\$25,359) and includes tenancy. Staff recommend the application be declined based on indirect financial assistance to business, commercial and industry interests <sup>14</sup>. The provision of tax relief could set a cost-prohibitive precedence given the number of professional, industry and trade associations, trade unions, sector-specific councils, and tourism sector associations and organizations many of which are registered non-profit organizations.

It is recommended that the Tourism Industry Association of Nova Scotia be declined.

**Note:** the proposed addition of the Sheet Harbour Chamber of Commerce is recommended in relation to the operation of a community museum, not a seasonal Visitor Information Centre or economic development.

# **Late Applications**

In 2020, the application deadline was extended by forty-five (45) days from March 31 to May 15 due to the COVID-19 pandemic. Under current policy, late renewal applications may be pro-rated to deduct 1/365 using dates and maximum penalties: after June 30, 2020, late renewal applications may be pro-rated to reduce the award by up to \$2,500 per property and late applications received after September 28, 2020, shall be reduced by up to \$5,000 per property.

Following the revised application deadline (May 15), notification letters were sent to those organizations in the program who had not fulfilled their reporting obligations. Notwithstanding this proactive approach to reducing default an exceptionally high number of renewals (44) have not been received as of the date of this report. Most are smaller volunteer groups who may not have staff/volunteer continuity. Consequently, it is recommended that clause 7C of the Administrative Order be suspended for only fiscal year 2020/2021 to avoid penalties or collection proceedings. Also, those organizations with tax arrears will be encouraged to apply for a monthly payment plan, thereby reducing pressure on cash flow.

# ADMINISTRATIVE ODER 2014-001-ADM TAX RELIEF TO NON-PROFIT ORGANIZATIONS ADMINISTRATIVE ORDER

- 5A. (1) An application for tax relief must be made to the Municipality by the March 31st immediately preceding the start of the fiscal year for which tax relief is sought.
  - (2) Any application for tax relief that does not satisfy subsection 1 is a late application.
- (3) An application for the renewal of tax relief that is a late application will result in a reduction of the amount of such relief in accordance with sections 7C and 7D.
- (4) Council may provide tax relief to an eligible non-profit organization or an eligible registered Canadian charitable organization that leases or has a license for real property that is located within the Municipality if
  - (a) (i) the real property is leased or licensed, for a minimum of five (5) consecutive years with a minimum of three (3) years remaining as of the March 31st immediately preceding the fiscal year for which tax relief is initially applied for, and the real property is licensed from the Municipality or leased from
    - (A) the Government,
    - (B) another non-profit organization or registered Canadian charitable organization,
      - (C) another person, or
      - (D) another entity; or
  - (ii) the real property was licensed from the Municipality, and the license has expired as of the March 31st immediately preceding the fiscal year for which the application to renew tax relief is applied for, and the conditions set out in subsection 5 are satisfied; or
  - (iii) the real property was leased, and the lease has expired as of the March 31st immediately preceding the fiscal year for which the application to renew tax relief is applied for, and the real property was leased from
    - (A) the Government,
    - (B) another non-profit organization or registered Canadian charitable organization,
      - (C) another person, or
      - (D) another entity,

and the conditions set out in subsection 5 are satisfied;

(b) the lease or license requires an eligible tenant non-profit organization or an eligible tenant registered Canadian charitable organization to pay the real property taxes on that portion of the real property that has been leased or licensed to the eligible organization; and

- (c) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization, the applicant is the owner of the property and such owner provides to the Municipality:
  - (i) the lessee's registration number listed in either the Registry of Joint Stock Companies or the charities listings of the Canada Revenue Agency;
    - (ii) a copy of the signed lease; and
    - (iii) the total area the lessee occupies under the lease.
- (5) If the lease or license respecting the real property that is the subject of an application for the renewal of tax relief has expired,
  - (a) the lease or license must have been expired for no more than three (3) years as of the March 31st immediately preceding the start of the fiscal year for which tax relief is sought; and
  - (b) the applicant must provide to the Municipality written confirmation from the licensor or lessor that
    - (i) the lease or license contains a provision allowing the lessee or licensee to remain in possession after the lease or the license expired, or
    - (ii) the lessor or licensor consents to the lessee or licensee remaining in possession of the real property.
- 5B If clause 5A(4)(c) applies, the amount of tax relief provided to the eligible lessee shall be the lesser of the amount of tax relief provided to the owner of the property or the total amount of the tax relief provided to the owner of the property divided by the area of the property occupied by the eligible lessee.

## **Application for Tax Relief During Covid-19**

- 5C. Notwithstanding sections 5A, 7C, and 7D, for applications for tax relief for the 2020-2021 fiscal year,
  - (a) the March 31st, 2020 deadline shall not apply; and
  - (b) the deadlines and reductions in section 7C or 7D shall not apply.

# **Pro Rata Tax Relief**

- 6. (1) If tax relief has been provided pursuant to this Administrative Order, the amount of tax relief shall be pro-rated based on the proportional occupancy of the subject real property by an eligible non-profit organization or an eligible registered Canadian charitable organization and the duration of such occupancy during the current taxation year as follows:
  - (a) that portion of the real property leased, sub-leased or occupied by Government, another person or another entity must be excluded from eligibility for tax relief and the amount of tax relief must be pro-rated based on the proportional share of non-profit organization or registered Canadian charitable organization occupancy, expressed as a percentage for the entire real property;
  - (b) if any portion of the real property owned by an eligible non-profit organization or an eligible registered Canadian charitable organization for which tax relief has been provided is conveyed to a Government, another non-profit organization or another registered Canadian

charitable organization, another person or another entity, the amount of tax relief shall be calculated by,

- (i) dividing the number of days in the calendar year by the dollar amount of the tax relief; and
- (ii) multiplying the result of sub-clause (b) (i) of this clause by the number of days the eligible non-profit or eligible registered Canadian charity organization owned the real property;
- (c) if the lease or license is terminated for any reason or expires prior to the end of the current taxation year, the amount of tax relief shall be calculated by:
  - (i) dividing the number of days in the calendar year by the dollar amount of the tax relief; and
  - (ii) multiplying the result of sub-clause (c) (i) of this clause by the number of days the eligible non-profit or eligible registered Canadian charity organization leased or licensed the real property.
- (2) For greater certainty, a vacant portion of the real property that:
  - (a) is the subject of tax relief that has been provided,
- (b) is owned by an eligible non-profit organization or an eligible registered Canadian charitable organization,
  - (c) is vacant, and
- (d) is not otherwise ineligible for tax relief or subject to a pro-rate reduction, is eligible for tax relief.
- 7. Where tax relief is provided pursuant to this Administrative Order and the property owner or lessee or licensee terminates the lease or license for any reason or the lease or license expires prior to the end of the fiscal year the amount of tax relief must be calculated by:
- (a) dividing the number of days in the calendar year by the dollar amount of the tax relief; and
- (b) multiplying the result of clause (a) of this section by the number of days the eligible non-profit or eligible registered Canadian charity organization is in possession of the property.

## 7A Where

- (a) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization; and
  - (b) tax relief is provided pursuant to this Administrative Order to the eligible lessee; and
  - (c) the owner of real property is no longer eligible for tax relief or the tax relief is pro-rate; then the tax relief of the eligible lessee shall terminate.
- 7B Repealed.

# **First Late Renewal Application**

- 7C. (1) If an application for the renewal of tax relief is a late application and the application for the previous fiscal year was on time, the amount of tax relief for each property that was filed late shall be reduced in accordance with subsection 2 of this section.
- (2) If subsection 1 applies, the amount of tax relief for each property that was filed late shall be reduced as follows:
  - (a) if the application is received on or before June 30th, there shall be no reduction; or
  - (b) if the application is received after June 30th and on or before September 28th, there shall be a reduction of 1/365 for every calendar day such application is late after June 30th, to a maximum of two thousand five hundred dollars (\$2,500) per property; or
  - (c) if the application is received after September 28th, there shall be a reduction of 1/365 for every calendar day such application is late after June 30th to a maximum of five thousand dollars (\$5,000) per property.
- (3) If June 30th or September 28th falls on a Saturday or Sunday, the deadline shall be extended until the next business day.

# **Subsequent Late Renewal Applications**

- 7D. (1) If an application for the renewal of tax relief is the second consecutive late application, the amount of tax relief for each property that was filed late shall be reduced in accordance with the following:
  - (a) if the application is received on or before the September 28th, tax relief shall be reduced by 1/365 for every calendar day such application is late; or
    - (b) if the application is received after September 28th, then
    - (i) tax relief shall be revoked for the fiscal year for each property for which the application is late, and
    - (ii) the applicant shall be ineligible for tax relief for the fiscal year for each property for which the application is late, and
    - (iii) if the applicant is listed on any Schedule, the applicant is struck off such Schedule in respect of each late property.
- (2) Where September 28th falls on a Saturday or Sunday, the deadline shall be extended until the next business day.
- (3) If a non-profit organization or a registered Canadian charity organization is struck off a Schedule pursuant to subclause 7D(1)(b)(iii), such organization may apply for tax relief for the next fiscal year providing the application complies with this Administrative Order and if such application is late, section 7C shall apply.

# **Application for Tax Relief During Covid-19**

- 5C. Notwithstanding sections 5A, 7C, and 7D, for applications for tax relief for the 2020-2021 fiscal year,
  - (a) the March 31st, 2020 deadline shall not apply; and
  - (b) the deadlines and reductions in section 7C or 7D shall not apply.
