#### VETERANS' WEEK OBSERVATIONS

Each year, from November 5th - 11th, hundreds of commemorative ceremonies and events will take place across our country to commemorate Veterans' Week. These will be opportunities for all Canadians to recognize the contribution our Veterans and Military personnel have made and to honour those who made the ultimate sacrifice on behalf of Canada. However; a lot of these events this year will be held virtually. Please wear a poppy BUT this year with the Covid-19 pandemic, the public is asked NOT to attend any local Remembrance Day ceremonies. So this year for Veterans' Week, please remember them at the 11th hour, on the 11th day, of the 11th month in your own special way. Take time out and observe a two-minute moment of silence. #### ESLSC INFRASTRUCTURE FUNDING

Canada, Nova Scotia & HRM will be investing in a new community centre for Sheet Harbour. The Federal Government is investing \$3.6 million in this project through the Community, Culture, and Recreation Stream of the Investing in Canada Infrastructure plan. The Provincial Government is contributing more than \$2.9 million plus providing the lands by the West River as the place for the new facility. And Municipality is contributing \$3 million. Plus, HRM is exploring the opportunity to incorporate a new fire station with it too with an additional \$3 million investment. This jointly costshare infrastructure funding will see the construction of a new community facility that will include spaces for recreation and fitness, a library, and a community hall, all housed in one building. Currently, these spaces are in separate buildings in different locations. This investment in a new, accessible Eastern Shore Life Style Centre (ESLSC) will encourage healthy, active lifestyles and help bring people in the area closer together. The current community centre - the Lion's Hall on Pool Road is a former indoor swimming pool that was retrofitted into a community hall about 40 years ago. About 5 years ago, HRM was going to redo the roof but found major deficiencies in the roof trusses. It is structurally unsound. There are significant risks of collapse if there were ever an accumulation of ice and snow load on it. High winds from a hurricane or severe storm could also damage it. For the last 4 years, the facility has been closed over the late autumn and winter months. That's about 5&1/2 to 6 months a year the community is without a facility. Many events, dinners, receptions, entertainment functions and bingo have either been cancelled or downsized to the local Legion. The community seized upon this opportunity to look at the possibility of co-location of several services and closing other smaller local facilities. Next phase will be the engagement of an architect to devise a conceptual plan from the work done by the ESLSC planning committee.

## SNOW REMOVAL FOR SENIORS

There is a snow removal program available to seniors (65 years of age or older) and for persons with disabilities throughout all areas of HRM. You must reside in a single dwelling home that you own or rent. Its mandate is to provide a resource to clients for the removal of snow for safe access. The program is limited to those households with a combined total income not exceeding \$32,000. The program is NOT available to landlords. # TAX EXEMPTION FOR LOCAL GROUPS

HRM can help some local non-profit organizations reduce their property tax payments through the Tax Relief for Non-Profit Organizations Program. Applications must be filed by November 30th. There are various types of tax reduction programs from Commercial to Residential Tax Rate Conversion, or to tiered level tax rate with 25%, 50%. 75% or 100% tax exemption.
