SUBJECT: Endorsement of Millbrook Reserve on Shannon Park Lands

#### **ORIGIN**

November 24, 2020 letter from Robert Gloade, Chief of Millbrook First Nation, regarding creation of a reserve on a section of the Shannon Park Lands.

## **LEGISLATIVE AUTHORITY**

HRM Charter Section 74(1) – The Municipality may agree with one or more municipalities, villages, service commissions, the Government of the Province or of Canada or a department or agency of either of them or a band council pursuant to the Indian Act (Canada) to provide or administer municipal or village services.

### RECOMMENDATION

It is recommended that Halifax Regional Council:

- Authorize the Mayor to write a letter on behalf of Halifax Regional Council endorsing the Millbrook First Nation's creation of a reserve on a section of the Shannon Park Lands and confirming the Municipality's intention to enter into a Municipal Services Agreement with Millbrook First Nation; and
- Direct the Chief Administrative Officer to initiate negotiation of a Municipal Services Agreement with Millbrook First Nation when the reserve is formally approved, and the development process commences.

### **BACKGROUND**

On November 24, 2020 the Municipal Clerk's Office received correspondence from Millbrook First Nation Chief Robert Gloade advising that Millbrook was in the final stages of working with Indigenous Service Canada to establish a reserve on the Shannon Park Lands. A copy of this letter, which includes a map of the proposed reserve, is attached to this report as Attachment A.

On December 17, 2020 the Mayor's Office received e-mail correspondence from Indigenous Services Canada stating that they require from Halifax Regional Municipality an indication of support for the new Reserve as well as a commitment to enter into a Municipal Services Agreement with Millbrook First Nation once they begin to develop the area.

On December 18, 2020 the Chief Administrative Officer wrote a letter to Chief Gloade confirming support for the creation of the Reserve and his intention to create a Municipal Services Agreement, conditional upon Regional Council's endorsement of the initiative. A copy of that letter is attached to this report as Attachment B.

### DISCUSSION

In 2014, Canada Lands acquired approximately 87 acres (33 hectares) of land at Shannon Park from the Department of National Defence. Indigenous Services Canada retained approximately nine acres (3.6 hectares) of the site for transfer to the Millbrook First Nation as an addition to their reserve lands. Millbrook has since been working collaboratively with Canada Lands to ensure alignment of the reserve with the overall development plan of the Shannon Park area.

Staff from Indigenous Services Canada – Atlantic Region are in the final stages of preparing a Ministerial Order package to formally create the new reserve at Shannon Park. As part of that package, Municipal endorsement is required, as well as a stated commitment by the Municipality to enter into a Municipal Services Agreement with Millbrook First Nation once development plans have been finalized.

As noted above, the CAO has sent a letter to Millbrook indicating that the administration supports the creation of the reserve and will enter into discussions with the intent to create a Municipal Services Agreement, conditional upon Halifax Regional Council's endorsement of this direction.

#### FINANCIAL IMPLICATIONS

There are no financial implications as a result of the information presented in this report. Any financial implications resulting from the negotiation of the Municipal Services Agreement will be brought to Regional Council for approval as required.

### **RISK CONSIDERATION**

There are no significant risks associated with the recommendations in this report. The risks considered rate low. A more comprehensive risk assessment will take place in conjunction with development of the Municipal Services Agreement with Millbrook First Nation.

#### **COMMUNITY ENGAGEMENT**

Canada Lands has undertaken public engagement for the Shannon Park site, developed a Master Plan based on this engagement and has made application for municipal planning approval. Canada Lands continues to work collaboratively with Millbrook First Nation to engage in the development process for their

adjacent properties.

### **ENVIRONMENTAL IMPLICATIONS**

There are no environmental implications related to the information presented in this report. A more detailed assessment of environmental implications related to the development will be conducted, as required, during negotiation of the Municipal Services Agreement with Millbrook First Nation and the subsequent development process.

### **ALTERNATIVES**

Halifax Regional Council may choose not to endorse the development of the Millbrook reserve on Shannon Park lands. This approach is not recommended.


# Dear Mayor Savage
