LEGISLATIVE AUTHORITY

Administrative Order No 1 - Schedule 6

The Terms of Reference of the Standing Committees, as approved by Regional Council.

RECOMMENDATION

It is recommended that Halifax Regional Council adopt the recommendations of the Executive Standing Committee regarding Councillor Appointments and proceed to appoint:

- 1. Councillor Iona Stoddard to the Women's Advisory Committee for a term to November 2022; and
- 2. Councillors Paul Russell and Cathy Deagle-Gammon to the Accessibility Advisory Committee for a term to November 2022.

BACKGROUND/DISCUSSION

Based on the terms of reference of the Standing Committee as approved by Regional Council, each Committee has the mandate to be the nominating/appointing body (to Regional Council) for the members of a number of Boards and Committees.

The Executive Standing Committee of Council met in January 2021 to review the expressions of interest put forward by members of Council to serve on the following Boards and Committees:

- Women's Advisory Committee (One Councillor nominated by the Executive Standing Committee)
- Accessibility Advisory Committee (Up to three Councillors nominated by the Executive Standing Committee)

Based on the decision of the Executive Standing Committee it is recommended to appoint Councillor Iona Stoddard to serve on the Women's Advisory Committee and to appoint Councillors Paul Russell and Cathy Deagle-Gammon to serve on the Accessibility Advisory Committee.

The appointees have been duly vetted and put forward by the Executive Standing Committee and is before Council for formal ratification.

A delay in considering and making appointments could result in additional delays for other meeting schedules and business of Committees, as they would be formed at a later date.
