Items for discussion:


There are 4 entrances accessible by vehicle: both lower and upper parking lots, and at either side of the fountain at the end of Young Ave. Recommend installing this first sign at each entrance, and eliminating the second one altogether:





No need for this sign (redundancy).





There have been issues surrounding clarity of the weekend bike route. Particularly do we need to sign each entrance stating, "no bikes on weekends at this entrance". Should there be reference to the fact there is a weekend route?

Also need to reference ebikes and scooters. Would these signs be the proper place?













Dogs along Sailor's Memorial Way. There has been confusion as to if this just means the roadway itself or is it to include the shore (fields) area as well. As seen on the park maps it is to include ALL areas beyond the signage. This should be made clear on this signage, perhaps saying "NO DOGS BEYOND THIS POINT" after 10 am, or should it reference shoreline specifically?









This combination sign is currently at many of the park entrances and references dog etiquette, weekend bikes, fires and the Parks by-law. Recommend removing these altogether and placing the most relevant individual signs at each entrance.

Question for discussion: Is there a need to list proper dog etiquette when there's a whole by-law dealing with this? Park staff do feel it is still necessary.

Are dog etiquette signs still required? If so, where would be the proper place for them?

Eliminate bike sign as it will be posted at each park entrance. Replace with:



OFF LEASH AREA USERS ARE REQUIRED TO ABIDE BY THE FOLLOWING RULES:

- Dogs must have current municipal tags.
- Dogs must be on leash unless signs indicate otherwise.
- You must carry a leash.
- Your dog must come to you when called.
- You must keep your dog within sight.
- You will be held responsible for any damages or injuries caused by a dog in your care.
- Dogs must not interfere with other park users.
- Aggressive dogs, female dogs in heat, and puppies under three months old are not permitted in off leash areas.
- You must pick up your dog's waste immediately
