# ORIGIN

June 5, 2018 – Regional Council approved Administrative Order 2014-010-ADM to provide interim funding to community museums as defined in policy located within the Halifax Regional Municipality.

February 26, 2021 – Application deadline for inclusion in the Interim Community Museums Grants Program and applications for project-specific grants from those organizations previously accepted into the program.

# **RECOMMENDATION**

It is recommended that the Grants Committee recommend that Halifax Regional Council:

- 1. Approve five (5) Project Grants as set out in Table 1 of the Discussion section of this report at a combined cost of \$58,500.00 in fiscal year 2021-22 from Operating Account M310-8004; and
- 2. Approve a two-year extension to the Service Agreement with the Association of Nova Scotia Museums at a total cost of \$24,000.00 from Operating Account M310-8001; and
- Authorize the Executive Director of Finance and Asset Management to negotiate and execute an Amending Agreement for a two-year extension to the Service Agreement with the Association of Nova Scotia Museums.

### **BACKGROUND**

June 5, 2018 - Regional Council approved the implementation of a 3-year "interim" grant program for community museums pending the development of a <u>Culture & Heritage Priorities Plan</u>. It is also anticipated that the program will be informed by the <u>HRM Museum Strategy</u> and/or any changes to the provincial *Community Museums Assistance Program* ("CMAP"). The aim of this program is to enhance the organizational capacity of community museums in achieving and maintaining established standards of practice using the provincial *Museum Evaluation Program* administered by the Association of Nova Scotia Museums ("ANSM"). This program provides constructive feedback from qualified and impartial evaluators. Through periodic re-evaluation participating organizations can gauge their own progress. In 2020, ANSM also launched a *Museum Accreditation Program* which identifies museums that have achieved and maintained a standard of excellence.

In January 2021, Regional Council approved amendments to the program aimed at creating a "single-point-of-entry" and to realize efficiencies for both HRM and the applicant<sup>1</sup>. The changes included the following:

- the addition of a Capital Grants funding sub-category;
- inclusion of specific types of events;
- and to extend the term of the program for two (2) additional years to March 31, 2023.

Because thirteen (13) multi-year Operating Grants totaling \$122,000 have already been approved by the Council, the recommendations presented in this report are with respect to applications for project-specific grants and an extension of HRM's Service Agreement with the Association of Nova Scotia Museums. For context, a list of Operating Grant recipients is included in Attachment 1 of this report.

#### **DISCUSSION**

As of the February 26, 2021, application deadline a total of six (6) applications were received for a combined total of \$78,000 in funding requests.

# **Project Grant** (>\$5,000)

# 1. Nova Scotia Sports Hall of Fame Society – Halifax

Established in 1964 as the Nova Scotia Sport Heritage Centre and incorporated as a non-profit society in 1983, the Society is a registered Canadian charity that operates a Hall of Fame and a sport history museum that has a significant collection of artifacts including extensive digital text and image files and sports memorabilia. In 2020, the Society did not renew their lease agreement and the collection has been placed in temporary storage pending a new location. A matching Project Grant of \$2,500 is requested towards the purchase of twelve sensor beacons and material costs for small satellite displays in assorted venues. The total project cost is \$5,500 and the balance of funding is confirmed. The sensor can be activated using a mobile device and the application downloads custom digital visual and audio content. The project is adaptive and maintains community contact in the absence of a physical facility, expands community outreach, and the application is available at no cost to users who can visit sites "virtually" thereby eliminating the need for transportation. A Project Grant in the amount of \$2,500 is recommended towards the purchase of small equipment and materials for outreach exhibits featuring mobile application access to customized interpretive sports history content.

# 2. Cole Harbour Rural Heritage Society – Cole Harbour

Incorporated in 1978, the society is a registered non-profit and a Canadian charity that owns and operates a living museum on 2.5 acres of land located in a busy commercial area that was once mainly agricultural, notably dairy and seasonal produce for markets in Halifax. A Project Grant in the amount of \$4,000 is requested towards the design, illustration and printing of a new brochure (a visitor site guide) and fabrication of signage for the venue's entry kiosk. The projected cost is \$5,250 including HST. The Society's contribution of \$1,250 is confirmed. As a registered charity the Society is eligible to apply for a partial HST rebate. The project could enhance the visitor experience by encouraging self-guided tours of a cultural landscape, including seasonal plantings and ecological features. A Project Grant in the amount of \$4,000 is recommended towards the production of visitor wayfinding/interpretive materials.

# **Capital Grant** (>\$25,000)

3. <u>Cole Harbour Rural Heritage Society</u> – Cole Harbour

The Heritage Farm Museum site includes a collection of buildings and out-buildings representative of farm homesteading and associated trades. Six of these structures are registered heritage buildings. A Capital Grant in the amount of \$7,000 is requested towards two elements: (i) *Harris House c.1843*<sup>2</sup>: repair and/or replacement of wooden window sills and sashes, three replacement windows, re-shingling two sides and (ii) scrape, prime and paint the exterior of both the *Harris House* and the *Giles House* c.1810<sup>3</sup>. Heritage

Planner approval is confirmed. The combined projected cost is \$20,987.50 including partial HST. As a registered charity the Society is eligible to apply for a partial HST rebate. The Society's contribution is confirmed and application has been made for a \$10,000 provincial grant (unconfirmed as of date of submission). The applicant has indicated that the exterior painting of both buildings is their priority. The project contributes to the protection and active use of authentic heritage assets. A Capital Grant in the amount of \$7,000 is recommended towards repairs and upgrades to two registered heritage buildings.

The applicant will be referred to the provincial tax rebate program for heritage properties administered by Service Nova Scotia. This program refunds a portion of the provincial sales tax paid on approved materials (not labour) used to repair, improve, or restore the exterior of a heritage property.

### 4. Hooked Rug Museum of North America Society – Hubbards

Incorporated in 2006, the society is a registered Canadian charity with a dual role in operating a hooked rug museum and a fibre art market<sup>4</sup>. The Society's niche collection focuses on hooked rugs originating in Acadian communities in New England and the Maritime provinces. The evolution of the craft and its contemporary status as a fine art is fostered by exhibiting original works and related needle-arts, for example braided rugs, quilting, knitting, embroidery, or crewel work. The collection also includes small artifacts (tools, patterns). A Capital Grant in the amount of \$25,000 is requested to fully fund the purchase and installation of one (1) heat pump and associated duct work (total cost \$27,097 including HST). The facility has two heat pumps, one of which is not sized correctly, and the existing ductwork does not fully service the current layout. Consequently, areas of the museum lack adequate heat or air conditioning and a recent donation of works requires additional storage and display capacity. As a registered charity the Society is eligible to apply for a partial HST rebate. The balance of funding (\$2,097) is unconfirmed but the Society is investigating energy rebate programs. To ensure that the project can proceed and/or avoid any over-payment staff will contact the applicant prior to issuance of any grant approved by Council. Hence, the motion includes the qualifier, "up to" \$25,000. Funding is recommended based on financial need, the importance of climate control to protect the collection of fibrous materials, and the opportunity to extend visitor hours in the Spring and Fall "shoulder seasons". A Capital Grant in the amount of up to \$25,000 is recommended to fund the purchase and installation of a replacement heat pump.

# **SPECIAL PROJECT GRANT** (>\$20,000)

# 5. <u>Lake Charlotte Area Heritage Society</u> – Lake Charlotte

Incorporated in 1995, the Society is a registered non-profit and Canadian charity that owns and operates a 4-acre living museum that portrays rural life in the area's small coastal villages. The Society's mandate is to "research, document, communicate and celebrate the social heritage of the coastal communities of the Eastern shore, from Lawrencetown to Ecum Secum, between 1940 and 1950". Located on-site is the award-winning Eastern Shore Archives which provides reference services and conducts community-based research on the genealogical, social, business, and natural history of the area. A Special Project Grant in the amount of \$20,000 was requested to fund the launch of a *Wild Islands Coastal Heritage Accessibility Project* which proposes to use GIS software to scan and digitally archive existing photographs and enhance content by adding historical maps, satellite imagery, property boundaries, travel routes, and contour mapping. The total cost is \$23,000 HST included. As a registered charity the Society is eligible to apply for a partial HST rebate.

The project fosters technological innovation in using GIS/ESRI software to create a user-friendly, online archives with the capacity to "layer" materials and enhance public access to the Society's collection. Because staff and volunteers are inexperienced in the technology, funds are requested to hire a part-time

employee for a 10-month term. In addition to developing and testing the digital operating system, the staff person will develop a training manual and guide to enable the Society's staff and volunteers to maintain the system on an on-going basis. The applicant has confirmed that although maintaining and adding to content will be on-going, any further funding would be sought from non-municipal sources. The Society's contribution of \$2,800 and \$200 from Destination Eastern and Northumberland Shores is confirmed. The project engages community members through participation in gathering oral histories, increases organizational capacity through technological enhancements, enhances the interpretation of archival resources, and broadens both content and public access. A one-time Special Project Grant in the amount of \$20,000 is recommended to fund a start-up digital platform to enhance public access to the Eastern Shore Archives.

# Not Recommended for Funding

#### **Atlantic Canadian Aviation Museum Society - Goffs**

The Society leases a former Visitor Information Building near the Halifax International Airport owned by the Government of Nova Scotia. The rent is \$1.00 a year in lieu of all capital and operating. The Society has requested a capital grant in the amount of \$19,500 for a partial roof replacement and enhancement using metal cladding (total cost \$21,500). The program does not fund leasehold improvements (Guidebook, p.7)<sup>5</sup>. Staff will endeavour to identify and notify the applicant of possible alternate funding sources.

# Association of Nova Scotia Museums (ANSM) Service Contract: Fiscal 2021 and 2022

At the commencement of the *Community Museum Grants Program* it was anticipated that demand from local museums to participate in the provincial *Museum Evaluation Program* would increase due to HRM's adoption of this program in encouraging standards of practice. An abrupt or sustained demand could exceed ANSM's operational capacity. To address this issue a Service Agreement, ending March 31, 2021, was executed to assist with evaluation-related costs. With Council's approval to extend the term of the grant program, it is recommended that the duration of the Service Agreement also be renewed to enable initial evaluations, re-evaluations, or participation in the new *Museum Accreditation Program*. The terms of the contract remain unchanged. The value of the contract is based on an average cost of \$3,000 per evaluation, preparatory workshops, and annual reporting to HRM. This contract provides HRM a cost-effective means to gather annual quantitative data thus reducing the administrative demand on both HRM and the community museums, many of whom rely on volunteers.

To date, five (5) community museums participating in HRM's *Community Museum Grant Program* have completed an evaluation or re-evaluation, including preparatory workshops. Namely, the Africville Heritage Trust, Hooked Rug Museum of North America Society, Musquodoboit Harbour Heritage Society, Nova Scotia Sports Hall of Fame Society, and S.S. Atlantic Heritage Park Society. The Atlantic Canada Aviation Museum Society has completed the new *Museum Accreditation Program*<sup>6</sup>. The Army Museum Halifax Citadel, Cole Harbour Rural Heritage Society, Fultz Corner Restoration Society, and the Lake Charlotte Area Heritage Society are scheduled for a re-evaluation and the Fort Sackville Foundation will be preparing for an initial evaluation. It is hoped that some of the well-established museums will also seek accreditation.

In 2020, the Association responded to COVID-19 restrictions by transitioning much of their programming and support to the Internet thereby enhancing opportunities for networking and peer learning at a time when museums were facing loss of earned revenues and uncertainty with respect to public programming. Examples of this adaptation included online and web conferencing platforms, web-based seminars to assist groups prepare for an evaluation, information on government emergency assistance (COVID-19), and online instruction for the 3-year *Museum Studies Program*.

# **FINANCIAL IMPLICATIONS**

The Interim *Community Museums Grant Program* is budgeted in M310-8004 for a total of \$220,000. As per Section 5(1) of Administrative Order 2018-010-ADM the term of this program has been extended to fiscal year 2022-23 pending Council's consideration of the <u>HRM Museum Strategy</u> and the <u>Culture and Heritage</u> Priorities Plan.

Currently, there are thirteen (13) approved Multi-Year Operating Grants totaling \$122,000. This value could change in subsequent years should the program receive applications from eligible organizations. In 2021, there are five (5) Project Grants recommended at a combined cost of \$58,500. The value of Project Grants is expected to vary year-to-year based on the number, type and value of requests. The contract expenditure is one-time.

# **Other Municipal Assistance**

# 1. Operating Grants: Community Museums Grant Program (2020)

The thirteen (13) community museums in receipt of an Operating Grant under the Community Museums Grants Program are listed below by "Tier" which is used only in relation to HRM's program. The Tiers distinguish those organizations that have completed the provincial *Museum Evaluation Program* with a minimum score of 50/100 in combination with their total revenues and other in-kind government assistance. Provincial funding is also noted: "CMAP" stands for the provincial *Community Museums Assistance Program* and "NS" indicates provincial funding outside the formal CMAP.

Due to significant variance in the value of CMAP grants, and the exclusion/non-participation of seven community museums located within HRM, the Community Museums Grants Program does not use provincial funding as a benchmark for municipal funding except in regard to the 80% government funding threshold.

# 3. Event Grants: Regional Special Events Grants Program (2020)

In 2020, public health restrictions on social gatherings resulted in event cancellations and few event grants.

# 4. Property Tax Relief: Tax Relief for Non-Profit Organizations Program (2020)

In 2020 nine (9) organizations currently included in the Community Museums Grant Program were assessed as taxable<sup>1</sup>. Discretionary tax relief was awarded to a combined total of fifteen (15) properties. The Sheet Harbour Area Historical Society operate a small community museum in McPhee House, an HRM-owned property leased to the Sheet Harbour and Area Chamber of Commerce (See: Note 4).

- 7. The BID levy paid by Fultz Corner is essentially a flow-through to the Sackville Business Commission and does not represent a net revenue to the Municipality. Likewise, the tax paid for an HRM office in the Musquodoboit Railway Museum is to be paid by HRM through the lease agreement.
- 8. In 2020, the Sheet Harbour and Area Chamber of Commerce was awarded partial tax relief based on the operation of a community museum in that portion of the premises leased by the Sheet Harbour Area Historical Society<sup>2</sup>. The property (MacPhee House) is owned by HRM and leased to the Chamber at less than market value. The agreement also includes indirect assistance with some seasonal operating costs.

# 5. Less than Market Value Lease/Indirect Operating Assistance

In addition to a less than market value rental rate, some lease or license agreements might also include specific operating expenses that would usually be covered by a tenant. Currently, two (2) organizations receive indirect municipal operating assistance through a lease agreement. The values listed below are estimates for only operating costs (not the value of the rent foregone) as of the date of the report to Regional Council (shown in parenthesis):

The opportunity cost for rent was estimated to be \$10,220/year and the direct expenses paid by HRM totaled \$10,300 for a combined cost of \$20,520 per annum.
