

2. Architectural Importance



- Strong example of the Craftsman Bungalow style (1900-1920)
- Adaptation of the British Arts & Craft Movement
- Style is characterized by a 1.5-storey building profile, gently sloping roof, broad eaves, fullwidth veranda (w/ supporting columns and low wall), etc.
- Dwelling also has unique features, like the tiered roof and sleeping porch

4a. Architectural Merit (Construction)



- 1.5-storey wood-framed construction that sits on a masonry foundation
- Precise construction type unknown; appears to be a common example of wood-framed construction
- Displays a high level of craftsmanship

4b. Architectural Merit (Style)



- Unique example of the Craftsman Bungalow style
- 1.5-storey dwelling with a square plan, wood shingles, and many Craftsman features
- Character defining elements:
 - Upper storey sleeping porch;
 - Tiered-hipped roof and dormers;
 - Overhanging eaves and rafter tails;
 - Brick chimney;
 - Large front yard setback; and
 - Original wood windows and fenestration



4b. Architectural Merit (Style)





B) Style	Points
Very rare/ early example	7 - 10
Moderately rare/ early	4 - 6
Somewhat rare/ early example	1 - 3
Not rare/ common example	0

5. Architectural Integrity



- Dwelling has a high degree of architectural integrity;
 the historic appearance, profile, and detailing remain
- Most original wooden windows are intact, as are many other character defining elements
- Modifications include:
 - One chimney removed
 - Two windows converted to entryways
 - Rear deck construction
 - Some rafter tails removed (or covered)
 - Vinyl soffit added

5. Architectural Integrity

Modest changes	6 - 10	
Major changes	1 - 5	
Seriously compromised	0	


6. Relationship to Surrounding Area



- Strong historical connections to the Keeler family who cultivated and developed the surrounding area
- Physical and visual relationship to six remaining Keeler homes
- Original Keeler home, Mount Pleasant (c.1802)

6. Relationship to Surrounding Area



Dainta	Comments
6 - 10	The building is an important architectural asset contributing to the heritage character of the surrounding area.
1 - 5	The Architecture is compatible with the surrounding area and maintains its heritage character.
0	Does not contribute to the character of the surrounding area.

Recommendation

Should 173 Crichton Avenue, Dartmouth score 50 or more points on evaluation as a heritage property under the HRM heritage property program, the Heritage Advisory Committee recommends that Regional Council:

- 1. Set a date for a heritage hearing to consider the inclusion of the subject property in the Registry of Heritage Property for the Halifax Regional Municipality; and
- 2. Approve the request to include 173 Crichton Avenue, Dartmouth in the Registry of Heritage Property for the Halifax Regional Municipality, as shown on Map 1, as a municipal heritage property under the Heritage Property Act
