


## **Margeson Drive Master Plan – Study Area**



Lands adjacent to the Highway 101 – Margeson Drive interchange





# What is an Area Advisory Committee (Public Participation Committee)?

- Set out in the Halifax Charter
- Make recommendation to Council on matters of Land Use policy and regulations
- Acts as a liaison to the public it represents
- Provides input in the advisory process of land use policy and regulations
- Is often created and utilized for larger land use project work
- Is used in the creation of every Municipal Planning Strategy

## **Public Participation Program**

### **Role of PPC**

- 1. PPC Terms of Reference;
- 2. Make decisions on key points to further the planning process;
- 3. Consult with the community at appropriate intervals to gather community input; and,
- 4. Make recommendations to the Community Council for recommendation to Regional Council for adoption of the Plan



Planning Advisory Committee (PAC)	Public Participation Committee (PPC)
