However, it was not until 2020 when Halifax Regional Council achieved two historic milestones: the election of the first woman of colour, Councillor Iona Stoddard, and a council with gender parity - which is equal representation of elected Councillors who identify as women and men. ## **TRAFFIC CALMING ON EISENER BOULEVARD**

Traffic calming measures have been installed on Eisener Boulevard which includes a tactical multi-use pathway (MUP) on the south west side of the street from Russell Lake Drive to Portland Estates Boulevard West. This includes using paint and flexible bollards and is planned to remain in place year-round. Crews will perform winter maintenance and snow removal within the limits of the MUP. As this will be a new type of infrastructure to maintain during the winter, staff will be monitoring to confirm feasible service standards. Parking will be restricted along the MUP but will be unaffected on the opposite side of the street.

The project also includes two painted crosswalks across Eisener Blvd at Russell Lake Drive and Portland Estates Blvd West that will remain in place for the duration of the tactical project.

The MUP will create roadway narrowing with the intended purpose of reducing vehicle speeds along the corridor as well as provide additional connection for pedestrians and cyclists.

The MUP is expected to be in place for 2 years as a temporary measure in advance of a future permanent solution. The tactical nature of the work allows us to evaluate and make adjustments as needed prior to installing permanent infrastructure.

I am receiving comments through email, phone, and social media all of which I am collecting and sharing with staff. This project is ongoing with a complex set of challenges. The traffic calming

framework that is in place right now does not include public consultation, however it is something that I believe should be considered on all future projects. I will be asking for that as a new recommendation to this framework.

Engineers and experts in traffic safety are where the designs are created, and they do so with many elements in consideration. It's important to see what the results are for this project before considering changes. We are in the early stages of changes that are expected over several years. The challenges include unsafe road crossing, speeding, one lane being used as two, and pedestrians on upper side are unsafe walking to school and parks. Other considerations include connections for pedestrians and cyclists to travel safely to the Portland Greenway.

Eisener Blvd is projected to be resurfaced in two years with full curb/gutter, complete sidewalks and bike lane installed. The current infrastructure is a solution to very serious traffic concerns expressed by the community. Narrowing roads are effective and proven ways to reduce traffic speeds.

Traffic calming is often needed and asked for, then many residents in the area express concern during installation, and later adjust and change driving habits. Please consider waiting this out and seeing what happens. If you have any questions or concerns, I ask that you send me an e-mail. I am happy to discuss any time.

## CALDWELL ROAD SCHOOLS IN EASTERN PASSAGE

On Wednesday October 27<sup>th</sup>, I held a stakeholder meeting at the Horizon Recreation Centre to discuss several converging traffic issues surrounding Ocean View Elementary, Seaside Elementary and Island View High School. I'm pleased to share that this was a very productive meeting and staff are investigating potential solutions.

In attendance was a parent representative of each school, HRM staff from Traffic, Fire and Emergency Services, Parks, Parking Enforcement, as well as Principals of Ocean View and Seaside Elementary Schools, and RCMP Community Policing. My goal was to give HRM staff and Police a thorough understanding of what is at play in this area of Caldwell Road. With 4 schools within 1km of each other and 3 all accessed from Caldwell Road, it is especially challenging and often unsafe for pedestrians, students, and drivers early in the morning and later in the afternoon.

Each school has different challenges so any approach or any solutions must take them all into account, so no unintended consequences of change makes it worse at any one location.

HRM Staff appreciate the opportunity to hear first-hand the challenges at these locations and hear some suggestions for solutions. I will be engaging with staff to follow up on suggestions and hopefully some potential solutions that make it safer for everyone. Please remember that driving safe and cautiously in school zones is always the best approach.

## KEEPING OF EGG-LAYING HENS IN RESIDENTIAL ZONES

**Nominate an outstanding volunteer for the 2022 Volunteer Awards**



Do you know an outstanding volunteer who gives back to your community? You can nominate an adult, youth, or group for the 2022 HRM Volunteer Awards until December 15, 2021. [Nomination forms](#) are available now.

HRM honours our community volunteers every spring during National Volunteer Week. Successful nominees will be invited to attend a ceremony and reception to receive their award with the Mayor and members of Regional Council.

Households will be able to keep and raise egg-laying fowl in residential areas for personal use thanks to a recent vote by Regional Council.

Amendments have been adopted to the [Regional Municipal Planning Strategy](#) and land use by-laws to allow the keeping and raising of egg-laying hens as an accessory residential use.

In recent years, Regional Council has considered household food security and supported policy changes, partnerships, and community-based solutions to food security challenges. This change will increase access to food, food skills and connections to food's origins.

The regulations will include standards to ensure safety and compatibility with neighbourhood norms, such as providing a setback from property lines and a limit on the number of egg-laying hens permitted based on lot size.

Public education, including a voluntary registration program supporting municipal tracking of backyard hens and providing information in case of a public health issue, will also accompany these new regulations.

Significant consultation, including an online questionnaire, correspondence, and feedback from key stakeholders, contributed to this decision.

### UPCOMING TRANSIT CHANGES AND ADDED ROUTES FOR DISTRICT 3

On November 22<sup>nd</sup> the following route changes and additions will take effect:

#### Existing routes that are being replaced:

- Route 60 Eastern Passage** – Replaced by Route 6 A/B/C
- Route 63 Woodside** – Replaced by Route 6 A/B/C
- Route 62 Wildwood** – Replaced by 63 Mount Edward
- Route 57 Russell Lake** - Replaced by Route 57 Portland Estates. Service between Penhorn Terminal & Woodside Ferry Terminal replaced by Route 67 Baker
- Route 66 Penhorn** – Replaced by Route 67 Baker
- Route 58 Woodlawn** – Replaced by Route 58 Woodlawn and 158 Woodlawn Express
- Route 59 Colby** – Replaced by Route 59 Colby and 159 Colby Express
- Route 61 North Preston** – Replaced by Route 61 North Preston and 161 North Preston Express
- Route 65 Caldwell** – Replaced by Route 65 Caldwell and Route 165 Caldwell Express
- Route 68 Cherry Brook** – Replaced by Route 68 Cherry Brook and Route 168A Auburn Express & Route 168B Cherry Brook Express
- Route 78 Mount Edward Express** – Replaced by Route 178 Mount Edward Express
- Route 79 Cole Harbour Express** – Replaced by Route 179 Cole Harbour Express
- Route 159 Portland Hills MetroLink** – Replaced by all new express routes and/or Route 5 Portland
- Route 401 Porters Lake** – Replaced by Route 401 Porters Lake

#### New Routes:

- Route 5 Portland** – New corridor route (7 days/week frequent service between Portland Hills Terminal and downtown Halifax)
- Route 6 A/B/C Eastern Passage** – New branched corridor route providing service between:
  - 6A Bridge Terminal – Woodside (weekday service only)
  - 6B Bridge Terminal – Eastern Passage (7 days/week)
  - 6C Bridge Terminal – Heritage Hills (7 days/week)
- Route 57 Portland Estates** – New local route, peak period weekday service only, between Portland Hills Terminal and Penhorn Terminal.
- Route 58 Woodlawn** – New local route, 7 days week service, similar routing to former Route 58 Woodlawn but will extend to Portland Hills Terminal.
- Route 59 Colby** – New local route, 7 days/week service between Colby Village and Portland Hills Terminal following same routing between Portland Hills Terminal and Colby Village as former Route 59
- Route 61 North Preston** – New local route, 7 days/week service between North Preston and Portland Hills Terminal following mostly similar routing to former Route 61, but will take Forest Hills Parkway to Portland Hills Terminal similar to former Route 68.
- Route 63 Mount Edward** – New local route, 7 days/week service between Portland Hills Terminal and Penhorn Terminal via Mount Edward Rd, similar routing to former Route 62 Wildwood
- Route 65 Caldwell** – New local route, 7 days/week service between Caldwell Rd area and Portland Hills Terminal, similar routing between Portland Hills Terminal and Caldwell

Rd area as former Route 65 Caldwell. No service on Carisbrooke Ln., Shrewsbury Rd., Carlisle Dr., Pearl Dr., Atholea Dr., & Caldwell Rd. south of Sherwood St. Instead, the route will travel along Caldwell Rd., Astral Dr., Sherwood St. and Brookfield Ave.

**Route 67 Baker** – New local route, similar routing to former Route 66 Penhorn. Also replaces the portion of the former Route 57 Russell Lake between Penhorn Terminal and Woodside Ferry Terminal

**Route 68 Cherry Brook** – New local route, 7 days/week service between Cherry Brook and Portland Hills Terminal. Follows similar routing to former Route 68 north of Hillsboro Dr., south of Hillsboro Dr. it will follow similar routing to the former Route 61.

Below are the express routes which at peak times, will provide service in their local area (servicing all stops for the local route) then provide express, limited stop service from Portland Hills Terminal to downtown Halifax:

- Route 158 Woodlawn Express
- Route 159 Colby Express
- Route 161 North Preston Express
- Route 165 Caldwell Express
- Route 168A Auburn Express
- Route 168B Cherry Brook Express
- Route 178 Mount Edward Express
- Route 179 Cole Harbour Express

**Route 401 Porters Lake** – New rural route, 7 days/week service between Porters Lake Park & Ride and Portland Hills Terminal. Service has been eliminated to West Chezzetcook, Grand Desert and Seaforth. Three trips per day have been added on Saturdays and Sundays.


