# **ORIGIN**

Requirement to fill a vacancy on the Appeals Standing Committee following the notice of resignation from Deputy Mayor Lovelace.

# **LEGISLATIVE AUTHORITY**

Administrative Order One, Respecting the Procedures of the Council provides:

- 119. A report with recommendations for nomination and appointment shall be brought forward to the appropriate nominating or appointing body in accordance with the HRM Charter, the Public Appointment Policy and Terms of Reference adopted by the Council.
- 125. (1) A member of a committee of the Council may resign from a committee at any time by submitting to the Clerk a signed resignation and the Council shall fill the vacancy created.

Schedule 1, Appeals Standing Committee Terms of Refence

- 2. (2) Two (2) Members shall be appointed by the Council from each Community Council.
  - (3) The term of each appointment shall be for two (2) years.

# **RECOMMENDATION**

It is recommended that North West Community Council recommend that Halifax Regional Council appoint one (1) member of North West Community Council to the Appeals Standing Committee for a term to November 2022.

# **BACKGROUND/DISCUSSION**

Deputy Mayor Lovelace provided notice of their resignation on May 28, 2022 from the Appeals Standing Committee. An expression of interest was issued from the Office of the Municipal Clerk regarding interest in serving on the Appeals Standing Committee, as outlined in Attachment 1 of this report.
