### NO. 2 CONSTRUCTION BATTALION APOLOGY

With information from the Government of Canada and The Royal United Services Institute of Nova Scotia

To acknowledge the contributions and sacrifices of the No. 2 Construction Battalion and their families, an official apology parade and ceremony was held at the Truro Amateur Athletics Club Grounds on July 9<sup>th</sup>, 2022.

That day, Prime Minister Justin Trudeau issued a statement of apology on behalf of the Government of Canada to the members of No. 2 Construction Battalion. It reads as follows:

"Today, I offer the Government of Canada's apology for the appalling way the men of No. 2 Construction Battalion were treated.

For the overt racism of turning Black volunteers away when they offered to sacrifice their lives for us all–

For not letting Black service members fight alongside their white compatriots–

For denying members of No. 2 Construction Battalion the care and support they deserved-

For failing to honour and commemorate the contributions of the members of No 2. Construction Battalion and their descendants–

For the blatant anti-Black hate and systemic racism that denied these men dignity in life and death–

We are sorry. Today, we see you, and we honour you.

And to the descendants, may you forever see yourselves as heirs to the memory of true Canadian heroes."

No. 2 Construction Battalion was authorized on July 5<sup>th</sup>, 1916, in Pictou, Nova Scotia, and was composed of Black men from across Canada, the United States and the British West Indies. In 1917, the men of No. 2 Construction Battalion left Halifax to deploy overseas in support of Canada's war efforts.

These soldiers served in France's Jura Mountains, near the Swiss border. The unit spent the First World War attached to No. 5 District, Canadian Forestry Corps, producing the critical wartime commodity of lumber. Despite their many sacrifices, these men persevered through predjudice and racism.

When the No. 2 Construction Battalion returned home, they were not entitled to any recognition. Sadly, an entire community was deprived of its heroes.

### SENIORS SNOW REMOVAL PROGRAM



There is a snow removal program available for seniors (ages 65 and older) and persons with disabilities to help ensure safe access to your home.

The Senior Snow Removal is a YMCA program provided in partnership with Halifax Regional Municipality, and oversees the clearing of front and back steps, walkways, ramps, and access to fuel tanks. Please note that the program does not include driveway clearing.

# Those 65+ or persons with disabilities must also meet the following eligibility criteria:

- The participant must reside in a single dwelling home which is owned or rented;
- The participant, also including all individuals who live on the premises aged eighteen or older, must not exceed a total gross household income of \$32,000, and;
- The participant may not be a landlord.

The Senior Snow Removal operates on a first-come, first-serve basis. When maximum capacity is reached, the program will come to a close and individuals will be placed on a waitlist.

### EXCITING BUILDING RENOVATIONS COMING TO KESHEN GOODMAN

Keshen Goodman Public Library is getting updates for public spaces in and around the facility! The project starts this fall and is expected to be completed in approximately 1.5 years. Here are some highlights:

**Even more spaces to call your own:** Look forward to a bookable meeting space for 4 persons, teens enclosed computer space, school-aged children area with kidsized pods, adult-sized pods with open sides and dimmable lights, and getaway nooks.

# More quiet spaces - and group spaces are being created, including:

- An addition between the building and parking lot for staff workspace frees up more space for community members.
- Organic-themed, soft elements dampen sound, such as a green lily pad carpet and felt acoustics panels shaped like clouds along the ceiling.
- Pods to interrupt sound carrying and provide you with a private space for work.

**More outdoor features, including:** Hammocks, bike stands, outdoor seating, and electrical outlets.

**More accessibility features, including:** A fully accessible washroom with an adult change table, way finding signs that are language-friendly, carpet tile leading to key areas, adjustable lighting in the adult study pods.

### FRASER LAKE UPDATES: FURTHER STUDY OF COMMUNITY GROWTH AND INFRASTRUCTURE RECOMMENDED

The public hearing for Phase 3 of the municipality's Regional Plan was approved on October 11<sup>th</sup>, 2022. As part of that staff report, the Fraser Lake area was included for further study in Phase 5 of the Regional Plan Review.

**Development Proposal Background:** There was a request by Clayton Developments Limited to extend the Urban Service Area boundary to enable residential development in this area, with an estimated 690 units proposed. Specifically, this area includes lands near Fraser Lake, 2832 St. Margaret's Bay Road, Timberlea (PIDs 40054306, 40054363, 40261729, 40689358, 40319550).

**Feedback:** Although staff did not actively seek public comment on this request during Phase 3, the request letter from Clayton Developments Limited was published on the Regional Plan Review *Shape Your City* webpage, and there were 17 submissions received and published in Attachment I and Attachment J of the staff report: <u>https://bit.ly/3goNriu</u>

These submissions expressed strong opposition to development on this site. Residents expressed concern about the ecological integrity of the site, the impact of increased traffic from a development of this size, and how it will impact water quality and nearby wilderness area. Concerns were also expressed by residents about a change to the Urban Service Boundary and how it may impact current residents and where the services would connect.

**Current Status / Next Steps:** Municipal staff are recommending further study of community growth and infrastructure in this area. Phase 4 of the Regional Plan is just beginning, and HRM staff are anticipating releasing a draft in Spring, 2023. The timing on Phase 5 is dependent on Council approval of Phase 4, but it is likely to occur in 2023/2024.
