**SUBJECT:** 2024 Halifax Regional Council Meeting Schedule

#### **ORIGIN**

Halifax Regional Council must adopt a schedule for meetings of Regional Council for the upcoming year.

#### **LEGISLATIVE AUTHORITY**

Administrative Order 1, the *Procedures of the Council Administrative Order* (Administrative Order One), as follows:

8. The Council shall meet on such Tuesdays determined by Council, and shall be held at such an hour as deemed appropriate by the Mayor and CAO jointly.

#### Schedule 6, Executive Standing Committee - Terms of Reference

8. The Executive Standing Committee shall act as a review committee for matters related to the general self-governance and administration of the Council as directed by the Council.

#### Appendix A

2. (1) A public hearing held by Council shall be advertised to commence at 6:00 p.m., or such other time as set by resolution of the Council

#### **RECOMMENDATION**

It is recommended that Executive Standing Committee recommend that Halifax Regional Council:

1. approve the proposed 2024 Regional Council meeting schedule as outlined in Attachment 1 of this report; and

2. direct, in accordance with Administrative Order One, Appendix A, Subsection 2(1), that if the only business for Regional Council listed on the agenda for the meeting is one or more Public Hearings, then the public hearing shall be advertised to commence at 5:00 p.m. rather than 6:00 pm.

#### **BACKGROUND**

In accordance with Administrative Order One, Section 8, regular Council sessions are held on those Tuesdays determined by Council at an hour deemed appropriate by the Mayor and Chief Administrative Officer (CAO) jointly. Regularly scheduled meetings of Council may be cancelled with the agreement of the Mayor and CAO. Other meetings of Council may be added with appropriate notice provided it is done in accordance with the Halifax Regional Municipality Charter and Administrative Order One.

#### **DISCUSSION**

Since amalgamation Regional Council has adopted a meeting schedule for the coming year. This process allows members of Council, staff and the public to be notified and plan in advance for the Council meetings.

The proposed modified bi-weekly schedule has been adjusted this year to allow for additional, if required, meetings for public hearings only (Attachment 1). This schedule proposes 20 regular meetings, 3 if required meetings, and 3 if required public hearing meetings which are proposed to commence at 5:00pm. The purpose of this is to allow for additional meetings for hearings if required, have them start earlier and allow for more strategic agenda planning, holding other items for regular meetings where possible and directing public hearings to specific dates.

The proposed schedule considers statutory holidays, March Break, Federation of Canadian Municipalities' Annual Conference, Nova Scotia Federation of Municipalities' Fall Conference, the proposed 2024 Budget Committee schedule, and the number of meetings provided for in 2023.

Where 2024 is an election year, with polls anticipated to open as early as October 10 and the Municipal Election on October 19, 2024, Council meetings are anticipated to end following the close of nominations on September 10, 2024, until the Swearing in Ceremony on November 5. Although there are no restrictions in the *Halifax Regional Municipality Charter* or the *Municipal Elections Act* preventing Council from conducting business close to an election, there may be a perceived benefit to incumbents. If meetings are needed during this period, an if required meeting is proposed for October 1 and additional special meetings of Council could be called to deal with urgent business.

#### FINANCIAL IMPLICATIONS

There are no budget implications associated with the recommended course of action.

#### **RISK CONSIDERATION**

A delay in approval could result in additional delays for other meeting schedules, as consideration of the approved Council schedule is used when proposing other Committee meeting dates.

In terms of Council not holding meetings from September 10 until November 5, due to the 2024 Municipal Election, while there is nothing in legislation that would prevent Regional Council from holding meetings, there have been concerns raised in the past about holding meetings during the election period.

There may be a corporate risk with no meetings for this duration where approvals required by Council may delay items. This risk can be mitigated by early communication of the 2024 schedule and planning to have any items that require Council approval dealt with no later than the September 10, 2024. Finally, an if required meeting is proposed for October 1 and additional special meetings of Council could be called to deal with urgent business if needed.

#### **COMMUNITY ENGAGEMENT**

The 2024 meeting schedule once adopted, is posted online at Halifax.ca to enable members of the public and media to have access to the meeting schedule.

#### **ENVIRONMENTAL IMPLICATIONS**

No environmental implications were identified.

#### **ALTERNATIVES**

Amendments to the proposed 2024 Regional Council meeting schedule as outlined in Attachment 1 may be made as required.

Executive Standing Committee could recommend that Halifax Regional Council approve the proposed 2024 Regional Council meeting schedule as outlined in Attachment 2 of this report. If this alternative is passed, part 2 of the recommendation would not be required and item 1 would need to be amended to change the Attachment number from 1 to 2.
