SUBJECT: Order to Demolish – Case # 2023 17718, 80 Brunt Road, Harrietsfield

#### SUPPLEMENTARY REPORT - Deferral from September 7, 2023 Appeals meeting

#### **ORIGIN**

Staff, pursuant to the *Halifax Regional Municipality Charter* (the "Charter").

## **LEGISLATIVE AUTHORITY**

Sections 355, 356 and 3(q) of the Halifax Regional Municipality Charter, S.N.S., 2008 C.39.

#### **RECOMMENDATION**

It is recommended that the Appeals Standing Committee:

Find the property to be dangerous or unsightly as per section 3(q) of the Charter and as per section 356 of the Charter, **orders demolition** of the barn at 80 Brunt Road including but not limited to, the removal of all demolition debris, backfilling of any foundation or crawl space, and disconnecting any and all utility connections to the standard set by each respective utility service provider, so as to leave the property in a neat, tidy, environmentally compliant and safe condition within thirty (30) days after the Order is posted in a conspicuous place upon the property or personally served upon the owner. Otherwise, the Municipality will exercise its rights as set forth under Part XV (15) of the Charter.

#### **BACKGROUND:**

Compliance case # CF-2023-17718 deals with 3 civics, #36, #42, and #80 Brunt Road. This report will focus on the concerns related to civic address 80 Brunt Road and the barn structure.

On September 7, 2023, the Appeals Standing Committee heard and issued Demolition Orders for the structures located at civic#36 and #42 Brunt Road. During the meeting, the property owner advised the committee that they wished to undertake repairs to salvage the barn structure. The Committee deferred the Demolition Order request for the barn located at 80 Brunt Road, Harrietsfield, until the January 2024 meeting, to provide additional time for the property owner as requested.

Following the September 7, 2023 Appeals Standing Committee meeting, the property owner has been issued demolition permits for civic #36 and #42 Brunt Road. The permits were issued on October 25, 2023 with an expiry date of April 23, 2024.

The property ownership changed in January 2022. Since then, there have been 7 dangerous or unsightly cases at the property due to open access. One case was closed with owner compliance and six cases were closed with HRM securing the building.

On June 23, 2023, Halifax Regional Fire Prevention contacted our office as their department reported structural damage to the barn at 80 Brunt Road due to 2 fires that recently occurred at the property. There was also concern expressed that the property posed an allurement and risk to those that may enter.

A subsequent complaint was received on June 25, 2023. The complainant reported that the property is dangerous and unsightly due to a 5-year abandonment resulting in individuals accessing the structure. The complainant expressed concerns related to fires, windows are broken or boarded up, and there is debris all over the property.

The property is zoned R-6 (rural residential).

A review of the HRM database system shows no permits have been issued for 80 Brunt Road.

The Compliance Officer is bringing this case forward to the committee to request a Demolition Order for the barn located at 80 Brunt Road (Case # 2023 17718).

## **CHRONOLOGY OF CASE ACTIVITES:**

24-Jun-2023 The Compliance Officer spoke with Halifax Regional Fire, expressed concerns about the ongoing issues and risks the property poses to neighboring properties.

The Compliance Officer conducted a site inspection at 36, 42 and 80 Brunt Road, Harrietsfield hereinafter referred to as "the property" (attached as Appendix B).

The Compliance Officer noted a deteriorated barn with open access at 80 Brunt Road. The inside of the barn revealed tire tracks from off road vehicles, multiple fire remains, graffiti all over the inside, parts of the ceiling falling in, holes in exterior walls, and the horse stalls were full of wood, hay, and other ignitable debris.

While the Officer was on site, a neighbor approached and expressed their concern with the state of the property.

28-Jun-2023 The Compliance Officer phoned the complainant and advised that the building has been secured against open access. The complainant advised that they observed the board-up

	taking place, stated it would only be temporary, and that they would submit a statement of their concerns to the Officer.
29-Jun-2023	The complainant emailed the Compliance Officer their concerns regarding the property and specifically the deteriorated structure at 80 Brunt Road. The complainant stated that the structures are extremely run down and pose an allurement to youth. With the recent wildfires, the complainant expressed their fear of a fire getting out of control at the property.
07-Jul-2023	The Building Official submitted a Structural Integrity Report for the barn at 80 Brunt Road (attached as Appendix C).
	The overall comment regarding 80 Brunt Road is: "The barn is not structurally sound; it would not be cost effective to repair."
13-Jul-2023	A Halifax Regional Fire Captain sent an email to the Compliance Officer advising that Fire Services responded to two fires at this location on November 29, 2022, and June 21, 2023.
07-Sep-2023	The case was heard at the Appeals Standing Committee, decision on barn structure, deferred to January 11, 2024.
30-Nov-2023	A complaint was received that boards were removed and individuals were gaining access to the lower level of the structure as well as the roof. An Immediate Order to Remedy was issued and an HRM hired contractor completed the board up to secure the open access.
04-Jan-2024	The Compliance Officer attended the property to complete a site inspection. The Officer noted the barn was unsecure and had open access. An Immediate Order to Remedy was issued and an HRM hired contractor secured the building.
08-Jan-2024	The Compliance Officer was in contact with the property owner. The property owner advised work has not been completed at the property as he is out of the country dealing with a family emergency.
25-Jan-2024	The Compliance Officer attended the property to post the Notice to Appear (attached as Appendix D) on the barn at 80 Brunt Road. The Officer noted the barn had open access. An Immediate Order to Remedy was issued and an HRM hired contractor secured the building.

## **FINANCIAL IMPLICATIONS**

There are no financial implications if the owner complies with the Order. If the Municipality is required to complete the work, the costs will form a debt against the property which may be collected in the same manner as taxes pursuant to the Halifax Regional Municipality Charter, S.N.S., 2008, C.39.

## **RISK CONSIDERATIONS**

The risk considerations rate moderate. The structures pose a risk to anyone who may enter and due to the deteriorated state of the buildings, they are unable to be fully secured from public access.

## **ENVIRONMENTAL IMPLICATIONS**

No environmental impact identified.

## **ALTERNATIVES**

The state of the property suggests no viable alternative to the recommendation by Staff.

## Halifax Regional Municipality Charter ("HRM Charter) Subsection 355, 356 and 3(q)

HRM Charter, subsection 355 (1) (2) as follows:

- 355 (1) The Council may, by policy, delegate some or all of its authority pursuant to this Part, except the authority to order demolition, to the Administrator.
  - (2) The Council may, by policy, delegate its authority pursuant to this Part, or such of its authority as is not delegated to the Administrator, to a community council or to a standing committee, for all or part of the Municipality.

HRM Charter, subsections 356(1)(3), as follows:

- Where a property is dangerous or unsightly, the Council may order the owner to remedy the condition by removal, demolition or repair, specifying in the order what is required to be done.
  - (3) Where it is proposed to order demolition, before the order is made not less than seven days notice must be given to the owner specifying the date, time and place of the meeting at which the order will be considered and that the owner will be given the opportunity to appear and be heard before any order is made.


## HRM Charter, subsection 3(q) as follows:

- (q) "dangerous or unsightly" means partly demolished, decayed, deteriorated or in a state of disrepair so as to be dangerous, unsightly or unhealthy, and includes property containing
- (i) ashes, junk, cleanings of yards or other rubbish or refuse or a derelict vehicle, vessel, item of equipment or machinery, or bodies of these or parts thereof,
- (ii) an accumulation of wood shavings, paper, sawdust, dry and inflammable grass or weeds or other combustible material,
- (iia) an accumulation or collection of materials or refuse that is stockpiled, hidden or stored away and is dangerous, unsightly, unhealthy or offensive to a person, or
- (iii) any other thing that is dangerous, unsightly, unhealthy
- or offensive to a person, and includes property or a building or structure with or without structural deficiencies
- (iv) that is in a ruinous or dilapidated condition,
- (v) the condition of which seriously depreciates the value of land or buildings in the vicinity,
- (vi) that is in such a state of non-repair as to be no longer suitable for human habitation or business purposes,
- (vii) that is an allurement to children who may play there to their danger,
- (viii) constituting a hazard to the health or safety of the public,
- (ix) that is unsightly in relation to neighbouring properties because the exterior finish of the building or structure or the landscaping is not maintained,
- (x) that is a fire hazard to itself or to surrounding lands or buildings,
- (xi) that has been excavated or had fill placed on it in a manner that results in a hazard, or
- (xii) that is in a poor state of hygiene or cleanliness;
