TUBERCULOSIS HOSPITAL - CITY HOME PROPERTY.

A delegation of residents of the neighborhood of the west end of the City Home property, consisting of Col. Flowers, J. C. Halloway, John Quinn, Deputy Mayor Powell, Alderman Smith and others, appeared before the Board in connection with the proposition to temporarily use the Hospital building in the City Home property for the treatment of advanced cases of tuber cular poor.

Strongly objected to the use of the building as a Tuberculosis Hospital, but because of the urgency under existing circumstances, would not press their objection, provided it was explicitely agreed that no alterations would be made to the building, and that its use as a Tuberculosis Hospital would positively cease not later than May 1st, 1915. Mr. Quinn urged that all other buildings which might possibly be suitable be investigated before the City Home property is finally selected, and suggested Mrs. Nolan's sanitorium at Willow Park.

Meeting to inquire into affairs

at the City Prison.

Halifax, N.S. September 18,1914.

Present; - The Mayor, Controllers Harris, Hoben, Scanlan.

(There were also present Mr. Wier, Governor and Mrs. Grant of the City Prison, and many clergymen and citizens.)

The Mayor said that the meeting had been called to inquire into matters at Rock Head and that Mr. Wier and the Governor had been notified to be present.

Controller Harris; The Governor was not notified.

The Myor; You don't stand on any question of that kind? I understood the clerk had sent notices to Mr. Wier and Mr. Grant to be present; and they are here; we will now have Mr. Wier's letter read.

Mr. Wier's letter of the 10th September was then read.

The Mayor; I do not know anything of the merits of the case.

After I received this letter one meeting passed; I received just the day previous to the ordinary meeting of the Board and I did not bring it up; at the next meeting I had the letter read and it was decided that Mr. Wier and the Governor should be summoned to attend and in consequence of that you are here. I do not know whether Mr. Harris answered Mr. Wier or not; but you say that is your reply. (Controller Harris handed in his reply).

H.V.Wier; This reply has just been placed in my hands since I came into this room and I have not yet read it.

Controller Harris; Defore the letter was presented to the Board Mr. Wier came into my office, and I have put in writing today my explanation so that there will be no misunderstanding.

The Mayor; We will have the answer read! I think it is only fair.

Mr. Wier; I want to make one remark. I regret to say that the matters detailed here have to a large extent been gone over at various times by ourselves; some are correct and some are incorrect. One statement alone will be sufficient to illustrate; in the front page it states; "No service was held by you on July 12th" .

Controller Harris; Read that sentence correctly.

Mr. Wier; No service was held for them by you on July 12th.

controller Harris; For the female prisoners; you left out "for them"; you held service at the prison, but not in the women's corridor.

Mr. Wier; This is a very skilfully drawn paper. I have been going to the City Prison since 1906 and I have been going not to incur enmity, hostility or to seek trouble in any way, but with one object, to help the people . To some extent we have been very successful. I find that owing to my contact with the affairs and the people there I have several times been brought into a place where disagreeable duties have to be performed; duties I would be very pleased to avoid. I want to make this matter particularly clear on this present instance. I want it understood that I attach no blame to any of the underkeepers of the City Prison; they have been discharging, as far as they were able, a very embarrassing and awkward duty in carrying out their orders, which I have been told were delivered by the Governor. Under the circumstances I wish to be fair and distinctly understood that we attach no blame to any underkeeper. I have no axe of a political or personal kind to grind; absolutely none. I am not here in a spirit of malice, hatred or revenge; I simply say to you that I appear here today on behelf of myself and my associates in connection with this work which is endorsed by the Evangelical Alliance of this City; and we have one object, and one only, and that object is that the Protestant services at the City Prison be relieved of the restraints, hindrances, offences and insults that Mr. Grant, the Head Keeper, has seen fit to subject us to since July 12th last.

A few of these I will relate to you and these are what we ask you to deal with. The question of the room does not affect us; that was eliminated long ago. Sundry other matters in the letter can be eliminated as far as I am concerned. But coming down to the service on Sunday afternoons to those who are locked up and debarred, we should be relieved from these embarrassing and offensive conditions. I want to say that at the close of the service on the 12th July last we came downstairs - I am speaking from memory, and there are three witnesses here - when half way down the Head Keeper approached and in a loud and offensive tone said, you are violating the rules. When I reached the floor I asked, what rules? He pointed to the card of Rules. I said, tell me the Rule, and he said, Number 2. I think it deals with the giving of presents to prisoners. I said, I have never violated that rule and I have never been accused before or since, and that has got to be proven or withdrawn. I and my associates have provided prisoners with clothing more or less and it has been sent there to be delivered on the expiration of the terms.

On Sunday July 26th, at the close of that service, Keeper Hensley, whom is not present, he was the keeper in charge of that service - I noticed no women were present at that service; I had not any particular idea, and I asked one of my associates what we had better do about the women - I said to Hensley, inform the matron when you are clear of the men we will have service for the women. He returned in a few minutes and said, there is to be no service for the women. In reply to the keeper I said, inform the matron we will hold the service in the corridor. We came down the three flights of steps and crossed the main hall and we stood, the men and the two ladies, at the entrance door of the womens corridor, during which time we were treated to a violent exhibition of temper by Mrs. Grant. Among other statements she made the following; There is only one service; I won't go in ; I won't go into the women's corridor; I will send Mr. Yeadon in to hear what they have to say.

I heard Mr. Crant say to her twice, open the door of that corridor, which she finally did. As Mrs. Grant was unbolting or unfastening the door, I was standing at the foot of the stair rail I realised the presence of Mr. Grant who addressed himself to the two ladies, Mrs. Jones and Miss Lyall and his manner and attitude was hostile and offensive to them. There was an awkward pause and I broke it by saying, How is Mr. Grant today, and the replicat I got, and it was very offensive the way he said it, was, None the better for your asking, Mr. Wier.

on Sunday the 2nd August, the service closed that day at 3.30. Yeadon was the keeper in charge, and he informed me there were a number of prisoners who wished to see me and I could see them in the corridor; not having had any previous intimation of the new rule, I took it to be one that had been made; when I reached the main door - the prisoners were in the main hall - I heard Mr. Grant addressing the prisoners, and I heard these words; Any men who are going out before the religious instructors return may see Mr. Wier, but no others; it is not necessary. named Lacey came out, but before we could exchange a word, Mr. Grant interrupted and asked whan his time was up. He answered in November; when Mr. Grant said, you have plenty of time to see Mr. Wier. I asked the prisoner what I could do for him; he said, I want to find out about my father, I wrote to him two weeks ago and I have not heard and he may be sick; Mr. Grant again interrupted and said, Yourfather's in town, you don't need to bother. prisoner is a young man who, when I first saw him, asked me if I would acquaint his father with his predicament. I did and his father saw him. Some time elapsed and then the boy asked me if I would find out about his father and would I let him know the next Sunday; which I did. Yeadon was the keeper in charge and he heard that conversation.

On Sunday the 9th August, just before opening the service, I extended my hand to one of the prisoners who occupied a front

service had ologed. I am prepared here and new Mr. Yeadon said, Mr. Wier, you are not allowed to corner seat. speak to any of the prisoners, it is my orders. I said, who gave those orders. He replied, the Governor says you must not speak to them without z permission. I asked, Am I to understand that neither I nor my assistants are permitted to speak to the prisoners; Mr. Yeadon replied, I will speak to the Governor when I go down; you must not blame me . I said, certainly not. At the close of the service we went down and held a short service for the women in the women's corridor. We had as the lady in charge of the music there that day, Miss Lyall. She had no organ, books etc., for the service and leaving out that part of the programme to her, she asked the women if they knew Hymn 117, and as she commenced to repeat the first lines of that old familiar hymn axi the keeper said, Ladies you are not permitted to speak to the prisoners. You will understand that these interruptions which take place under circumstances like that are not interruptions that would bother us in a meeting of this kind. Those persons who know realise how embarrassing and irritating and annoying it is to have these interruptions coming contantly week to week. These memorandums are typewritten, taken from the original notes which I have taken from a little book in my pocket. I do not trust to my memory; the data is here and goes back for years, and I regret there are memorandums of this kind.

On August 23rd at the close of the service I was about to speak to one of the prisoners when the keeper interrupted and said, You are not permitted to speak to the prisoners. At this service on the 23rd there was a gentleman visiting the City. Mr. James Potter, whom I had the good fortune to take tea with a day of two previous and I invited him and he was present and witnessed the interruption and he said afterwards it was a most unfortunate state of affairs and should be remedied promptly because it was having a bad effect on the prisoners and all concerned.

The reference made in my letter in regard to the service on Sunday September 6th; it was interrupted by Charles Yeadon.

Mr. Harris offered me an explanation that Yeadon was under the 342

impression that our service had closed. I am prepared here and now to accept that explanation and exclude Yeadon from any blame in the matter.

The difficulties under the present regime are quite sufficient without my being enforced to drag in any of the keepers to receive odium from the Head Keeper; Mr. Harris knows full well what I mean and if there is any investigation data will be brought out as to that. This does not excuse the continuous interruptions from July 12th down to the end of August, prior to the Sunday referred to in the end of that letter. Mr. Harris and I have discussed these matters; I have gone into the privacy of his own office and showed him the folly of not dealing with the matter and preventing it from being published and to keep it out of the papers, but evidently he thought better to do otherwise and gave me no protection in this matter but rather intimated it was a personal affair and I am quite satisfied he should have that view; I wish to say that at all times I have no quarrel in this matter and do not propose to quarrel with Mr. Grant on it; I won't accept that attitude; I am not going in that spirit and if there is to be a quarrel thrust on me I shall not accept it. If I had been in a quarrelsome mood offences have been numerous enough and I think it would have pleased them better than anything.

I want to go back to the first statement and ask you to give us the benefit of your inquiry here such as it may be and free us from these hindrances and annoyances in order that the work may be prosecuted and that the good we seek to do these unfortunates may be done.

The Mayor. We have heard Mr. Wier's statement and the charges made against the Governor: I suppose the next will be to call the governor.

Controller Harris; I want to cross-examine Mr. Wier.

It was rather awkward the way we were placed. His statements are not exaggerated. Controller Hoben to Miss Lyall; Are you a teacher in the public shhools? A. I am . In what school? A. Tower Road. Mr. Wier; Don't you consider the keepers had an awkward duty to perform and that it was an unfair position to put them in ? Miss Lyall; I do; and, what is more, I think the keepers them selves did not like to perform it, from the way they did it; they rather shrank from it; they didn't say anything more than they had to, they simply did as ordered.

Mr. Wier; I have nothing further to say except that we be relieved from this state of affairs.

Controller Scanlan; What led up to this friction? There is evidently friction between Mr. Grant and Mr. Wier. I know up to . the time of the investigation of the Mary Murphy case they appeared to be working in harmony. I would like to ask if Mr. Grant knows anything that has led up to this friction between Mr. Wier . Controller Harris; Is it correct about Mr. Giffin being present on July 12th and 26th ?

Mr. Vier; Speaking from memory, he has been with me since last I have not got the dates recorded.

Controller Harris; Mr. Grant does and he has not Mr. Giffin's name down for these two days and that is the reason I said he does not seem to have been present on these two dates.

Mr. Wier has come here with data and so forth and I may say I have not come with that and as I am the defendant in the case I would ask time to prepare a statement so as to give everything accurate. Mr. Wier has stated his side of the story, but I cannot remember it all, and there is nothing that gives people went of confidence more than the behaviour of officials and I consider, as the head of the City Prison I endeavour to carry out my duties to the letter with a conscience devoid of offence towards any. Alderman Murphy; It would look to me in the general spirit of those taking part, there is very little to be done today, by denials on one side and assertions on the other. CIVIL SOCIAL SERVICE BUREAU.

Controller O'Connor reads and submits a statement of his views as to the establishment of a Civil Social Service Bureau, as follows:-Halifax, Sept. 28th, 1914.

Re Social Service Bureau and application for grant of \$1500.00, or less, and civic spperintendence.

On Friday last, I asked for a delay of decision upon this application until today. I felt so strongly disposed towards its support that I hoped to be able to devise some means whereby civic authority might be imparted to the acts of the proposed body, but certain difficulties were apparent to me, and consideration has not resolved them.

- The financial aspect of the matter I regard as not the most important. Nevertheless, any financial support that the City might be able to give could not even approach the amount suggested. The amount contributable, if any, considering the financial circumstances, would be so small that it might be considered insignificant, so I do not favor the offer of any grant at all.
- 2. I would be opposed to civic superintencence f. I would be opposed to the establishment of itself. the office in the City Hall of such an association. Once such an organization was instituted, it would survive so long as the salaried officials thereof and their friends could so insure, and other officials would from time to time be found "necessary". Such is civic experience. So do civic budgets grow. And, aside from the turning of the City Hall into a resort

for mendicants, civic authority or superintendence would entail the unloosing as against the Mayor, the Controllers and the Aldermen of a horde of the impecunious who would demand their influence towards the securing of the always coveted "Something for nothing". I do not consider such conditions desirable.

3. The scheme itself I consider good and necessary, but not more necessary now than ever. The body should be permanent in character, if established at all.

I look for busy times this coming winter, and not for destitution. It would seem that the charitable societies interested could best and most properly effect their purpose by their own joint action. The funds saved by the proposed co-ordination of action would be their funds, not civic funds, and believing that this theory is right, and that savings could be effected, it seems to me that these savings might well be applied towards the expense of the kind of Bureau proposed, with the idea that the collateral advantages so ably and eloquently expounded to the Board might be regarded as the profit justifying the diverted and better expenditure of said moneys.

Mitchell, in answer to the Mayor; I had intercourse with her but believe there were also others. I kept company with her for about a couple of years. We quarrelled, but afterwards made up again. After the quarrel she used to come to my house and I could not get rid of her; I told her to keep away. After I

had promised to marry her I had intercourse with her, but this was after we had a row and she kept following me. I had intercourse with her five, six or seven times perhaps. After our first row I have coaxed ger to have intercourse with me and she kept following me up. When I left her she said that she was sick but not in trouble. The length of time during which I was having intercourse with her was for a month or so: the last time along in the early part of December, 1913. When brought before the court in bastardy proceedings I pleaded guilty thinking it would stop trouble and that I would not lose my job on the police force. Don't remember the date fixed for our marriage, or the time at which we fixed the date. The date for our marriage was fixed for about the last of December or in January. Sometime in January I told her I would not marry her. Long before that I stopped having intercourse with her. A year and three or four months ago I gave her an engagement ring. I had intercourse with her while we were engaged. In December 1913 I guess she thought she was engaged to me. Also in the month of December.

Miss Alice Findley, sworn.

Mitchell and I were keeping company for two years.

In December we started to quarrel. In January and
February he stopped coming to my house. In May he
knew of my trouble. Lots of times he told me he would
marry me. On 16th July,1914, he promised to marry me.

Our child is living. He had intercourse with me as he
says six or seven times. We were engaged 24th December
1912. About a week before July 16th,1914, he asked
me for my ring to use it for measuring for our marriage

ring. He never gave it back to me; I never saw it afterwards.

In answer to questions by the Mayor, as to whether Mitchell complained of jealousy, witness says, Mitchell often used to say things to me about not going with other fellows.

Cross-examined by Mitchell; In December I told you I was not in trouble but I did not know I was in trouble.

I was sick, but didn't know the reason. I was sick with rheumatism and was being treated by Dr. O'Shaughnessy.

Mrs. Emma Findley, sworn.

I told Mitchell about the 16th July 1914, she was in trouble. He said he didn't think the child belonged to him but that he would marry her. She was quite a while with child, six or seven months, before she told me. She kept it secret from me. In May she told me she was in trouble. Previous to May I had no suspicion of wrong between my daughter and Mitchell; I thought he was going to marry her and was more of a man than to get her in trouble.

Alice Findley, requestioned, stated that the last time she had connection with Mitchell it was at his own house. It occurred at different places and once or twice at my house. My mother was not in a position to know anything about it. When he first had connection with me we were engaged. I had his engagement ring at that time. It was his fault, he induced me.

The Chief of Police questioned, states that he had never had a charge against Mitchell; there is no weight to him as a policeman; at the time of the street railway strike there was some complaint as to Mitchell not doing his duty.

John Bennett and Pettipas called by Schotts, stated that they were in Schotts' store while Smith and Mason were there, and that Smith stated (to Schotts) that if Mr. Hopewell wouldn't pay the card, that he (Smith) would see it paid.

All witnesses agreed that all present knew that

it was printed on the card in red ink that the card was not negotiable.

Smith stated that he did not know at the time that Mason owed Mrs. Verge for board.

No action is taken in the matter.

Governor Grant and H. V. Wier are in attendance. For record of proceedings see Mr. Eccles' notes.

BOARD OF CONTROL.

Meeting to inquire into affairs at the City Prison.

Halifax, N.S. October 26,1914.

Present: - The Mayor, Controllers Harris, Hoben, Scanlan and O'Connor.

We held a meeting to investigate certain The Mayor: charges made by Mr. Wier against Governor Grant of Rockhead Prison, that is of using insulting language and interfering with the proper discharge of the religious exercises in the Institution, and counter charges by Mr. Grant that Mr. Wier interfered with the discipline of the prison, with the regulations of the prison. We had an address from Mr. Wier and Mr. Grant on this subject a few weeks ago and I don't know that it is necessary to have those addresses again; I don't know what course the Board wishes to pursue ; we are ready to hear the evidence and take it upon oath. I may say this matter was postponed on the request of the Evangelical Alliance until they should deal with the matter but we received a letter from the Alliance which perhaps should be read before we proceed with the evidence; the gist of it is we should go ahead first, after protesting we should not. Controller Harris: The Alliance did not protest. The Mayor: The President did; Mr. Johnston; didn't know there were differences of opinion. You all know Mr. Wier is the representative; he has authority for being there and holding the services: it was given some few years before I had the honour of a seat here, and as respects the Evangelical Alliance, I supposed they were going to deal with it but they dont seem to have done that and I take it for granted from the reports that have reached me that he is still in his position satisfactorily to

them and we are here to investigate any charges
he has against Mr. Grant and anything that Mr. Grant
has against Mr. Wier. Dr. Forrest is here and
perhaps it would be as well to sh-ow the status
Dr. Forrest occupies.

Controller Harris. I am satisfied with that.

Mr. Wier. Mr. Harris was the only man who
questioned my relation to the Alliance.

(Letter from the Alliance was read) The Mayor. That simply means that Mr. Johnston when he asked for this matter to be deferred, until the matter was taken up by the Alliance, the Alliance did'nt support him, and we were taking the proper course in going ahead with the matter, as Mr. Wier is the proper accredited representative The first charge against Mr. of the Alliance. Grant, we have heard a great deal -Controller Harris. There are six particular dates when he charges Mr. Grant with discourtesy and he referred to these in the evidence he gave before. The Mayor. Perhaps it should be read over, and then he can swear to that. Mr. Wier has been presented with a copy of this and if he has read it over he can swear to it. Mr. Wier. At the beginning I made a statement in

Mr. Wier. At the beginning I made a statement in this room at the first session and in that statement I said, I appeal to the present Board of Control, but two members have been added since.

Controller Harris. No.

Mr. Wier. This was the statement I made, and I make it here tonight; you are appealed to by myself and my associates in connection with this work, that we have one object and one only, and that object is, that the Protestant services at the City Prison be relieved of the restraints,

has seen fit to subject us to since July 12th last. I then followed with specific statements of the hindrances and objections.

(Mr. Wiers statement of September 18th 1914 was then read over to him and then signed by him)

Mr. Wier. That is substantially correct and I accept that. Might I ask as to the where-abouts of two witnesses.

Controller Harris. They will be produced when the time comes.

Mr. Wier. At previous investigations the witnesses were always present in this room.

(Mr. Wier was then sworn)

The Mayor. This statement that has been read over to you by the Clerk, that is substantially correct; do you wish to amplify that in any way before we go self on with the next witness.

Controller Harris. I want to ask Mr. Wier some questions.

Mr. Wier. Is Mr. Harris here as the representative of the people or the Solicitor of Mr. Grant; if so, it is a dual position I do not understand.

The Mayor. He is the Chairman of the City Prison Committee, and if his attitude assumes that of an advocate on either side we -

Mr. Wier. We had an investigation in connection with prison matters and some prisoners were asked to be present, and they were seated at the back of the room with the keepers; my witnesses if here at all, are locked up in the cell and they should be here.

Controller Herris. Just where they ought to be.

Mr. Wier. Why didnt you lock them up before
when they were here; they were in charge of a
policeman then.

are locked up in cells and are accustomed to it. The Mayor; The witnesses you have asked for we will have here if you say it is at all necessary. Mr. Wier; I do not think it is fair to have them locked up in the cells and then suddenly brought into this light; let them get accustomed to the atmosphere of this room; you didn't treat them before in the that way and there is no reason for treating them in that way now. I ask for two. Controller Harris: There are three; one is a

witness for Mr. Grant.

The Mayor: Do you wish to amplify this testimony at the present time.

Mr. Wier: No. Those are the bare facts. Comtroller Harris: You have rather questioned the statement of your status up there: I think you misunderstood me in the first place; I said you are not official Chaplain, you/an official Chaplain: is that correct?

Mr. Wier: That is your statement.

Controller Harris: Is that not a statement of fact. Are you not the official representative of the Evangelical Alliance?

Mr. Wier: I have always understood I was.

Controller Harris: You don't profess to exercise any

authority over the Salvation Army representative

up there. Mr Wier: Certainly not.

Controller Harris: You are not the Official Chaplain?

Mr. Wier: In the sense you are putting it perhaps

not.

Controller Harris: That is the sense I understood. You were appointed on Merch 7th 1912? A: You have the record there, I have none here; I think the dat-e is accurate.

Q. You said in your evidence that your one object is

relieved of the restraints, hindrances, offences and insults; when you say the word Protestant you don't mean the Salvation Army? A. I am speaking in connection with the services I have been taking.

Q. Not all Protestant services? A. Only the services I have conducted.

- Q. Would it surprise you to know that the Salvation Army have not been hindered? A. Nothing would surprise me in the City Prison under the present Regime.
- Q. Would it surprise you that the Salvation Army or the Roman Catholics were not hindered in any way?
- A. Whether they were or not what has that got to do with it? I have enough to look after my own affairs without bothering with the Salvation Army.
- Q. You spoke of the question of the room; was that settled satisfactorily to you? A. No, I eliminated that; I could not get what is reasonable and right and it is not what it should be for the services.
- Q. The trouble about the room arose on July 5th?
- A. Thereabouts.
- Q. That is settled, Rev. Robert Johnston, yourself, and myself met at the prison in connection with it, is that not right? A. No, It is not right, it is not settled yet?
- Johnston and myself that that room would be satisfactory to you and you had no objection to it, but the objections came from Mrs Jones and Miss Lyle
- A. I said as far as the room is concerned we could drop that entirely. I could do with it, and I say so still. I can hold the services on the roof,
- Q. From that time on you didnt raise objections
- to the room? A. I have not raised objections.
- Q. July 12th; that occurred when this difficulty about the room existed? A. What difficulty are

you speaking of.

- Q. The difficulty of where the services could be heard. A. I did not find any great difficulty.
- Q. If you say it existed on July 5th, 12th, and 26th? A. I say the room is not adopted for the services.
- Q. The friction existed on July 12th as to where the services should be held? A. I have not said that, you have said that.
- Q. Did not that friction exist on July 12th as to where the services should be held? A. The plain statement of fact is, I objected to the meetings up-stairs, I did not consider the room suitable, it is too large and vaulty, and an oppressive room, when you have a place double the size necessary.
- Q. I am not asking for the kind of room to hold it, on July 12th was there not considerable difference of opinion between you and Grant as to where the church services should be held; is that not a fact? A. I do not think Mr Grant is agreed with me at all in this matter.
- Q. Did any difference of opinion exist on July 12th?
- A. A difference of opinion has existed between him and I ever since I have known him.
- Q. A difference of opinion as to where the church services should be held? A. Just you wait until I am good and ready; you are trying to put your own phrases in my mouth; certainly they existed at that date and they do today.
- Q. On July 12th? A. The services on that day were in that room.
- Q. You have a memorandum book there; on July 12th tell me who were present at that service; that is of your helpers. A. Mrs Jones, Miss Lyle, Mr. Bennett, and a lad by the name of Victor Gormley.

- Q. Was Mr. Giffin present? A. I have not him on the record.
- Q. Who is Mr. Victor Gormley? A. He is a boy of about 15.

Controller Hoben. Where does he live? A. Yale Street. Controller Harris. Was there not a stranger there that day? A. Or that day there was a stranger there.

- Q. Who was he? A. I did not get his name.
- Q. Who brought him in? A. I did.
- Q. On whose pass? A. He came in with me.
- Q. The services took place upstairs? A. Yes, in the large room, and the women were not present.

 Controller Hoben. Was the stranger an Evangelist?

 A. On July 12th at the request of the Rector of

I took the afternoon service at 2 p.m., and from there I went to the City Prison, and one of the men in the class asked me if he could go to the service with me, and I said, Come along, we shall be glad to have you. I was introduced to him but I have not his name down; I can easily get his name if necessary, he was an Episcopalian from StMatthews Church.

Controller Harris: The women were not present at the services upstairs? A. I think they were, I have no record of the women not being present; I think they must have been present on the 12th. No, there were no women present on the 12th

- Q. You gave us your account of what happened and you say when you were half way down the stairs Mr. Grant spoke to you and said you were violating the Rules, and you ask what Rule? A. I did.
 - Q. Did not that conversation take place after you reached the ground floor? A. It certainly did.
- Q. Did not Mr. Grant say something like this -

OCT 26 1914

Mr. Wier, you had better tell your lady friends to go down the other stairs. A. If he did, I did not hear it and my hearing, thank the Lord, is very good.

- Q. When you got through the to the Rotunda did not you sit down beside Mr. Grant in the lower hall on the tabel? A. No I did not sit down beside him, or sit on the table.
- Q. There had been a previous accusation on your part about some clothes? A. You will hear something more about that.
- Q. That is a fact about the previous accusation in regard to the clothes? A. You can call it an accusation if you wish; there was a conversation.
- Q. And was not the first statement Mr. Grant made on reaching the floor about those clothes? A. I did not hear it.
- Q. Did not Mr. Grant say something like this Mr. Grant spoke to you about the accusation to Mrs
 Grant and you said such are the facts; did not
 you say something like that? A. When?
- Q. When you reached the floor. A. What is the good of beating all over the country; I will give you exactly what happened; I have ample evidence to prove it. After service, on coming down stairs, when I was about half way down the head keeper approached, I walked down the balance of the stair—way, four or five steps, and I asked him what rules I had vidlated, and he pointed to a card of rules pinned on the wall, and I said read it, and he read Rule 2, My answer was Well then, we are partners in crime.
- Q. Rule 2 has reference to bringing clothes in?
- A. Something to do with giving to prisoners.
- Q. That is what Mr. Grant was referring to about

- A. I gather he had reference to giving clothes to the prisoners; we had been bringing in clothing for prisoners for years.
- Q. Previous to the service you had been talking about that? A. Before the service; but our mark conversation ceased, and we were going in to a gospel service; and we came down and took up this debate again, is that your theory? I want Mr. Harris to keep to facts. The fact is this, after the service closed this man laid in wait to molest us and unnecessarily came across the corridor and in an offensive tone accused me of violating the rules.
- Q. Had he not reference to the conversation that had taken place before? A. I am not a mind reader.
- Q. Was he not talking about clothes at the time?
- A. No he was not.
- Q. Had you not discussed clothes before the service began? A. An hour previous.
- Q. After Mr. Grant read the rules did not you say to him, you read the rules to me how dare you? I have received more impudence from you today than I ever got from old Murray? A. No such thing. I am satisfied absolutely I never used the name of Murray in that prison that day.
- Q. Did you say you do not know what discretion means?
- A. I doubt if I did.
- Q. Did you say you will be wait sorry for what you have said today? I can do as much with the City Council of Halifax today as I ever could? A. You have a tissue of fabrications. I contradict it. I made no use of that thing.
 - Q. On July 26th, will you look up your notes for that day; the service was upstairs in the large room? A. Yes.
 - Q. And Mr. Giffin was not present? Can you find any record of his being present? He said the last

- time he was? A. No, Mr. Giffin was not present; there was Mrs. Jones, Miss Lyle, and myself.
- Q. Handsley was in charge? A. No, he admitted us at the gate. Yes he was in charge of the service.
- 2. The women were not present? A. I do not think they were.
- Q. You held the service afterwards in the womens corridor? A. Yes.
- Q. Yeadon was in charge of the women's service?
- A. Down in the corridor, yes.
- Q. And it did not last very long? A. About fifteen minutes. And there were four present out of 8; the women were removed from one corridor to another and only four came in.
- question. What do you think was the cause of Mrs. Grant's temper? A. I am not going into a psychological
- Q. What do you surmise was the reason for Mrs. Grant's temper? What do you surmise was the cause of her exhibition of temper? A. I suppose she was angry.
- Q. Why do you think she was angry? You must have surmised; did it come like a bolt from the blue?
- A. Some people get angry very quick.
- Q. You had an idea? A. I suppose something went wrong.
- Q. What did you surmise was the cause of Mrs Grant's anger? A. I think they have never forgotten that their son's name came up in another investigation.
- There was a cause? A. There is a cause for everything.

Controller O'Connor. Had anything occurred previous to that which would explain it? A. No absolutely nothing I know of.

Controller Harris. You think some cause was behind Mr. Grant's remark 'none the better for your asking". Did you ever have an explanation of that remark of Mr. Grant's? A. No.

- Q. Did you ever have a withdrawal by him? A. Not to my knowledge.
- Q. Ever an apology? A. Never, absolutely.
- Q. Did not I tell you at one time I told him it was a most indiscreet remark to make? A. That is getting far removed; you said yourself you thought it was indiscreet.
- Q. Did not I tell you I told him that? A. You may have; I will not say you did not; I think you did tell me something like that in your own office; I am satisfied you did not approve of it from what you said.

Controller O'Connor. Dealing with private conversations we will never get through.

Controller Harris. Miss Lyle said when giving evidence before; that this conversation took place upstairs; I want to know whether this conversatio of the 26th took place upstairs and at the entrance to the corridor, this exhibition of temper?

A. We were anwn on the ground floor; as we came down the stairs we heard Mrs. Grant say a great many things.

Controller Hoben. What difference whether on the ground floor or upstairs.

Controller Harris. You said "We came down the three flights of steps and crossed the main hall and we stood at the entrance door of the women's corridor during which time we were treated to a violent exhibition of temper by Mrs Grant". A. That is right. This conversation referred to their, we three, Mrs. Hones, Miss Lyle and myself were standing at the foot of the stairs near the womens corridor

Mrs. Grant was on the way down or the first corridor above, I did not see her, but I heard her, she was not on the ground floor.

- Q. Were others present? A. Not within sight.
- C. Was Mrs. A. F. Devideon present? A. I did not see her.
- Q. Was an ex-prisoner by name of Bailey present?
- A. No I do not think so.
- Q. August 2nd, on that date there had been a Salvation Army service, had'nt there? A. Is this the 26th?
- Q. No, August 2nd. A. You ask me if Bailey was present on the 26th, no he was not.
- Q. August 2nd, the Salvation Army service had taken place beforehand? A. 2.45 to 3.30 we joined with the Salvation Army and made one service.

 There were no women present. Yeadon was in charge.

 Mrs. Jones and Miss Lyle were with me.
- Q. Didn't Capt. Thomas of the Salvation Army take service for the women in the women's corrector?
- A. I was not there.
- Q. You say you joinedtogether?

 A. You informed me you would see I got privacy for attending to the spiritual wants.
- Q. Such a statement as that was made after the conference? A. That I would have privacy.

 We discussed the matter. In regard to the privacy of the prisoners you said you would see I had it.
- Q. Without previous conference and discussion .?
- A. There was previous conference and discussion, but your statement has yet to be looked up: the

When you make the statement you had no intimation of a new rule about this sort of thing what do you mean? A. I simply mean this, that the common courtesy would dictate to an ordinary man that he should receive a notice. I go there to conduct a service, the prisoners are there and the service begins, and the first intimation I have of a new regulation and rule is when it is thrust under my notice before these people in the service. Common courtesy demands you should have said, Mr. Wier, hereafter you shall not be permitted to speak to the prisoners. You should not let me find out, in the presence of prisoners, without previous intimation. Do you understand what I mean. I not only look for courtesy on Mr. Grant's part, but on the Controller's part.

Controller Harris. "On Sunday, Aug. 2nd. Yeadon was the keeper in charge and he informed me there were a number of prisoners who wished to see me and I could see them in the corridor; not having had any previous intimation of the new rule, I took it to be one that was being made." "I asked the prisoner what I could do for him". What do you mean by that, that was speaking to the prisoners in service? Not having had previous intimation, that was on Aug. 2nd., what do you mean by previous intimation, when you were party to a conference on July 27th, when that rule was discussed?

- A. I had no previous intimation, I say, to see prisoners in the corridor. The only intimation I had was by the keeper at the close of the service one day, that I could see certain prisoners in the corridor. That happened on Aug. 2nd. I came down with Keeper Yeadon.
- Q. You mean to say that arrangements you should see prisoners in the corridor was not discussed at

- A. I won't say that at present, it was discussed and no one knows better than you do. The facts are you absolutely refused to give workers of the Institution common courtesy.
- Q. What do you mean by not having previous intimation? A. I have not admitted any such thing: I got it from the keepers.
- Q. Is it not a reasonable sort of rule, in your opinion, that conversations and interviews with prisoners should not take place in the church service room? A. If no other place is provided that is the best place for it.
- Q. Would you have some thirty or forty men waiting there? We seldom have that number.
- Q. Would you have twenty held, when you have a conversation with one? A. Here is a service, that will take three quarters of an hour or say, an hour, as the case might be, does it make a particle of difference if a part of the service is given over to a quiet talk with the men after the service is over. Who is hurt? These men are taken into the corner and talked to in low tones and we try to help them. The under keeper can wait.
- Q. What happens while he waits? A. If they quietly sit in their seats, there is no breach of dicipline, absolutely none.
- Q. Don't you think in establishing reforms precedents should not hamper one? A. It is not a fair question: I have one thing to stand for, the simple thruth: your question is not reasonable.
- Q. I have asked you whether such a rule is a reasonable one: is it a workable one? A. Such a move is not a workable one, the troubel with the prisoners since Dr. Hawkins left it as chairman is, there are too many rules.

the corridors first and anyone wanting to see you should go out? A. In such an institution as this I don't think; in Dorchester and Kingston it is.

- Q. You think it is workable? A. I think it could be made workable. Under the way you are handling it, it is not.
- Q. What change would you make? A. The only change, whoever conducts the services shall have the privilege of having the prisoners talked to privately as they desire and as, in their jusgement, he sees fit to discuss matters with them.
- Q. Where? A. In the privacy of the service room of a room set apart.
- Q. Would the corridor suit you? Where would you have the men interview you? A. Preferably after the close of the service in the service room. The keeper could march the rest of the men off and the man remain behind. That has been done.
- q. I want to know what you consider is a workable rule; you agreed to this rule yourself. A. I have hever agreed to that rule. I tried to meet you people and went more than half way as far as possible to accommodate conditions. I laid out to accommodate you as you were determined to persecute me.
- Q. You say you met us half way; what was the agreement you reached? A. The room was not suitable and I dropped it rather than continue to press for more suitable place.
- Q. Where was it we agreed to interview the prisoners in the cellar, attick or service room? A. Where did we agree?
- Q. In the outside corridor. A. You never agreed with me.
- Q. Didn't we hold a conference ? A. You never

privacy with the prisoners and it was absolutely no good.

- Q. Coming to Lacey; about this rule; would you be surprised to find such rules were in force in other prisons? A. I would not.
- Q. Have you had a talk with Lacey since August 2nd ?
- A. I have never seen him since.
- Q. Did he only want to see the Salvation Army representative that day? A. All I know is what he told me.
- Q. What did he tell you? Did he tell you he wanted to see the Salvation Army representative that day?
- A. He said nothing of the Salvation Army people that day. It may be true he did want to see him; I won't say he didn't want to see him but he said nothing to me.
- Q. But he did want to see him for he asked for him, the Salvation Army Ensign Richardson, and he had left the prison? A. Yes.
- Q. Lacey may have thought he was still at the prison?
- A. He may. He knew my name was not Richardson.
- Q. I want to show you didn't hold service together and that Mr. Richardson had left some time before. He left at 2.50 and you at 3.35. A. No; he was not out more than ten minutes ahead of me.
- Q. Coming to August 9th; there were two services that day; were there not ? A. I don't know anything of any service on August 9th except the service I held.
- wards in the women's corridor? A. Yes, we held both these services.
 - Q. And it was at the opening of the service you extended your hand to one of the prisoners? A. Yes.
- Q. When Yeadon said that it was the Governor's orders you replied, Am I to understand that neither

prisoners" is that what you replied. A. That is a question I put.

- Q. He replied; I will speak to the Governor when I go down; you must not blame me; I said, certainly not". Didn't some conversation like this take place: "There is going to be a war around here, bigger than there is in Germany; I am making balls now and I am going to fire when I get ready and fire them good and hard ". A. To whom?

 Q. Generally. Just after the conversation took place? A. Your question is, did I make that statement.
- Q. Did you make a statement to that effect at the conclusion of that which I have just read. On August 9th?

 A. I did not.
- Q. You didn't make any such statement then or at any other time? A. I didn't make that statement.
- Q. Afterwards when you went to the women's corridor didn't Miss Lyle or Mrs. Jones startix talking with the women first. A. She asked them if they knew a certain hymn and took a step towards the women and asked, do you know this hymn. It was before she commenced to repat the lines that Yeadon interrupted her. There was no conversation, she was starting to select a hymn.
- Q. She didn't start in to shake hands with the women?
- A. She did not.
- Q. The service had not begun when Yeadon interrupted?
- A. I consider it had.

 Controller Hoben: Are we trying to show there was any discourtesy between Mr. Grant and Mr. Wier?

 Controller Harris: I am trying to get all the

the facts; Mr. Wier makes some statements and he is being cross-examined.

The Mayor: He is giving arguments and he will decide later.

Controller Scanlan; Do you propose to give the Board of Control any further evidence ?

Mr. Wier: My evidence is in the statement I made first.

Controller Harris: You shook hands with Yeadon, did not you, in this corridor, and said something like this; - I have shaken hands with the officer and I don't think he will catch any smallpox; there is no contagion about me. A. I don't think I shook hands with Yeadon; I said, I don't think I will shake hands because you might catch smallpox. It was a rude interruption and we had enough to contend with, without having anything else thrown upon us.

- Q. Didn't you turn to the women; did you say in the presence of the prisoners; A. After we left the corridor coming out ?
- Q. Didn't you say, so that the women prisoners could hear ? A. No, I didn't.
- Q. On August 23rd, when Mr. Potter was present, Handsley was in charge, was he not ? A. He was, yes.
- Q. Did Mr. Potter say anything to you afterwards about the service ? A. He discussed it with me, yes.
- Q. Do you know whether he sought an explanation from
- Mr. Grant ? A. He was with me after the service was over; I met him afterwards at a house on Robie St.
- Q. Did he give you Mr. Grant's explanation ? A. No,
- I don't think he did.
- Q. Then it comes to September 6th, the last occasion. Mr. Yeadon interrupted you; You don't suggest that as a charge against Mr. Grant, do you ? A. I said before, regarding that interruption, the explanation

- Q. Yeadon has apologized to you? A. When?
- Q. I am asking you, did he? A. There was no apology.

- Q. There was nothing in that charge as against Mr. Grant ?A.In the charge on that particular day ?

 Q. Yes . A. If I withdraw it; which perhaps I foolishly did, I say now that statement made there was accurate; the occurrence happened; you offered an explanation and I accepted it.

Controller Scanlan; What was it ?

Controller Harris: (reading) Mr. Harris offered
me an explanation that Yeadon was under the impression
that our service had closed. I want to know whether
Mr. Grant was exonerated. I want to know if Mr.
Grant is implictated in that charge? A. He was not
present.

- Q. Do you think it was inspired by him? A. Certainly.

 He would not act like that if he was not.
- Q. He made no explanation? A. You said he thought the service had closed.
- Q. If that was an nonest explanation how could Mr. Grant be implicated in anyway? A. Because of Mr. Grant's orders, repeated over and over again to us, to do that; he would hold them responsible that we were not permitted to speak to the prisoners; he was so zealous to carry out the duties so as not to offend this little Czar there, to overstep the boundaries in his zeal.

controller O'Connor; Were these instructions given in your hearing? Controller Harris; No, we want to know where they came from. Mr. Wier; I blame Mr. Grant for the commencing of the keepers in their actions.

ular time had nothing to do with Mr. Grant ? A. It had everything to do with him.

- Q. Do you think Mr. Grant was under the impression the service was ended? A. I think the keeper was under the influence of Mr. Grant; if he had not been under such drastic treatment by his chief he would not have taken any chances.
- Q. Is that an inference you draw from these particular circumstances? A. Only one thing that is, the whole thing emanates from the chief.
- Q. You say there were continuous interruptions from July 12th to the end of August? A. They were intermittent from July 12th to the present time.
- Q. If each keeper was instructed to interrupt the services they evidently lost a good many opportunities from July 12th to the endof August? A. It looked to me they did not lose many. I am simply in this position; we have been intermittently bothered and annoyed by this man and his helpers through his orders from July to this time.

Controller O'Connor; You don't help us one iota when you say it happened intermittently or continuously; what was said and done and the nature; let us have that.

Controller Barris: The only two charges of Specific internuptions are August 9th. Mr. Wier: I charge that On July 12th Mr. Grant in an offensive manner accused me of violating the rules.

Controller Harris: I want the continuous inter-

statement; I think the thing has got down to very
small details; my opinion is that if the evangelical

Controller Harris: Mr. Wier makes the statement that he was continuously interrupted, and he has not given any.

Controller Hoben; Are they illustrated with the attitude of the authorities to the religious workers that go there? Mr. Wier; Yes.

The Mayor: I would not expect/to have down every

interruption.

service.

Mr. Wier; I have offered these as instances to show.

Controller O'Connor; You can say there were other similar incidents? Mr. Wier; I consider it a flagrant interruption for the keeper to come up to me in an offensice tone and say you are not allowed to speak to the prisoners.

Controller O'Connor; Are there other similar things not detailed in your general charge that you were continuously interrupted; or is your charge a generalization of particular things. Mr. Wier; These are given as instances to show what we are undergoing from July to the present time.

Controller O'Connor: Are these instances the only interruptions, or were there others? Mr. Wier: There are others I have not detailed.

Controller Harris: Give us some other instances .
Mr66Wier: On September 6th -

You spoke of two. A. We had interruptions there on the 19th and on the 12th; the first was the 12th.

Q. That was not in the sertice of the 12th, that was a row with Mr. Grant, down in the hall. A. On the 26th the women were refused the privilege of the

Q. That was not an interruption. A. It was a denial of the privileges the people should have had.

and I want the charges ? A. I was interrupted again in connection with the visit of a prisoner in the corridor and I was informed the prisoner wanted to see me. I want the interruptions to the services A. They took place by Yeadon and Handsley.
Q. When? A. I can nick them out handsley. A. I can pick them out by going through my notes. The Mayor: Do you suppose it is reasonable to appear a man who is going up there to remember every time he was interrupted? If we believe it, it is enough and says Mr. Wier was Do you suppose it is reasonable to axpect for me. If Mr. Grant comes in and says Mr. Wier was troublesome we will weigh it all. I want to give a decision before I go out of office in May. Controller Scanlan: I was going to suggest we would have Mr. Wier's evidence there; the stenographer is there. we can get Mr. Grant's and Mrs. Grant's and hear what Mrs. Jones has to say and if after that Mr. Wier wishes to ask Mr. Grant any question or Mr. Grant ask Mr. Wier, we can weigh the evidence and wind it up tonight; otherwise it will drag along.

Controller Harris: Mr. Grant accuss him of pushing a curtain back and tearing it down. The Mayor: That comes up next; you are taking the charge of Mr. Wier against Mr. Grant.
Mr. Wier: On Sunday August 9th and 26th September our servies were interrupted. Controller Harris: Are those the only cases?

A. I won't say that.

Q. You say July 12th to the end of August there were continuous interruptions. The curtain was a source of friction. The Mayor; That is subsequent; This took place since mr. Wier laid his charges and as a consequence he might have been in a temper; he might have been in a tamper as to being imposed on by him; but that will come up later. Controller Hoben: Do I understand, summingit all up, I am not trying to put it in your mouth, are you not treated with courtesy and respect, is that the charge? A. It is. Q. You say there is a general air of hostility to you and those associated with you ? A. That is correct and I make that statement. That is the substance of our complaint. Q. And these specific things are only illustrative of the situation? A. That is to illustrate the conditions under which we labour. Controller Harris; I am not going to ask questions; I want to find out what created this atmosphere.
The Mayor: Let's get through with Mr. Wier's evidence.
Montroller Harris; That was a charge about the curtain; it is a charge to divert that.
The Mayor: You have been diverting, the way you have been asking questions all along. Mr. Wier has not the hast of you all through. Your case was got the bast of you all through. Your case was stronger at the start than it is at the finish. Mr. Wier: I either stand supported by my witnesses ot I stand alone; I will ask Mrs. Jones if she will give some evidence.

Mrs. Margaret Jones, sworn.

The Mayor, requested that Mrs. Jones evidence at page 9 of the proceedings of September 18th, 1914 be read over to her, which was done.

The Mayor: A few weeks ago on being questioned here your evidence was taken down; if you have any corrections to make you might correct it and if not,

correct, we will ask you to swear to it. You have heard every word Mr. Wier has said.

The Mayor; Down to the word "Lenient" on page 9 is correct?

A. Yes. Any questions you want to ask Mrs. Jones The Mayor: Mr. Wier, you can ask. Mr. Wier; Were you present on Sunday, August 5th .? Mrs. Jones. Yes. Q. Do you recollect the conversation; you heard the date, Sunday, August 5th ? A. Yes.

Q. July 5th, I should have said July 5th ? A. Yes.

Q. Before the service we were in Mrs. Grant's dining room, were you not ? A. Yes.

Q. Miss Lyle, was she with us ? A. Yes. Q. Do you recollect me asking Mr. Grant why it was we were not to have the service in the room as usual ? A. Yes. We discussed it with Mr. - Grant and Mr. Wier that day and Mr. Grant gave his reasons he did not want the Committee Room used, he was not going to have the men go over the floor with their hob nailed boots and Mrs. Grant said she would not hate the men or women there on account of the odours and then Mr. Grant said Mr. Harris wanted them to have that room, and she said No, she went down to Controller Harris and she wished he would learn to tell the truth and she wanted the room, it was not Mr. Grant at all, and then it came up about the odours and the hob nail boots, and Mr. Wier said, you didn't object to the odours when you put in your application for the position, and thatwas said then and we went upstairs to the meeting. Q. On the following Sunday after the service, which would be July 12th, I am relating to Huly 12th; On July 5th we were all together in the big room; the circumstances you have related pocurred on the 12th July? A. Yes.
Q. Do you remember after that service was over we were coming down the stairs, the same Sunday, July 12th; do you remember anything about what happened when we got to the foot of the stairs ? A. You were ahead and we were four or five steps behind, and we hea Mr. Grant say in loud tones, you have broken the rules, and you said, what rules, and he pointed to the wall and we were on the same floor as you were there, and you said, Rulez 2, what Rule is that, about the clothes and you said, we were partners in the same crime. We had given clothes to the prisoners. I heard that distinctly on July 12th. Then we went out of the meeting, we didn't stop.

2. On the 26th July you were present? A Yes. Q. Do you remember me saying to the keeper, after you are clear of the men we will have service for the women ? A. Yes. And the keeper came back and said there would be no service for the women. He went away and came back and you said, inform the matron there will be a meeting in the corridor for the women and we went right down the stairs and stood over by the corridor door, by Mrs. Grant's dining room; we all stood at the foot of the stairs and Mrs. Grant said she would not open the door, she called from upstairs; Mr. Grant says, you will unlock the door. She said, I will not. He said, You will and she came right down stairs and shot past us and in the meantime he came down and said how do you do Mrs. Jones, and spoke to Miss Lyle, and Mr. Wier said, How is Mr. - Grant and he said, None the better for your asking. You never said a word, and Mrs. Grant had opened the door and she brought four women and put them in the corridor; we had a little meeting and sang and spoke and them we came out.

prison ? A. Yes. Q. You didn't hear what took place in the corridor after the service? A. No, we went down to the corridor and you came after me and you said, come slowly down as you were going to speak to the men, and we came down a little while after. me Q. I told you one of the men wanted to see you? Q. You said Lacey wanted to see you; Ensign Richardson was there and he went out just ahead of us. Q. I left you upstairs in the meeting room on the 3rd floor and you came down afterwards ? A. Yes. You said you wanted to see a prisoner and we came down after you. Q. On the 9th August you were present with us and Yeadon was the keeper in charge? A. Yes.
Q. Did you see me extend my hand to one of the prisoners at opening of the service? A. Yes, that old man. Q. What happened when I did that ? A. The Keeper said you are not allowed to speak to the prisoners.

Q. He came over? A. He came over and said, you are not allowed to speak to the prisoners.

Q. Did I ask him who gave those instructions?

R. You said, have I to understand I cannot shake hands with the prisoners and he said, yes that is my orders. And you asked who save the orders.

Q. Were you present on the 23rd August when the Rev. James Potter of Montreal was present ? A. Y.

Q. Who gave the address? A. Mr. Potter. Q. At the close of the service did you hear me ask Mr. Potter if he would like to speak to any of the men? A. Yes. Q. What happened? A. He was a little bit afraid and he said he would rather not get into any trouble. Q. Handsley was the keeper in charge ? A. Yes. Q. Have you a distinct recollection yourself of Handsley being present there? A. Yes, I think I have. Q. Do you remember me saying anything when I spoke to Mr. Potter and turned round to the prisoners? A. No, I don't think I do. Q. You don't recollect hearing Handsley come across the room and say, you are not allowed to speak to the men T A. He came one Sunday, is that the Sunday ? I know he came one Sunday.

Q. We held a service in the corridor of the prison; to come back to that incident you related where Mrs. Grant spoke at the foot of the stairs; we went in and had service; Yeadon was with us; was Miss Lyle interrupted? A. Yes, she said, What hymn can we sing; 117? we only had two books; and Yeadon said, Lodies you are not allowed to speak to the prisoners. Ladies, you are not allowed to speak to the prisoners and we didn't say anything more.

Q. Coming back to October 23rd.

Controller O'Connor; Was that question about asking the women whether they knew 117 hymn, was that said in a low tone? A. Just low; we were standing beside them; Miss Lyle said, do you know 117, that is an old familiar hymn. Then Yeadon said you are not allowed to speak to the prisoners.

One of the Sunday before Mr.

Potter was there; when we left the prison that afternoon did he come away with us ? A. He remained behind and we went on. Q. On Sunday July 5th did you notice any unusual decorations in the service room ? A. I noticed a Q. That was the first time ? On Sunday July 5th ? controller Harris: There is something wrong about that; you have the wrong facts. Is it a fact that on Sunday July 5th it was there?

Mr. Wier: August 30th; On this Sunday do you recollect whether there were any women at the service? A. It was a rainy day. They were brought in and in

a few minutes Mrs. Grant came in and said who moved that curtain back. Mr. Wier; That is not the date; you remember this happened on Sunday - do you remember quite a number of Sundays passed by and no women were in the service.

A. Six or seven Sundays. Two or three Sundays we held service in the corridor; three out of the seven I think. You have been visiting the prison in connection with Christian work for how many years? A. 9 or 10.

Q. You were there before I went there? A. Yea.

Q. Do you consider that in that institution there should be a separate service for the men and women.

A. No, all the years I went there the men were brought in and put in first and the women were brought in and put in front of them; that curtain is not necessary and is only put there for annoyance. They necessary and is only put there for annoyance. They never interfered with the service having them together. We should have a service in the meeting room for the men and then in the corridor for the women. A. No, they should be held together in one room; they ought not to be separated at all. Q. On September 6th I have stated the meeting was interrupted by the Keeper and that Mr. Harris offered an explanation of it which I accepted. My statement in regard to that interruption is substantially correct is it not? A. Quite correct.

The Mayor: Mrs. Jones has stated that all you said is correct. You heard what Mr. Wier stated and you were present on all of those occasions which he particularises ? A. Yes. I never miss a Sunday rain or shine. Mr. Wier; Mr. Wier: Do you recollect the first Sunday the curtain was there? A. I don't recollect the date. Q. Would it be about August 30th ? A. It was in August some time. Q. The first time I saw it was August 30th and we had the women present at that service? A. Yes. Controller O'Connor; Are you going to ask a question relative to Mr. Grant's charges or the charges against him. Don't mix the charges.

Mr. Wier: I will first finish my own.

Controller O'Connor: We are not going to mix the drinks; we have decided that. Mr. Wier; On the 20th Sept; we held service and you were present with Mr. Giffin and also Miss Lyle; Keeper Handsley was in charge on that Sunday; did I draw your attention to a curtain which was against x the table? A. Yes.
A. It was against the table? A. Yes. Q. Have you any recollection how close it was to the table? A. Right against it. The table was pushed against the window and the curtain drawn right up against the edge and it was against Mr. Wier's face and all the prisoners had to give it a push to get in their seats and that was the day it was taken down. and on that day after the service began the door opened and someone came in; did Mrs. Grant come in? A. Yes, and she said, who pulled that curtain back and Mr. Handsley said I did, and she said to the women get up and march out and she opened the door. Q. They were ordered out ? A. Yes. Q. And we continued the service? A. Yes.
Q. And then we came away? A. Yes.
Q/ There were five women in that meeting; did you see any visitors up there that day; any members of the City Council? A. That is the day Mr. Brown came.

OCT 26 1914 Q. How long after Mrs. Grant had ordered the women from the meeting was it before Mr. Brown came?

A. Just a minute or two after she went the door opened and he walked in. Q. Had Mrs. Grant enough time to get down stairs ? A. No, as soon as and said the door was shut when she opened it quick and said, who moved that curtain and Handlsey said I did. Q. How do you suppose she knew that the curtain was moved if no one went out to tell her? A. It is beyond me but she came right in and said who moved the curtain. Alderman Brown came in a moment or two afterwards, after she passed out. A. After the service was over did I, in Alderman Brown's presence and the presence of the keeper, show the position the curtain was in? A. Yes.
Q. You saw me measure it? A. Yes.
Q. You did? A. Yes and how much it overlapped.
Q. The distance I measured, did you notice I measured it in this way (indicating). A. With your Q. Do you remember how many feet I counted ? A. You measured three feet on one side and I think 2½ or 7 feet on the other side. One side was longer than the other. The table was at an angle.

Controller Harris: The curtain is an hindrance; that is what you want to say. A. What I want to say, I am not going to say without being fed by your speeches. Controller Hoben; Have you noticed a general spirit of hostility between Mr. Grant and Mr. Wier. Mrs. Jones: There has not been any hostility on Mr. Wier's part; there might have been on Mr. Grant's part. Mr. Wier has put up with more than any ordinary man would. If he had any feeling of hostility he did not show it. Controller Hoben; Is there a spirit of hostility between Mrs. Grant and Mr. Wier? A. When she is there she won't stay in the meeting if he was there. She gets up and walks out.
Q. Does that extend to the women workers? A. She does not treat us nicely. I have nothing against her and it does not bother me; she does not treat us nicely.
Q. Does Mr. Grant ? A. We never see him or speak to him. He never has anything to say to us. I have nothing to say against him personally. Q. Do you think the treatment you get there interferes with the usefulness? A. Yes, it spoils our work and hurts us and the prisoners. It is ruination to our work. 2. I want to ask you in all fairness do you think Mr. Wier could modify his attitude to eliminate some of this hostility. A. There is nothing to modify, he goes in to have a gospel meeting and he does not say anything hard.
Q. You know that some men can irritate others without

saying it. Do you notice anything of that with Mr.

A. He does not interfere with anyone. He goes in and goes upstairs and has the gospel meeting and we come down and he never interferes with anyone not even the keepers. He does not irritate.

Of the place?

A. No.

Controller Harris: Q. Why did the Roberts W.C.T.U.

A. They brought a big crowd with them; perhaps 15.

Q. Do you know anything of their not going now?

A. I think it is a blessing they don't go.

Q. You don't know why they stopped? A. I don't know.

Q. You think it is a good thing they stopped?

A. I don't think that. We don't know whether they stopped or not.

Miss Beatrice Lyle, sworn. Mr. Wier: You heard the questions and answers that were put to Mrs. Jones by myself? A. Yes. Q. Do you corroborate on your oath here the statements she has made in answer to my questions ? A. I do. The Mayor: And these specific dates Mr. Wier mentions, the Sundays he has stated he was in any way interfered with, and what he states, whatever the fact may be, is substantially correct? A. Yes. Q. You were present on these occasions ? A. Yes. Mr. Wier: You were present according to my record on October 11th; do you remember the keeper in charge on that date; was it George Yeadon? charge on that date; was it George Yeadon?

A. I don't remember.

Q. Do you remember my coming down stairs after service on October 11th and as we entered the corridor Keeper Yeadon approached me and said a prisoner would like to speak to you? A. Yes, I do.

Q. Do you recollect what transpired then? Did keeper Yeadon, after saying to me there was a prisoner would like to speak, did he speak to anybody else before I spoke to him? A. That was the Sunday Mr. Grant was there; one of the prisoners Sunday Mr. Grant was there; one of the prisoners wanted to see Mr. Wier and Mr. Grant said -Q. Did he ask Mr. Grant if Mr. Wier could see this prisoner? A. Yes. Q. What was the answer ? A. I will see him first before he sees Mr. Wier. Q. Did he ask if he was a long term man ? A. Yes Q. Did Mr. Grant grant that request to the prisoner or refuse it ? A. He said to him stay there Q. Did I ask to take any part in the conversation up to that? A. You told Mr. Grant that he could not see any man for you; this man wanted to see you.

Q. Did I say to Mr. Grant there is a prisoner in the corridor whom I wish to see? A. You said that Q.And Mr. Grant said to him he would see him first ? A. Yes. 4 Q. And I replied he would see no man for me ? A. Yes Q. I made that reply just in general to those present; did I request Mr. Grant to allow the ladies to pass out of the corridor ? A. Yes. Q. And he did so ? A. Yes, he said he had no wish to detain the ladies and we went across the yard to go out . Q. Did we go out ? A. No, the keeper came. Q. Why didn't we go out ? A. There was nobody to let us out. Q. Did I ring the bell ? A. Yes.
Q. And after waiting a few minutes what happened ?
A. The keeper George Yeadon came out and said Mr. Grant says you may see the prisoner if you

And I left you and went back ? A. Yes. Controller Harris; Do you know who the prisoner was? A. I think his name is Alsopp. Q. Did you know at that time there were two Alsopp's at the prison? A. No. Controller Hoben: You heard what Mrs. Jones said in reply to me a moment ago? A. Yes. To would your answer be the same? A. Exactly the same. Q. You understand there is a sort of friction; Can you tell me how long you have been going to the prison . A. I don't know how many years, two years before Mr. Wier. Q. When did you see this general spirit of disagreement between these two men develop? A. About what? On the 12th July I think was the first date; we were in on the 5th in Mrs. Grant's dining room and Mr. Wier asked Mr. Grant what the trouble was over the room; Mr. Grant A. About what ? was giving us to understand after the repairs we would go back and Mr. Wier asked him what the trouble was and Mr. Grant told him we were not going to have the services there any more; and Mr. Grant said there was no trouble, and we said, why are we not going back and Mr. Grant said, it seems to be Controller Harris, that I keep that for my office. Controller Hoben; If it is so; this attitude developed comparatively recently. A. Yes. Q. On previous occasions they got on all right?
A. There was never any trouble.
Q. Do you think Mr. Wier could modify his attitude to eliminate a good deal of it. A. If he were willing to allow the work to suffer; but if he did right he could not. Q. Is Mrs Grant apparently in sympathy with the work ? A. She seemed to be up to the time the trouble commended but not since. Q. Does that extend to the ladies also ? A. Since Mr. Wier was treated that way all the workers were treated the same by Mr. and Mrs. Grant.

Q. Do you find it unpleasant work up there now with conditions as now? A. We are restricted; we can only go in and hold service but we want to help the families of the prisoners, and the orisoners.

O. Do you find the Evangelical work hampered?

A. Yes, it is stopped altogether, except for the Sunday meeting.

Controller Herris; This trouble seemed to develop about July 2nd?

A. Yes.

O. And out of the use of that particular room?

A. The first talk about that began as Mr. Wier told you that subject was eliminated because he said he was willing to go in that room; at the time it was a live subject. prisoners. time it was a live subject. That seemed to be a subject for a difference of opinion at that time ? A. Yes.
