Dear Sir:

Halifax County has recently completed the construction of a sanitary sewer collector and water distribution mains along Caldwell Road in the area of Cole Harbour, Halifax County. This is Phase 1 of a project to construct sanitary sewers and water distribution mains, and to upgrade storm water drainage for this area.

The cost for this project is being shared between Halifax County, the Province of Nova Scotia, and owners of land abutting on Caldwell Road which include lands of the Mic Mac Indian Band.

Phase 2 of this project is the design and installation of a storm drainage system along Caldwell Road. This requires diversion of storm water to the water course located on the Mill Brook Indian Band lands which would then empty into Morris Lake.

Negotiations have taken place in recent months to secure access and an easement to the water course on the Mill Brook Indian Band Council lands with the first position put forward by the Band Council requesting compensation in the sum of \$286,000. Subsequently, a tentative proposal was reached by both parties to endorse this project providing compensation in the amount of \$93,800.00 to the Band Council.

This proposal was placed before Halifax County Council for their consideration and they have responded in a manner as covered by the following resolution:

Honourable Thomas Siddon Page 2 April 29, 1992

"That this item be deferred pending a request to the Minister of Indian and Northern Affairs with a copy to the Honourable Brian Young, the Honourable David Nantes and the Honourable Kenneth Streatch asking for their intervention to obtain the required access and easement from the Mill Brook Indian Council given the actions of financial participation of the Municipality and Province of Nova Scotia for providing sanitary sewer and central water line extensions along Caldwell Road, thereby, providing servicing capability to existing properties located on reserve lands, and further that a reply be requested by May 19, 1992."

Halifax County Council believes that our cooperation and financial support to date should be sufficient compensation to obtain the access and lease to the water course.

We look forward to your favourable support to resolve this present impasse.
