I beg leave to make the following report for the month of December:-1. There were 22 alarms of fire from the following causes:- hall stove smoking 1; over-heating pipes 1; unknown 1; rubbish 1; bon fire 1; gasoline range 1; oil cabinet 1; chimneys 15.

I recommend the purchase of a triple combination motor pumping and hose car and chemical engine.

I beg to report that on the 4th inst. a fire occured in a plant now under construction for the manufacture of explosives on Agricola Street Extension, and would recommend that the same be safeguarded according to the underwriters' regulations, as there is at present a quantity of acetylene not properby stored and exposed to the weather, which I consider a menace to public safety.
