City Hall, July 7th, 1919

His Worship the Mayor and City Council.

Gentlemen:-

The Committee of Fire Wards beg to report that William Wells driver of the motor pumping engine "Patricia" the only survivor of the crew of that engine at the time of the explosion, December 6th 1917 and who suffered great physical injury from which he will be permanently handicapped, has been continued in the employment of the Fire Department at such duties as his condition enables him to perform, but for the six months from November 1st 1918 to April 30 1919 he was only given half pay by the City.

It is recommended that Mr. Well's appeal for full pay for and that period should under the circumstances be recognized that the City Auditor be authorized to pay over to him the difference between the amount he has already received and the equivalent of full pay. Respectfully submitted,
