- 8.1 Discussion
- 8.1.1 Ghost Bikes

Kelsey Lane asked for the Committee's feedback on the subject of Ghost Bikes in HRM. Lane has been receiving quite a bit of correspondence about this sensitive issue. There are questions around: what to do, who is responsible for the upkeep, how long should they remain. David MacIsaac, AT Program Supervisor, explained that this is a right of way issue and Public Works would be the HRM contact for this matter. The Committee looked at the number of ghost bikes in HRM, five (5) were identified; who had installed them; who was presently maintaining them and the condition they were in. There seemed to be an overall lack of information. Lane noted that Ottawa had done a comprehensive review while some other Canadian Municipalities had done none. They asked how HRM might approach this. The Committee discussed how this is similar to the flowers and crosses that are used as commemoration as well. They noted that while needing to be sensitive to the families there were also health and safety concerns about the condition of the bikes and if they were an impediment to traffic. The Committee endorsed the idea of the Halifax Cycling Coalition creating a web page to share and memorialize these sites and to create a database which would include key pieces of information around their installation.

# 8.1.2 AT Route through Dartmouth Common

The Committee discussed the challenges for bikes and pedestrians safely sharing the paths on the Dartmouth Common. An Active Transportation Route is planned for the Dartmouth Common with a multiuse pathway being installed, paving is scheduled to take place this summer. The Committee discussed the use of signage and education around the use of bells and right of way. Dave MacIsaac informed members that there is user etiquette signage, with 4 key messages, being installed elsewhere in HRM which could be used there as well, the area can also be monitored for safety. Suggestions for the use of signs, arrows and directional markings on the greenways were provided as additional options for consideration. There are also opportunities when designing new trails to create safer sharing. The Committee discussed the urban design challenges in creating a functional network moving toward a long-term solution and the importance of education in the short term. They looked at the limited effectiveness of signs in changing behavior and agreed that a Public Service Announcement approach for educating all trail users could be an effective way to address this issue. Dave MacIsaac agreed to talk with the HRM Communications Team.

The Committee encouraged a focused look at the Dartmouth Common as what works in one space may not translate to this space. The Committee considered the correspondence received. Dave MacIsaac noted that the intent is to improve the shared pathway beginning with the paving project and that they will investigate the concerns brought up and report back to the Committee at the next meeting.

David MacIsaac, Active Transportation Program Supervisor, provided an update on the work being done by his department:

- Planning co-ordination for HRTA Community group capital and planning projects: e.g. Gaetzbrook Greenway; Bissett Phase III; Sackville Greenway; East Preston; Lucasville Rd.;
- Functional planning, property agreement processes, detailed design of Dartmouth Harbourfront segments (e.g.: Parker St. to Old ferry Rd.)
- Support to HRM-delivered Greenway projects in detailed design (e.g. Penhorn Greenway)
- Participation in IMP implementation projects (e.g.: multi-modal level of service study; indicators; project evaluation framework; corridor functional plans)
- Joint provincial projects (e.g. co-ordination on AT facilities/connections and new provincial infrastructure; input to MVA changes; Blue route)
- Lead the development and distribution of 2018 Bike and Greenway Map (with Corporation Communications and ICT)
- Support Local Street Bikeway detailed design. Initiate North End and West End local street bikeway functional planning processes.
- New Sidewalks assessments
- Halifax Urban Greenway functional planning process. Public engagement June 7.
- Herring Cove Road pedestrian facility Council report and support for planning/design process
- Support detailed design for South Park bike lane upgrade and enhancement
- Conclude Downtown Bikeway functional plan and begin Council report.

- Project charter and reference development for Peninsula South functional planning (e.g. University, Bells Rd, intersection changes)
- Bike rack program- new supplier.
- Almon Street planning. Concluding design and will report to Council in 2018.
- Support design for Wyse, North and Fall River bike lanes.
- Advise Cogswell District planning process
- Project manager for Macdonald Bridge Bikeway Connectors project will start work in June.
- Bike Week 2018 planning very active. CEU is contracted to co-ordinate. Great sponsor supports this year.
- In the process of hiring two term AT Planners and one Planning and Design Intern. Will have full staff by June/July.
- Working on updated multi-use pathway etiquette signs for a few locations.
- Starting to consider capital 2019-10 program
- Preparing Council report on advancing AAA bikeway implementation

# 8.2.2 Committee Member Updates:

The Chair shared an email from member Elizabeth Pugh. They advised the Committee that public engagement on the Traffic Safety Act is now open. Ben Buckwold noted that Bike Nova Scotia is promoting a bike friendly certification program and the website is live http://rarebird.ca/work/bike-friendly-certification/.

There is also a cycling event in Mahone Bay this coming Saturday with 25 spots left.
