#### 9.1 STAFF

#### 9.1.1 HRM Police Services Complaint Communications Plan

The following was before the Board:

- HRP and RCMP Police Complaints Communication and Public Education Plan
- Presentation titled "Police Complaints Communication and Public Education Plan" dated May 28, 2018

Inspector Robert Doyle, RCMP, Halifax District Detachment, and Superintendent Colleen Kelly, HRP, provided the Board with a presentation on the HRP and RCMP Police Complaints Communication and Public Education Plan. The presentation outlined the HRP and RCMP Complaints Communication Action Plan, as well as the current practices for filing and handling police complaints.

Responding to questions of clarification from members of the Board, Inspector Doyle and Superintendent Kelly noted the Action Plan is not seeking to significantly alter the two (2) police complaints processes, but rather, to provide clear information and streamline the process to make it more accessible and transparent to the public.

The Chair thanked Inspector Doyle and Superintendent Kelly for the presentation.

# 9.2.1 Canadian Association of Police Governance 29th Annual Conference in Winnipeg, MB, August 7-11, 2018

#### 9.3.1 Board of Police Commissioners Annual Report to Regional Council - Update

David Perusse, Legislative Assistant, provided the Board with an update on the Board of Police Commissioner's Annual Report to Regional Council. They noted that a special meeting of the Board has been scheduled for June 12, 2018 for the purpose of completing the Board's 2018/2019 work plan for inclusion in the Annual Report.

#### 9.3.2 Management Employee Relations Committee Update

Commissioner McDougall provided the Board with an update on the April meeting of the Manager Employer Relations Committee. They further noted that the Board is going to include the Manager Employer Relations Committee Update as a regular standing agenda item going forward.

#### 9.3.3 Nova Scotia Association of Police Governance Workshop Update

Commissioner McDougall provided the Board with an update on the Nova Scotia Association of Police Governance Workshop, which they attended in May 2018. McDougall explained that one item arising out of the meeting was notice that there is a vacant Nova Scotian seat on the national Board of the Canadian Association of Police Governance. They further noted that the CAPG has indicated that they are interested in having a member of the Halifax Board of Police Commissioners take on the vacancy until August of 2019.

Chief Superintendent Lee Bergerman, RCMP, Halifax District Detachment, noted that the official request for additional RCMP officers has been sent from Chief Administrative Officer's Office to the Nova Scotia Department of Justice.

Bergerman further noted to the Board that funds from the Nova Scotia Chiefs Drug Committee have been allocated to additional naloxone kits, ion drug scanners, and additional fentanyl training for officers.

Inspector Robert Doyle, RCMP, Halifax District Detachment, updated the Board on the RCMP, Halifax District Detachment's Eagle Feather Protocol Initiative.

Deputy Chief Robin McNeil, HRP, provided the Board with an update on the HRP Cadet recruitment campaign.
