10.1 STAFF

10.1.1 Regional Centre Secondary Municipal Planning Strategy and Land Use By-law (Package A)

The following was before the Board:

• A staff recommendation report dated April 3, 2019

Ross Grant, Planner I, Mark Inness, Planner II and Kasia Tota, Principal Planner gave an overview of Package A, with a focus on coastal elevations and watercourse setbacks, and sustainability. The proposed by-laws along with the adoption path and timeline were shared. Staff were looking for feedback and recommendation to the Environment and Sustainability Standing Committee from the Board. A copy of the presentation is on file.

The Board discussed Package A with staff responding to questions.

Staff confirmed that the existing setbacks for water bodies would be used for any development in the Penhorn Future Growth Node and that a development agreement was needed for this space providing an opportunity to incorporate new initiatives around watershed areas.

It was further noted that both wind impact and shadow impact assessments have defined protocols and performance standards. Environmental regulations for watershed protection are covered in the Regional Plan by land use by-laws for: Coastal area elevation requirements (CGVD2013 3.2 metres), watercourse buffers and wetland protection (20 metres). An example of open space weather protection was shared with the Board.

Staff clarified that the issues of stormwater runoff and snow/salting concerns are considered by Halifax Water and not a part of the land use by-laws, although design requirements for landscaped spaces and parking lots can have an impact on these issues. The question of erosion sediment control plans on construction sites was raised with staff noting that there are other by-laws in place that apply to this as well as it being addressed in the permitting stage. There have been 20 sites identified as high risk for flooding due to rising ocean levels and extreme weather events which will result in the establishment of a Flood Plain Zone which will be looked at in detail in Package B at a later date.

Further, environment and watershed related polices are addressed under Sustainability E1-E7, which are in alignment with the Green Network Plan, and Urban Lakes and Watercourses Policy 9.5. Sustainability addresses: landscaping, porous surfaces, built environment and building design, urban agriculture, supporting biodiversity, mixed uses and complete community frameworks. Policy 9.5 uses enabling language demonstrating a commitment to low impact development technologies and stewardship through water quality monitoring, pilot projects and partnerships. Future Growth Nodes Policy 3.30 covers how neighbourhood planning and development agreements will be used for these sites with specific attention to sustainable design, stormwater management and opportunities to identify, preserve and re-habilitate significant environmental features.

THAT the Regional Watersheds Advisory Board recommend that Environment and Sustainability Standing Committee recommend that the Regional Council:

- 1. Give First Reading and schedule a public hearing to consider the Regional Centre Secondary Municipal Planning Strategy, and the Regional Centre Land Use By-law, as contained in Attachments A and B of the staff report dated April 3, 2019.
- 2. Give First Reading and schedule a public hearing to consider the proposed amendments to the Regional Municipal Planning Strategy and the Regional Subdivision By-law, as contained in Attachments C and D.
- 3. Adopt the Regional Centre Secondary Municipal Planning Strategy, and the Regional Centre Land Use By-law, as contained in Attachments A and B.
- 4. Adopt the proposed amendments to the Regional Municipal Planning Strategy and the Regional Subdivision By-law, as contained in Attachments C and D.
