10. REPORTS 10.1 STAFF

10.1.1 Staff Update on Nichols Lake Trail

The following was before the Committee:

A staff memorandum dated October 16, 2019

Gareth Evans, Recreational Planning Specialist, provided an update on the construction of the Nichols Lake Trail. A consultant has been retained to examine the parts of the trail on the north side of the water crossing to locate any further potential water crossings which would restrict future construction or require work stoppages. Gareth Evans stated that Alex Quinn, Construction Engineer, will likely have an update at a future meeting of the Committee regarding when a report will come back to the Committee on this assessment. Gareth Evans also stated that staff will follow-up with members regarding if there are any remaining funds previously used for top-dressing current sections of the trail.

10.1.2 Staff Update on the Capital Budget

The following was before the Committee:

• A staff memorandum dated October 16, 2019

Gareth Evans, Recreational Planning Specialist, provided an update on the construction of the Nichols Lake Trail and answered questions for the Committee. There are no additional funds proposed for 2020/21 budget. No additional funds were proposed until the 2022/23 budget. The cost associated with the WSP Bridge Crossing Design is \$54,555 (excluding tax), with funding provided from the approximately \$89,000 that was previously approved. The cost associated with the Cobequid Trail Consulting Report is \$5,555 (excluding tax), with funding provided from the approximately \$89,000 that was previously approved.

In response to questions about potential future sources of funding, Gareth Evans indicated that the Otter Lake Compost Facility expansion could provide a source of funds if the project proceeds, though this would likely be several years from the current date.

10.1.3 Staff Update on the Geotechnical Work for the Bridge Footing

The following was before the Committee:

Gareth Evans, Recreational Planning Specialist, provided an update on the construction of the Nichols Lake Trail. Members and staff both expressed interest in engaging in further discussion when the preliminary report is prepared. Members suggested the possibility of addressing this at the next regular meeting of the Committee, or at a special meeting if warranted.

Gareth Evans also noted that real estate staff also plans to come speak to the Committee following the completion of their work by the end of November.
