4. YOUTH ADVISORY COMMITTEE WORKPLAN 2020/2021

The Chair opened the discussion on the Youth Advisory Committee workplan and members discussed their main priorities for the coming year:

1. Mental health accessibility for youth
 - The Committee discussed having a mental health professional come in and provide a presentation
 - Members also discussed putting together a document detailing mental health resources which could then be sent out to different groups
2. Systematic racism for Black and Indigenous people of colour (BIPOC)
 - Members discussed holding an event to discuss issues pertaining to systemic racism
 - The Committee also discussed the benefit of hearing presentations from HRM's Office of Diversity & Inclusion as well as from the Office of Public Safety (re: defunding the police)
3. Transit
 - The Committee expressed a desire to have Halifax Transit come in and provide a presentation on the recent changes to the transit system and how these changes affect youth
 - Members also commented
4. Lack of access to programs and services for youth in lower income areas and rural communities
 - Members discussed ways to support youth in lower income areas and rural communities and requested that Rebecca Bishop, Community Developer, provide a presentation to the Committee regarding data that has been collected from youth in rural communities
5. Climate change and environmental issues
 - The Committee expressed a desire to have HalifAct return to provide another presentation on the municipal climate change strategy now that it has been completed
6. A social media page for the Youth Advisory Committee
 - Members discussed how a social media account would allow them to communicate with the public and therefore receive feedback from youth in the community on what actions they want from the Youth Advisory Committee
