# 9.1.1 Regional Plan Review: Themes & Directions Report Presentation

The following was before the Committee:

• Staff presentation dated June 21, 2021

Shilo Gempton, Planner III, Regional Planning presented to the Committee indicating that the Regional Plan was adopted in 2006 and sets region-wide policy. A comment period is underway with internal/external stakeholders, as well as the public and runs from May 20, 2021 to July 16, 2021. Staff are hoping to have the review completed by 2022.

Gempton spoke to the review themes and growth targets, indicating the Integrated Mobility Plan will be considered, as required with any proposed amendments to the Regional Plan. A copy of the staff presentation is on file.

In response to the presentation, the Committee inquired as to whether or not affordable housing or monorail for outlying areas are being considered and noted the importance of access to primary medical care. Inquiries were further made regarding the status of lands designated Urban Reserve.

Leah Perrin, Principal Planner, Regional Planning stated that transit options for outlying areas are being looked at as part of long-range transit planning and that consultation with other municipalities is ongoing. Perrin further indicated that affordable housing options are being looked at, and that there are no specific changes being worked on for lands designated Urban Reserve with the exception the AKOMA lands in Dartmouth and a portion of the Purcell's Cove Backlands.
