8.1 STAFF

8.1.1 Update – Committee Composition

Krista Vining, Legislative Assistant, Municipal Clerk's Office, noted that Halifax Regional Council passed a motion April 20, 2021 requesting a staff report on amending Administrative Order Number 2016-001-GOV, *Respecting the Advisory Committee on the Western Common* to include a representative from the Resource Opportunities Centre located in the Prospect Road Community Centre. The staff report to Regional Council was targeting Fall 2021. Vining would share a copy of the staff report with the Committee when it was available.

8.1.2 Discussion re: Trail Type

Gareth Evans, Recreation Planning Specialist, Policy and Planning, noted that Halifax Regional Council passed a motion June 8, 2021 requesting a staff report on proposed amendments to the Western Common Wilderness Common Master Plan to consider the implementation of natural surface backcountry trails within the interior areas of the Western Common. Evans explained that Figure 23 of the Master Plan calls for an extensive six (6) foot wide barrier free trail system and as discussed with the Committee and

Parks Capital, this would be highly disruptive to the natural surroundings. The intent is to be as inclusive and accessible in certain sections of the Western Common and have a two (2) foot wide trail system, a classic hiking trail, in other areas to respect the natural surrounds. Staff would be working with the Committee, the trail consultant and Parks Capital to determine a more integrated approach. Evans responded to questions from the Committee.

Evans would continue to update and consult with the Committee, outlining the Western Common Wilderness Common Master Plan phases, layout and areas of focus over the next year.

8.1.3 Update – 50 Best Family Friendly Hikes in HRM

Gareth Evans, Recreation Planning Specialist, Policy and Planning, noted that Michael Hines was writing a book on the 50 best family friendly hikes in the Municipality, noting their discussion with Hines on the Western Common as an up and coming trail system, and responded to questions from the Committee.

8.1.4 Update – Family Grave Sites within the Western Common

Gareth Evans, Recreation Planning Specialist, Policy and Planning, noted that in response to a question they had received from a resident, staff would ensure that trail planning within the Western Common Wilderness Common Master Plan would be mindful and respectful of culturally sensitive areas. Evans responded to questions from the Committee.
