### 2. APPROVAL OF MINUTES - November 10, 2021 and December 8, 2021

Thomas Gribbin and Nancy Soliman requested additions be made to the draft November 10, 2021 minutes as follows:

Insert the following information under Section 7.1 paragraph 4

Committee members outlined questions and concerns regarding the Committee's role in the site plan approval process. Some of the key issues raised were:

- 1. The Committee still does not have a tracker requested in the March 10th, 2021 meeting that tracks each recommendation of the committee and whether it was accepted or not by the applicant. Without this tracker it is impossible to determine whether the DAC has any benefit to the city of Halifax.
- 2. We are a team of highly qualified professionals and bring innovation and best practices to this volunteer role. Our wish was to help the city and our expectations of the role were higher. This is not a good use of citizen volunteer time.
- 3. The committee has no meaningful input into the site application process and recommendations are (almost) all ignored.
- 4. It feels like members are expected to rubber stamp everything. Meetings are a waste of time.
- 5. Terms of reference are too narrow for example, the TOR have very little to do with the environment and sustainability.
- 6. Our terms of reference limit us to advising on 51 trivial design requirements. These DR's do not require a group of professionals to review. What benefit is there to the city? How is it worth the effort of gathering city staff, clerks and professionals together monthly to review?
- 7. Political theatre HRM gets the benefit of saying it has a team of arm's length experts reviewing applications and recommending approval. However, the DAC's mandate is so narrow that it has no meaningful influence on any developments. The volunteers feel that the city may be leveraging their involvement to provide the impression of citizen involvement when none exists.
- 8. The committee members are not upset because they lack personal influence. It is a frustration that this is how the city chooses to do design review. There should be more meaningful input from citizens in some form.
- 9. HRM does not have an architecture dept and relies on DAC to provide advice but DAC recommendations are all ignored. What is the point?

#### Replace paragraph 6 in section 7.1:

Committee members had questions regarding the amendments to the Regional Centre Land Use Bylaw as it relates to the Committee's mandate and the usefulness of the DAC within the process of site plan approval.
