- 9.1 TAXI. LIMOUSINE & TRANSPORTATION NETWORK COMPANY LICENSING APPEALS
- 9.1.1 Refusal of Reinstatement of Taxi Driver License #D699

The following was before the Committee:

The Chair confirmed the appellant, and their representative were in attendance.

Lois Beaton McNamara, License Administrator presented the refusal of reinstatement of taxi driver license #D699 and responded to questions of clarification from the Committee and the appellant's representative.

Beaton MacNamara advised that staff reviewed the appellant's application which included a Criminal Records Check Report and Drivers Abstract, and made their decision to refuse reinstatement of Taxi Driver License #D699 based on the criminal charge and two suspensions, of which the Licensing Authority was not notified, in accordance with sections 44.1 (e), (f) and (g) of By-law T-100, Respecting the Regulations of Taxis, Accessible Taxis, Limousines and Transportation Network Companies.

Karen MacDonald, Senior Solicitor provided an overview of the appellant's right to appeal in accordance with section 48.0 of the by-law, and the Committee's options to allow the appeal and reinstate the license or deny the appeal and uphold the decision of the Licensing Authority.

Andrea MacDonald, Acting Director, Compliance and Tanya Snair, Supervisor of Regional Licensing spoke to other considering factors under section 44.1 (g) as to whether the driver was fit to operate a taxi, accessible taxi, or limousine, based on the charge of impairment, operating a vehicle with passengers, and the safety of passengers, the taxi industry, and liability of the driver.

Beaton MacNamara confirmed the appellant was initially licensed to drive a taxi in July 2004.

Pavel Boubnov, Solicitor for Alexander Sarukhanov, Appellant presented their appeal, speaking to the appellant's history of driving a taxi, their employment with Bob's Taxi and written support from their employer, and show of support through attendance at the meeting. Boubnov spoke to event that led to the charge and subsequent conviction. Boubnov noted the appellant was operating their personal vehicle and was not working at the time and did not have any passengers. Boubnov and Sarukhanov responded to questions of clarification from the Committee, clarifying that the two suspensions were related to the one charge and conviction. Additional clarity was provided around the appellant health, willingness to work, and inability to earn income due to the suspension of their taxi driver license.
