Michael Pappas, Director of Corporate Planning, and Dave Harley, Director of Accounting and Financial Reporting spoke to the proposed Budget and the Budget Adjustment List and responded to questions of clarification from the Committee.

THAT the Accessibility Advisory Committee approve that the Chair send a letter on behalf of the Accessibility Advisory Committee to Budget Committee for consideration during the 2023-24 Budget Adjustment List discussion.

Pappas and Harley responded to questions of clarification from the Committee.

The following was noted by the Committee during their discussion regarding the Budget Adjustment List:

- Concerns regarding increased costs to services creating access issues and disproportionately affecting racialized and low-income individuals.
- Impacts on the deaf community if interpreter services are cut, i.e., not being able to attend events.
- Engaging the Accessibility Advisory Committee earlier in the budget process.
- Using plain language when drafting documents related to the budget.
- Keeping the tax increase as low as possible.
- The importance of equity throughout the budget planning process.
- Support for the Affordable Access Program, Public Safety Strategy and addressing the housing crisis.
- Turning proposed savings in areas like parking enforcement into investments in public transit.
- A desire to see more transparency around police spending and hiring.

Councillor Russell proposed the motion be amended by adding, "of the resident members" immediately following, "on behalf". As provided for in section 53 (2) of *Administrative Order One*, *Respecting the Procedures of the Council*, the amendment was accepted as friendly.

Annie Sherry, Legislative Assistant noted that if included in the work plan for the upcoming year, the Committee could work with the Office of Diversity &Inclusion/ANSAIO and Finance & Asset Management to advise on disability issues that have an impact on the budget planning process, and support staff in the development of a formalized equity lens for future budget processes.
