lain MacLean, Municipal Clerk provided an overview of Administrative Order One, *Respecting the Procedures of the Council*, the Committee's Terms of Reference, the role of the Municipal Clerk's Office in supporting the Committee, the role of a staff liaison, and the process to request a staff report and presentation.

Claire Gillivan, Solicitor spoke to the Committee's Terms of Reference and provided an overview of the Committee's role and objectives, the role of the Executive Standing Committee, how to bring forward a notice of motion, and the purpose of an agenda and agenda review.

MacLean and Gillivan responded to questions of clarification from the Committee regarding the Terms of Reference and reporting provisions to the Executive Standing Committee.

5. WORK PLAN BRAINSTORMING

Becca Bishop, Community Developer and Lama Farhat, Legislative Assistant provided an overview of the objectives and duties of the Youth Advisory Committee and responded to questions of clarification from the Committee.

In response to the overview, the Committee discussed and proposed the following topics of interest that may develop their 2023 Work Plan:

- Housing: affordable housing, educational resources for newcomer youth, access to student housing;
- Youth wellbeing: mental health supports and resources, social and safe spaces for youth, supports for newcomer youth, supports for youth self reliance, education on diversity and inclusion and anti-black racism;
- Youth engagement and involvement in HRM activities:
- Municipal elections: youth involvement in elections, education on the role of the municipal government and its services;
- Food insecurity;
- Climate action; and
- Safety in schools.
