## 9.2 COMMITTEE MEMBER UPDATES 9.2.1 Michael Lamplugh

Michael Lamplugh noted that a tour of the new compost facility on Evergreen Street was conducted on October 5, 2022 and staff and Councillors Stoddard and Cuttell were in attendance. Lamplugh further highlighted that Halifax Regional Council on June 20, 2023 passed CA 0138 resolution which expands the boundary of the Beechville community to include parts of the St Margaret's' Bay Road and Evergreen's Place. Furthermore, Lamplugh noted that Jan Macneil, a long-standing member of the Committee, resigned in 2022 and thanked McNeil for their work. Lamplugh advised that a site visit was conducted in June 2023 at the walking trail behind Prospect Road Community Centre to check in on the ongoing project.
