- 10.1.1 Halifax Regional Police 2024/25 Business Plan and Operating Budget Framework Presentation

The following was before the Board:

Staff presentation dated October 18, 2023

Acting Chief Don MacLean, Halifax Regional Police gave a presentation and responded to questions of clarification from the Board.

John Traves, K.C., CD, Executive Director of Legal & Legislative Services/Municipal Solicitor/Chief Governance Officer responded to questions of clarification from the Board regarding the Board's options for addressing specific budget items, opportunities for further input and the timeline for the budget process.

Acting Chief MacLean, Deputy Chief Reid McCoombs, Operational Support, and Chief Superintendent Jeffrey Christie, Officer in Charge, Halifax District Royal Canadian Mounted Police (Halifax District RCMP) responded to questions of clarification from the Board regarding training for new officers, collaboration with local hospitals and potential implementation of body-worn video across Halifax Regional Police. Chief Superintendent Christie noted at the federal level the RCMP would be continuing to develop a strategy for body-worn video.

Jerry Blackwood, Executive Director of Finance and Asset Management/Chief Financial Officer responded to questions of clarification from the Board regarding the budget framework, budget timelines, opportunity for public participation, and provided clarification on capital versus operational budgets. Blackwood noted the process of allocating funds to upgrade the Halifax Regional Police headquarters.

Bill Moore, Executive Director, Community Safety responded to questions of clarification from the Board regarding the collaboration with Halifax Regional Police and Halifax District RCMP to align with public safety. Moore noted alternate approaches to address homelessness, mental health responses and work being done to implement transition centres.
