The Committee received a presentation on the 2026-2030 Strategic Plan and noted the following:

- Lack of inclusion of indigenous communities;
- Lack of plans to address homelessness or to collaborate with the Province on the issue;
- The possible role of the Committee to provide feedback regarding safety on public transit through a gendered lens;
- Lack of inclusion of affordable housing;
- Newcomers only being mentioned when connected to productivity and skilled labour; and
- The importance of the use of plain language.

Councillor Hartling, Councillor Hinch, Amy Brierley, Social Policy Strategist and Elizabeth Macdonald, Legislative Assistant responded to questions of clarification from the Committee.

9.2 COMMITTEE MEMBERS

9.2.1 Regional Council Update

Councillor Hartling provided an update on Halifax Regional Council's recent activities and spoke to the proposed Regional Plan. Hartling noted the Province rejected the municipality's submission of the updated Regional Plan and explained that the current 2014 Regional Plan, last amended in May 2025, remained in effect. Hartling spoke to the ongoing work between Halifax Regional Municipality and the Province of Nova Scotia on the Regional Plan.

Councillor Hartling and Councillor Hinch responded to questions of clarification from the Committee.

The Committee discussed potentially providing feedback on the Regional Plan in the future.
