Later in the meeting, Nathan Tuck, Chair noted that Transportation Standing Committee passed a motion on August 21, 2025 requesting a staff report outlining the requirements and expected impacts of eliminating transit fares for ferry rides and bus trips crossing the MacDonald Bridge when pedestrian and cycling facilities on the MacDonald Bridge were made unavailable to the public, for Transit users who normally rely on those Active Transportation facilities.
