13.1.1 Case 20945: Development Agreement Discharge - 874 Sackville Drive, Sackville

Melissa Eavis, Planner II presented the applcation of Armco Captial Inc. and Emscote Ltd. to amend the development agreements for Royale Hemlocks to allow for the subdivision and development of remnant parcels of land along Cutter Drive and Starboard Drive, Halifax

Members discussed the motion with staff responding to questions on the advantages and disadvantages of proceeding with established planning applications with/without hearing from the Planning Advisory Committee. Members sought clarification on composition of the North West Planning Advisory Committee (NWPAC) with the inclusion of District 13 and the remainder of District 16. Kevin Arjoon, Municipal Clerk explained that there are four terms coming to an end in the Fall, 2017 for NWPAC. Although there is no requirement under the Committee's Terms of Reference to ensure each area is represented, attempts would be made to try and balance the newly expanded NWPAC.
