# 7.1.1 Case 19117: Development Agreement for 525-unit Mobile Home Park on the Old Truro Road, Enfield

# 7.1.2 Case 22143: Development Agreement for a 176-unit residential subdivision (Open Space Design Development) near Charleswood Drive and Cumberland Way, Windsor Junction

The following was before North West Community Council:

A staff recommendation report dated May 5, 2020

The North West Community Council discussed the report with staff responding to questions. Some concerns were raised regarding the scheduling of virtual public hearings, especially during the summer months. Specifically, it was noted that the community will require additional time to prepare for virtual meetings. It was also noted that the public hearing for this case should not be held until September, which would allow for increased public participation given that many families go on vacation during July and August. Therefore, North West Community Council proposed an amendment to the motion to ensure that the public hearing for this case is not held during the summer months (i.e., July or August) of 2020. This was considered a friendly amendment by the North West Community Council.
