Tyson Simms, Planner III, Regional Planning presented case 20761 and responded to questions of clarification from Halifax and West Community Council.

The Chair opened the Public Hearing at 6:58 p.m. and invited the applicant to come forward and address Community Council.

Connor Wallace, **ZZap Consulting Incorporated**, spoke to both phases of the proposed development including changes made to the proposal as a result of public feedback. Wallace answered questions of clarification around building materials, the types of units being proposed, wind and parking.

The Chair reviewed the rules of procedure for public hearings and opened the public hearing for anyone wishing to speak on the matter.

Hadrian Laing, **Halifax**, would like to see improved transparency with respect to public engagement and shared a 3D model of the proposed development.

Judy Haiven, **Halifax**, feels the public engagement process lacks transparency and would like to see the decision deferred until more information is made available to the public.

Peggy Cameron, **Halifax**, spoke to how developments of this nature negatively affect the climate crisis and the affordable housing crisis.

Larry Haiven, **Halifax**, expressed opposition for the proposed development and noted this will not help the affordable housing crisis.

Judith Fingard, **Halifax**, expressed concerns around shadows, losing affordable housing as well as impacts on the climate, and would like to see the decision on this case deferred.

Hannah Bing, Halifax, is concerned about the affordable units that will be lost.

Jen Powley, **Halifax**, expressed concerns around the climate crisis and effects developments like this have on the climate.

Howard Epstein, Halifax, would like to see Community Council defer its decision on this proposal.

Beverly Miller, **Halifax**, would like to see Community Council defer its decision on this proposal and expressed concerns around the public engagement process. Further concerns were expressed around wind, traffic and the environment.

Alan Ruffman, **Halifax**, would like to see Community Council abstain from voting on the motion as an abstention is recorded as a negative vote.

Tynette Deveaux, Halifax, expressed concerns around the impacts on the environment.

Beverly Miller, **Halifax** expressed concerns around the impacts on the environment and the increased traffic on Robie Street.
