The meeting was called to order at 6:00 p.m., and recessed at 8:16 p.m. Community Council reconvened in at 8:26 p.m. Community Council moved into an In Camera (In Private) session at 8:46 and reconvened at 8:50 p.m. Community Council adjourned at 8:52 p.m.

13. REPORTS 13.1 STAFF 13.1.1 District Boundary Review – Phase Two Presentation

The following was before Community Council:

• Staff Presentation dated October 24, 2022

Liam MacSween, Elections and Special Projects Manager, Pamela Brennan and Russell Walker, members of the District Boundary Resident Review Panel gave a presentation on Phase 2 of the District Boundary Review and responded to questions of clarification from Community Council.

Public Participation

The Chair opened the floor for members of the public to speak to Phase Two - District Boundary.

David Nantes, Cole Harbour recognized the work of the District Boundary Resident Review Panel. Nantes expressed difficulties engaging with the online survey. The speaker expressed that regarding the boundaries of Cole Harbour, greater efforts should be made to ensure their continuity to reduce confusion to the residents regarding their representation and to foster their sense of community.

Lyssa Clack, Dartmouth recognized the work of the District Boundary Resident Review Panel. The speaker expressed difficulties engaging with the online survey. Clack recognized the proposed boundaries maintain community integrity of Craigburn Drive and Port Wallace. The speaker expressed concerns regarding the combination of urban and suburban communities within proposed District E. Clack expressed concerns regarding the scope of data regarding future growth relative to the date of the next district boundary review.

Glenn Bowie, Dartmouth expressed concerns regarding the combination of urban and suburban communities within proposed District E, and the need to ensure the proposed boundaries represent the fabric of existing communities. Bowie also expressed that with the new and current Business Improvement Districts, it would be valuable to work to maintain their integrity within proposed district boundaries.

Alan Blair, Dartmouth (District 5) spoke about their personal experience witnessing the growth and urban revitalization of downtown Dartmouth over 13 years as a resident. Blair expressed that they prefer a boundary which would keep the Dartmouth downtown core within one district.

Lindsay May, (District 5) spoke about their personal experience as a resident of downtown Dartmouth since 1983. May expressed that they prefer a boundary which would keep the Dartmouth downtown core within one district. May also expressed concerns regarding the size of proposed District A noting that it

would be difficult for an elected Councillor to represent several distinct communities spread across the large geographic area.

Colin May, Dartmouth (District 5) spoke about their personal experience as a resident of downtown Dartmouth. May expressed that they prefer a boundary which would keep the Dartmouth downtown core within one district but noted that they recognize that voter parity and population growth within the area may not make this a feasible option. May also expressed concerns regarding the size of proposed District A noting that it would be difficult for an elected Councillor to represent the large number of communities spread across the large geographic area. May stated that there will be frustrations expressed from most communities regarding the proposed changes, but it is important to let the Nova Scotia Utility and Review Board review the proposal and make their decision.

Carolyn Judd, Cole Harbour expressed concerns regarding proposed Districts B and C, specifically the division of Cole Harbour between proposed districts and the risk that this will divide the existing community. Judd suggested that there may be confusion if people reside in one district and own a business in another district, explaining that the prospective Cole Harbour Business Improvement District would likewise be divided between two districts. Judd also expressed concern with the shape of proposed District B which the speaker described as relatively non-contiguous. Judd expressed difficulties engaging with the online survey.

Paul Currie, Dartmouth expressed concerns regarding proposed Districts A and E. Currently, as a resident of District 1 located on Waverly Road, though the speaker accesses amenities within their community, their voting and poling location is located far away due to the size of the district. Carrie emphasised the value of convenience to residents and community fabric when considering proposed district boundaries.

Stewart Sparks, North Preston expressed concerns regarding the extent of community consultation conducted. While acknowledging that a consultation session was held within the Lake Loon and Cherry Brook area, Sparks explained that sessions should have been held closer to the centre of the African Nova Scotian communities of North Preston. Sparks suspected that this may have reduced participation. Sparks stated that they hoped the Nova Scotia Utility and Review Board would extend the deadline to ensure community participation continues.

Gary Giles, Cole Harbour spoke about their experience as a community resident with seventhgeneration roots. Giles expressed concerns regarding dividing Cole Harbour between proposed Districts B and C.

Christ Mont, Cole Harbour expressed concerns regarding dividing Cole Harbour between proposed Districts B and C, stating that this would undue past work to unify the community.

Vivian Lamar, Downtown Dartmouth expressed concerns regarding the size of some of the proposed districts. Lamar stated that if the municipality's population is growing, then the Nova Scotia Utility and Review Board should increase the number of districts, as otherwise it will be impossible for a single councillor to represent proposed District A.

Ray Gilmour, a resident of District 5 spoke about the importance of districts aligned with community fabric. Gilmour stated that they are a fourth-generation resident of their home and community and their experiences highlight the importance of avoiding dividing established communities as part of proposing new district boundaries.

Cheryl Scotland, Dartmouth expressed difficulties engaging with the online survey and the process generally. Scotland expressed a desire for a fuller community consultation process. Scotland expressed concerns regarding the previous inclusion of the Craigburn Estates community's inclusion within District 1, which had little in common with Middle Musquodoboit. Scotland noted that many neighbours did not vote in the previous municipal election due to challenges visiting their district's remote polling locations.

Scotland stated that experiences like those they mentioned made them sympathetic to residents of proposed districts in Cole Harbour.

Gerry Olwyn, Cole Harbour expressed concerns regarding the division of Cole Harbour between proposed districts and the risk that this will divide the existing community. The speaker noted that they were an intervener in 2012 during the Nova Scotia Utility and Review Board's previous review of the district boundaries. Olwyn suggested for similar reasons residents of Cole Harbour should seek intervener status if the proposed districts are submitted for review to the review board, as these would raise similar issues.

The Chair called three times for any further speakers and there were none. The Chair closed public participation.
