10.1 PUBLIC HEARINGS

10.1.1 Case 22483: Planning District 5 (Chebucto Peninsula) Land Use By-Law Amendment to rezone 801 Old Sambro Road, Harrietsfield

First Reading was given on October 12, 2022.

Claire Tusz, Planner II gave a presentation and responded to questions of clarification from Community Council.

The Chair opened the hearing and invited the applicant to come forward and address Community Council.

The hearing opened at 6:19 p.m.

Stephen Adams, Stephen Adams Consulting Services Incorporated spoke on behalf of the applicant, Civtech Engineering and Surveying Limited and stated that the proposed rezoning would permit the current auto-body business to expand and would bring the existing parking lot into compliance with the by-law.

The Chair reviewed the rules of procedure for public hearings, noted there were no registered speakers and called three times for anyone wishing to speak on the matter; there were none.

Community Council indicated support for consolidating lots 801 and 811 Old Sambro Road and amending the zoning of the consolidated lots to allow the existing business to expand. Council expressed satisfaction that the watercourse buffer would be maintained on lot 821 Old Sambro Road as it was not included in the lot consolidation and rezoning.

Kristian Curran suggested that HRM strengthen the existing by-law to

include increased fines and allow for cost-recovery. Early intervention and enforcement were also encouraged for future homecoming events. Kristian Curran responded to questions of clarification from Community Council.
