VISCOUNT RUN PARK CONCEPT PLAN

GREEN CARTS

[Sign up](#) for weekly reminders and service alerts, or print a calendar customized for your address. Collection can start as early as 7:00 a.m. but may not happen at the same time each week. You can place your green cart curbside as early as 7:00 p.m. the night before. Any carts not collected must be removed from the curb by 9:00 p.m. on the day of collection.

The municipality provides green carts and mini bins to properties that received curbside collection. Call 3-1-1 to request a bin delivery for new homes, or for repairs to a damaged cart.

Carts are assigned to the property, not the owner. If you move, the cart and mini bin must stay at the property.

CANCELLATION OF MOBILE HOUSEHOLD SPECIAL WASTE DROP-OFF EVENTS FOR MAY 2020

To further support Public Health directives related to staying home and social distancing, the following upcoming Mobile HSW drop-off events have been cancelled:

- May 2 - Sackville Transit Terminal
- May 9 - Porters Lake Transit Terminal

Future events will be evaluated on a month-by-month basis. Every attempt will be made to reschedule the cancelled events, conditions permitting.

Operation of the Household Special Waste depot (located at 20 Horseshoe Lake Drive), has also been suspended until further notice.

MESSAGE FROM DIABETES CANADA

Diabetes Canada donation bins are overflowing, and some are becoming a dumping ground for well-meaning citizens who want to support our work.

Due to the covid-19 pandemic and crucial physical distancing orders by governments that non-essential services be stopped, **the pick-up of all textile donations by Diabetes**

Canada from homes and donation bins across Canada stopped on March 23rd.

The current donations at the donation bins and, in some unfortunate instances, the **dumping of garbage at donation bins is posing a serious health and safety issue.**

Diabetes Canada has been urging the public to hold off on their bin donations until business resumes.

Diabetes Canada relies on generous charitable clothing donations as a crucial source of revenue to support the 11 million Canadians living with diabetes or prediabetes. Efforts include innovative diabetes research, supporting children and youth living with type 1 diabetes, and developing evidence-based policy recommendations to improve the lives of those living with the disease. Additionally, thanks to the donation bin business, more than 100 million pounds of textiles are diverted from landfill annually.



LIFTING OF SPRING WEIGHT RESTRICTIONS

At 11:59 a.m. on April 26th, Halifax Regional Municipality lifted spring weight restrictions on roads it oversees. Spring weight restrictions were simultaneously lifted on roads in the municipality maintained by the Nova Scotia Department of Transportation and Infrastructure Renewal.

ILLEGAL DUMPING

Call [311](#) if:

- You see debris on HRM property that requires cleanup
- You witness someone leaving garbage / recycling / debris etc. on your property or a neighbour’s property
- You see garbage on the side of a municipal road that requires cleanup

Call the [police](#) if:

- You see someone currently dumping debris and they are still in the area

Contact the [Department of Transportation](#) if:

- You see something that requires clean up on the side of a provincial road

HRM is not responsible for removing illegally dumped material from private property. Place the material curbside for collection on your [regular garbage day](#) or make arrangements for it to be removed.



CASE 22865 - 1633 SACKVILLE DRIVE

WSP is applying on behalf of the property owner (Keizer Property), to rezone a portion of 1633 Sackville Drive, Middle Sackville, from R-6 (Rural Residential Zone) to R-4 (Multiple Unit Dwelling Zone), to allow for a multiple unit dwelling with four (4) residential dwelling units.


The proposed new building is designed as a 4-unit, 2-storey, townhouse-style multiple unit dwelling with separate exterior entrances for each unit.

The permitted uses in the R-4 Zone (subject to the zone requirements) are as follows:

- Existing multiple unit dwellings in excess of six (6) units
- Multiple unit dwellings containing no more than six (6) units
- Open space uses

The area where the existing single-family dwelling is located is not intended to be rezoned. The applicant is pursuing land subdivision to enable subdividing the dwelling area from the area to be rezoned leaving the home on its own lot under existing R-6 zoning.

CAN'T PAY YOUR RENT DUE TO COVID-19

No Evictions for Three Months

The Premier has stated *"No tenant can be evicted because their income has been impacted by COVID-19 (effective for next 3 months)."*

- People are not required to be sick with COVID-19.
- Landlords may not serve a tenant with a Notice to Quit (eviction notice) until 15 days after rent was due, and Landlords should not serve anyone who has had their income impacted by COVID-19



Shopping Etiquette



You must stay home if you have symptoms.


If you must go to stores for essentials, always practice physical distancing - stay 2 metres (6 feet) away from others. Stores are keeping up with new information and carefully changing how they operate to protect customers, staff and their families.



- Be patient**
Controlling the number of people allowed in the store at one time increases physical distancing.
- Follow store signs**
Designated aisles may have become one-way, with markings on the floor. Listen to store staff. They are trained on precautions and want to ensure everyone's safety.
- Shop alone**
Fewer people in the store allows for easier physical distancing and less people potentially exposed to the virus.
- Have a detailed list**
Organize your list by aisle to limit your time in the store and traffic within the store. Avoid lingering in the aisles.
- Take only what you need**
Get enough supplies for 2 weeks in case you or a family member get ill.
- Be understanding**
Some products may be less available.
- Shop with your eyes**
Avoid touching items that you do not intend to buy.
- Be patient at the cash**
Some stores may close every other cash to allow for physical distancing. Wait your turn. After placing your items on the conveyor belt, move to the end of the conveyor belt. Do not wait in front of or near the cashier.
- Use clean bags**
If you are allowed to use your own bags, make sure they are clean. Stores may only allow staff to pack items using store-provided bags.
- Pay with plastic**
Use tap if you can and avoid paying with cash to reduce the surfaces you touch and decrease money exchanges.
