Each fiscal year, all districts are allocated District Funds that Councillors have the ability to designate for community benefit. #### 2023/24 Planned Capital Work in District 1

The municipality works to keep streets and sidewalks in top shape by providing maintenance services for streets and sidewalks from May –November, during construction season. To report a maintenance issue, call 311. Here are the projects planned for District 2.

Staff will make every effort to design, tender, and construct these projects in 2023. However, unforeseen circumstances may arise which could impact the scheduling of these projects, and potentially cause delays.

#### **Parks Projects**

The following projects have been approved for 2023/24 in District 1:

MacDonald Park – ball diamond lighting - design (\$75,000). Middle Musquodoboit Park development (\$600,000).

The concept plan includes a swing set, playground equipment for those aged 2-5 and 5-12 years old, a spray feature, an open lawn to be used as a play field, various seating options, shade trees, shrubs for privacy from neighbouring properties, rail fence to protect park users from the road, a light feature, waste receptacles, bike rack, a potential path connecting the park to the existing Cornerstone Park, and a driveway for maintenance vehicles.

**Carrolls Corner Community Centre Park** – playground recapitalization: swings already installed - (\$40,000)

#### **Active Planning Applications**

Case 21460 - Residential Development Opportunity Site C, south of Ingram Drive and west of Highway 102, Fall River

Application by KWR Approvals Inc., on behalf of Perry Lake Developments, for a Residential Development Opportunity at Site C, south of Ingram Drive and west of Highway 102, Fall River to allow three (3) Multiple Unit Dwellings each containing 40 dwelling units for a total of 120 units off of Ingram Drive.

Current status: On October 3, 2022, North West Community Council defeated the Notice of Motion to the Development Agreement. At a public hearing on November 8, 2022 Halifax Regional Council refused to approve a request to amend the District 14 & 17 Municipal Planning Strategy to remove the requirement for a road connection over the CN rail line to Cobequid Road.

This decision has been appealed to the NS Utility and Review Board. The outcome of this process is still pending.

#### Case 22009 - Aerotech Business Park

Planning & Development is working to update the zoning forthe Aerotech Business Park and surrounding lands within the Airport Industrial Designation. This project includes introducing new zones that will protect and support these valuable industrial lands.

**Current status:** Review ongoing by planning and development staff.

#### Case 22195 - 19 McPherson Road, Fall River

Application by KWR Approvals Inc. to amend the policies for Block B of the River-Lakes Secondary Planning Strategy (RLSPS), and also to amend the Land Use By-law (LUB) to enable a development agreement on a portion of Block B in Canal Court, Fall River.

**Current status:** Adjacent property owners will be notified of public consultation. A sign has been posted by the applicant on the subject site advertising the Planning Application. Staff will undertake a detailed review of the application and undertake public consultation prior to sending a recommendation report to Halifax Regional Council. Prior to any considerations on this matter, Regional Council is required under the Halifax Regional Municipality Charter, to hold a Public Hearing. At that time, an additional opportunity for public feedback is provided. Notices of the date, time and location of the Hearing will be advertised in the future.

#### Case 22670 - Conrad Quarry Lands Rezoning

A Regional Council initiated project to consider industrial and highway commercial development on the Conrad Quarry lands (PID: 00276105; 00276188; 00275966; 40174286 and 41168279).

**Current status:** On Tuesday, February 15, 2022, Halifax Regional Council held a virtual public hearing and approved the application.

### Case 24242 - 195 Old Post Road, Enfield (Ledwidge Lumber)

Sunrose Land Use Consulting is applying to amend the Planning Districts 14 and 17 (Shubenacadie Lakes) MPS and LUB to rezone portions of 195 Old Post Road, Enfield. The applicant wishes to construct a biomass power plant fueled by woody residues from the existing forestry operation. The applicant also wishes to ensure the existing operation (outdoor storage of logs) be applied with an appropriate zone. The Site Plans outline the development proposal in detail, and include information related to the proposed building, its height, parking locations, and driveway access.

**Current Status:** Municipal staff are drafting a report with recommendations about the development, which will be presented in front of Halifax Regional Council.

### PLANAPP - 2023-00673 (Former Case 23188) - 3136 & 3124 Hwy #2, Fall River

Application by KWR Approvals Inc., to enter into a Development Agreement (DA) at 3136 & 3124 Hwy #2, Fall River. The property is designated River-lakes Village

Centre Designation of the RLSPS within the MPS for Planning Districts 14 and 17 and is zoned Village Main Street (VMS) under the LUB.

The applicant is seeking approval 12 townhouses and to retain occupancy of one residential structure by DA. In order to achieve this the applicant proposes to demolish an office and residential structure on one of the subject properties

**Current status:** Adjacent property owners will be notified of public consultation. A sign has been posted by the applicant on the subject site advertising the Planning Application. Staff will undertake a detailed review of the application and undertake public consultation prior to sending a recommendation report to North West Community Council. Prior to any considerations on this matter, North West Community Council is required under the Halifax Regional Municipality Charter, to hold a Public Hearing. At that time, an additional opportunity for public feedback is provided. Notices of the date, time and location of the Hearing will be advertised in the future.

#### **HalifACT**

HalifACT is one of the most ambitious climate action movements in Canada. It's our community response to the climate crisis that will build a more resilient and healthy future in Atlantic Canada while preparing for current and future climate impacts.

On June 23, 2020, Halifax Regional Council unanimously adopted HalifACT – a transformational plan to achieve a net-zero economy by 2050. The municipal budget included a residential and commercial property tax bill increase of 4.6 per cent. Of that 4.6 per cent increase, three per cent was allocated towards the Climate Action Tax which directly supported HalifACT.

The Climate Action Tax funded many important projects, such as electric vehicles and buses, net-zero buildings, and the installation of public electric vehicle chargers.

This funding will improve the resilience of communities and infrastructure against the impacts of climate change by supporting initiatives around flood mitigation, storm water management, food security and emergency preparedness.

#### **URBAN FOREST MASTER PLAN**

As part of HRM's Urban Forest Master Plan implementation, approximately 3,000 trees are to be planted from May to October 2023.

A tree may be planted in the right of way space in front of your home, either between curb and sidewalk or between curb and private property. Street trees are an essential part of our urban forest. They are an air filter for the city, a traffic calming and stormwater management tool, protection from the heat, wildlife habitat, a safety barrier between vehicles and pedestrians, and key to combating climate change.
