LED STREETLIGHT CONVERSION PROJECT

The LED Streetlight Conversion Project began on October 5th. To help make our communities safer and more energy efficient, the Halifax Regional Municipality is moving forward with a project to replace all traditional high-pressure sodium streetlights in the Halifax region with energy efficient LED technology.

The municipality is responsible for more than 44,000 streetlights across the region. About 7,000 of those have already been converted to LED technology through spot replacements and smaller conversion projects. All remaining streetlights will be converted over an 18-month period.

LED streetlights are widely popular for their energy efficiency, long lifespans and reduced maintenance requirements. Once complete, the conversion to LEDs will save the municipality about \$5 million a year — savings that will fully fund the conversion work and continue to accrue after the project is paid for.

As they're replaced, each LED streetlight will be equipped with adaptive technology installed by Silver Spring Networks. Once fully implemented, the system will monitor the streetlights in real-time and send alerts when maintenance is required, allowing the municipality to better manage streetlight maintenance and eliminating the need for residents to report outages. The old streetlight bulbs will be properly disposed of by Dan-X Recycling in Dartmouth, diverting that waste from the landfill and keeping harmful chemicals out of our environment.

WINTER OPERATIONS



Streets are prioritized based on a number of criteria including how often they're used by commuters, access to important infrastructure like hospitals and schools, and whether they're on major bus and traffic routes. The municipality has classified all routes and will service them (salt, sand and plow) in order of priority.

When the parking ban is in effect, it is only enforced during declared snow and ice events, from 1:00 a.m. to 6:00 a.m. Residents have a responsibility to secure off-street parking during the winter months and seek information about when the parking ban is enforced. The easiest way to stay informed is to sign up for notifications by filling out an online registration form at halifax.ca/snow/parkingban/, calling 311 or by emailing contact@halifax.ca.

If you signed up last season, you will automatically be included. Residents who subscribe will receive timely messages by phone, email, and/or text message about the status of the ban.

RESIDENTIAL PROPERTY TAX EXEMPTION

The program is now open for the current 2015/16 fiscal year. Halifax Regional Municipality can help homeowners pay their property tax through a payment plan, a property tax rebate, or deferral of property taxes (payment is put off to a later date). These programs are available to all homeowners with a combined household income of \$32,000 or less a year who live within the boundary of Halifax Regional Municipality. There are different programs to choose from depending on a person's needs. It is important that you know what choices exist.

You can have your exemption award direct deposited to your bank account by completing the payment registration form and returning it with your application and a void cheque.

The 2015-16 Residential Property Tax Exemption Application form and a guide are available each year from municipal Customer Service Centers, the municipal Call Centre, the Halifax Regional Municipality Financial Services Department and on our website. Each year an advertisement is placed in the newspaper to inform the public that the program is open for applications. After you have filed your personal income tax for the current income tax year 2014, filed in April 2015, and have received the Notice of Assessment back from Canada Customs and Revenue Agency confirming your income, you can then complete your application. A copy of this must be submitted with your application form as confirmation of income is required.

HEATING ASSISTANCE REBATE PROGRAM

The Heating Assistance Rebate Program (HARP) provides help to lower-income Nova Scotians with the cost of home heating.

You qualify for this program if you pay a heating bill at your current address and meet ONE of the following criteria:

- live alone with an income of \$27,000 or less;
- live with others and have a combined income of \$42,000 or less;
- receive Income Assistance from the Department of Community Services, OR;
- receive the Guaranteed Income Supplement from Service Canada.

You must apply by March 31, 2016 to receive a rebate.

2015 HALIFAX EXPLOSION 100th ANNIVERSARY GRANTS PROGRAM

FAIRVIEW URBAN FOREST NEIGHBOURHOOD

New street trees arrived in our area in November! Halifax Regional Council approved HRM's Urban Forest Master Plan (UFMP) in 2012. Our urban forest consists of all trees within the urban core, including street trees, park trees, and trees on private and public land. The goal of the plan is to ensure a sustainable future for our urban forest and to create awareness about the many benefits that we all gain from the trees in our neighbourhoods. This November, 40 new street trees were planted in the Fairview Urban Forest Neighbourhood on Adelaide Avenue. Seven hardy tree species suitable for fall planting were selected. In years to come these trees will beautify the neighbourhood and grow tall to form a protective canopy cover.

The progress of the UFMP street tree planting project is being monitored by faculty and students from Dalhousie University's School for Resource and Environmental Studies (SRES). The Dal monitoring crews evaluate the condition of our new street trees and note any diseased or dead trees to be removed under the replacement warranty provided by our tree planting contractors. In the meantime, please remember that you can report street tree damage to our Citizen Call Centre at 311.
