Artificial Turf Replacement at Mainland Common

The Halifax Regional Municipality is advising residents that work is now underway to replace and expand the artificial turf at the Mainland Common all-weather fields in Halifax.

This work will require a retaining wall to be constructed adjacent to the Mainland North Linear Parkway. Construction equipment will need to access the trail from Westridge Drive and the work may temporarily affect pedestrian access along the trail in early September.

As well, temporary fencing will be installed to separate the nearby off-leash park from the construction area, reducing the size of the field area for the dogs. The fencing will be removed once the work is complete; however, some of that space will become part of the expanded all-weather facility.

The work near the Linear Parkway is expected to continue until the end of September, while the turf replacement will take longer. The all-weather fields

will be closed for the duration of the replacement. The municipality regrets any convenience this closure or the construction may cause.

Proposed Schmidtville Heritage Conservation District

The Halifax Regional Municipality is currently working on establishing a Heritage Conservation District in Schmidtville, the Halifax neighbourhood generally bordered by Morris Street, Brenton Street, Dresden Row, Birmingham Street and Clyde Street.



Blue Mountain Birch Cove Lakes Trails

Project (submitted by the BMBCL Trails Group)



The Blue Mountain-Birch Cove Lakes Wilderness Area (BMBCL) is a spectacular near-urban wilderness located on the doorstep of Halifax. The site is now comprised of public land totaling approximately 1700 hectares recently expanded, located to the west of Halifax-Bedford urban areas and Highway 102. The area is roughly bounded by Cox's and Fraser's Lake and Timberlea subdivision to the west, Kingswood subdivision to the north, Kearney Lake to the east and Bayer's Lake Business Park to the south. Our vision is to create trails within the BMBCL Wilderness Area and the adjacent crown lands located at Maskwa Aquatic Club with a focus on trails originating from the northeast region of the Wilderness Area. The planned trails will provide the public with access to one of the largest wilderness areas in Nova Scotia while reducing the impact on the environment. On September 17, our Consultant will be presenting the Trail Plan and will be welcoming input and discussion. The 2008 Community Facility Master Plan (CFMP) provided strategic direction and recommendations related to community/recreation facility development, and provided direction related to the protocol for budget and project development. The 2008 CFMP is currently being updated, and will be presented to Regional Council in early 2016. It will be utilized as the strategic guiding document to enhance the quality of life of citizens through the provision of sustainable, planned, accessible and appropriate community facilities.
