WEEKLY GREEN BIN COLLECTION

Last year was the first summer that weekly green-bin collection was introduced across the entire municipality. This additional service is available to all households commencing on Wednesday, July 2nd and continuing through the summer months until Friday, August, 29th. During this time you may place your green-bin at the curb every week, even if it's not full. Collection can commence as early as 7:00 a.m. so be sure to have your bin at the curb by that time.

Green-bin collection will return to the regular two-week collection schedule on August 30th.

PROSPECT ROAD BUSINESS ASSOCIATION

The Prospect Road Business Association (PRBA) has experienced tremendous growth since its inception with membership continuing to grow. The objective of the Association is to be a collective voice to promote and support local business. Most members reside in the community and actively refer and promote membership in the PRBA to neighbours and friends. A Facebook page has been activated and is used by business owners and the community. There is also an established website (www.prba.ca) with a Business Directory. The Business Directory is a work in progress with hopes that it will become the "Go To" spot for the Community to find LOCAL solutions to their needs.

The PRBA's community involvement has become more active as membership grows. With funding support provided through the District 11 Capital Funds, joint efforts include: the Prospect Road Beautification projects (Christmas wreaths / hanging flower baskets) and a new initiative to provide crosswalk flags at two local crosswalk locations. The PRBA has also participated in the Prospect Road Community Centre's anniversary and the Brookside Community Homeowners Association (BCHA's) indoor yard sale.

Included in the Membership Fee (tax deductible) is a profile on the Business Directory, a monthly meeting opportunity to network with other business owners and; new this fall free training/support on Business and Business Owner issues. The PRBA meets monthly at the Prospect Road Community Centre.

PROSPECT ROAD - MANAGING ADVERTISING SIGNAGE

In my previous Newsletter I provided a detailed background on the issue surrounding the plethora of unauthorized advertising signage along provincial secondary-highway, Route 333, (Prospect Road). At that time, municipal staff was working on a draft By-Law which has now been signed-off by the Province with a few minor conditions. Once final approval is received, HRM staff will use provisions of the by-law to address signage in the prohibited zones.

DISTRICT FUNDS

The District Capital Fund (\$94,000 annually) is a centralized program, which provides partial or full funding of HRM capital projects to non-profit community groups at the discretion of a District Councillor. This fund has two primary goals: completing small-scale HRM projects not included in HRM departmental or capital budget processes, and providing a simple and responsive method of providing modest donations and grants in support of local neighborhood volunteer initiatives. As always, I try to ensure that as many community groups and organizations as possible receive some level of funding. If you have an idea, project or initiative that you would like considered, you will find the application form at: halifax.ca/councillors/councillor

The District Activity Fund (\$4,315.50 annually) is managed by HRM Finance and administered by staff at the Councillors' Support Office. The fund, at the discretion of a Councillor, provides modest cash grants, most of which would either be ineligible for the HRM Community Grants Program or too small to be well served by the program's decision-making process and time frame. Policies and procedures for this program guide councillors and staff on appropriate types of eligible expenses. These funds are for smaller-scale community events/activities or funding for local organizations such as sport teams. Requests for funding must be submitted in writing to the Councillor explaining the project and how the funds will be used.

RESIDENT'S SPECIAL EVENT GROUP INSURANCE COVERAGE

In response to the issue of residents who wish to hold events but cannot find affordable liability insurance coverage, HRM has worked with Aon Reed Stenhouse to create a Resident's Special Event Group Insurance Coverage Policy available through Aon. This policy will provide affordable liability insurance coverage for a variety of events and will be available to residents shortly. CHANGES TO CURBSIDE COLLECTION

GARBAGE

- A maximum of 6 regulation plastic bags (clear bags) including 1 privacy bag in the 6 bag limit per residential single unit collection
- A privacy bag can be a standard solid colour bag (black/green/opaque)
- All bags may be placed in a standard size garbage can for storage/privacy.
- A maximum of 4 regulation plastic bags (clear bags) including 1 privacy bag in the 4 bag limit per unit (up to 6 unit multi-residential property eligible for curbside collection)

RECYCLING

Boxboard is now to be placed with the paper or cardboard; however, you may continue to use boxboard as a kitchen-scrap catcher and deposit in the green-bin when used for this purpose.

LEAF & YARD WASTE

Use Kraft paper bags for excess leaf and yard waste instead of plastic bags. Leaf and yard waste is still permitted to be placed in the green cart. Grass clippings will be banned from curbside collection in favour of grasscycling and/or backyard composting. No grass clippings will be collected curbside.
