# MUNICIPAL PLANNING STRATEGY AMENDMENTS FOR 10 HECTARE LOTS

At the October 4<sup>th</sup> meeting of Regional Council, a staff report recommending public participation and possible amendments to the Regional Municipal Planning Strategy (MPS) for development on 10 hectare lots came forward, and at this week's Council meeting we set the date for a public hearing to amend the MPS and applicable community land use by-laws that prohibit development. The public hearing will be on December 13<sup>th</sup> 2016 at 6:00 p.m.

The *HRM Charter* allows lot sizes of 10 hectares or more to be created outside of the municipal subdivision approval process. This exemption is generally intended for resource uses such as farming or forestry. However, in recent years it has become more common for people to utilize the exemption with the intent of creating such lots for cottage or residential development. Although such lots can be created without meeting subdivision bylaw or Land Use Bylaw (LUB) requirements, development permits will only be issued if the development meets LUB requirements.

The municipality has heard from several landowners in recent months with questions and concerns related to development on lots of this nature. For more information about this issue, see our <u>website</u>.

## DRAFT CENTRE PLAN RELEASED

The Centre Plan will shape the Regional Centre for our future, serving as a blueprint for smart development by providing clarity on how and where growth should occur.

Last month, our Planning and Development team released the proposed urban structure for the Regional Centre. The urban structure considers existing development and land uses, and reflects a vision for how to grow in the Regional Centre over the next 15 years.

We are releasing the draft plan in installments to allow the time for thoughtful, considered review and public input in relation to each section of the plan. For more information, check out the Centre Plan <u>website</u>.

# POLICE WARN CITIZENS OF RECENT SCAMS

Investigators in the Financial Crime Unit of the Integrated Criminal Investigative Division are warning citizens about three recent scams; an email scam that claims to be from police regarding an overdue traffic ticket, a telephone prize scam claiming to be Publishers Clearing House and an online romance scam.

Investigators remind citizens to be suspicious of anyone asking for financial information by e-mail or over the phone. Refrain from providing personal information, whether the solicitation occurs by telephone, email or in person, unless you have initiated the contact or you are certain of the identification of the person and the legitimacy of the organization they claim to represent. Providing personal information such as your Social Insurance Number (SIN) and date of birth could lead to identity theft.

If you've lost money or provided personal information as a result of these or any other scam, please report the matter to your local police agency. There is no need to call police to report that you've been contacted in relation to these scams if you're not a victim. ## HALIFAX WATER STORMWATER RATE

#### **HEARING**

Since July 2013, Halifax Water has had a separate stormwater charge as approved by the Nova Scotia Utility and Review Board (NSUARB). Previous to this date, stormwater was included in a combined wastewater/stormwater charge initially levied by HRM in 1997 and continued by Halifax Water in 2007 after wastewater and stormwater assets were transferred from HRM.

On October 31, 2016 Halifax Water filed an application with the NSUARB to adjust the rates, rules and regulations regarding stormwater service to reflect a new cost of service approach. If this application is approved, many customers will see their rates decrease based on a new tier level system.

A public hearing will take place the week of January 23, 2017. For more information, see their <u>website</u>.

How billing of the stormwater Right of Way charge, currently charged through your property tax bill, is paid is being reviewed by Regional Council. You can find the most recent staff report <u>here</u>.

## **OFF SEASON BURNING RULES**

October 16th to March 14th is the off-season for outdoor burning restrictions. During this period, the provincial burn map is not active but there are off-season burning restrictions in place.


Take a moment to find out whether your property requires a permit to burn by checking out our <u>website</u>. If your property is serviced with municipal water and sewer, then you are in a Permit Required Zone. If you are in a Permit Required Zone, you must print and fill out a <u>municipal burn permit</u> or <u>campfire</u> <u>permit</u> and have it with you while burning. You must also have 23 metres' clearance from any building and burning can only take place from 8:00 a.m. until midnight.

If you live in rural parts of the municipality (No Permit Zones), campfires are allowed throughout the year and would need to be a minimum of 4.75 metres from any dwelling or accessory building. Campfires cannot be larger than .5 metres (1.6 feet) in diameter.
