HRM Focus Pedestrian Safety

In light of the number of pedestrian incidents in the HRM, I brought forth a motion to Regional Council on January 29th, and Regional Council approved a request for a staff report providing the information requested, before the end of fiscal year 2012-2013.

One of the responsibilities of Halifax Regional Council is to "develop and maintain safe and viable communities". With growing concern and increased pedestrian - vehicular incidents, HRM needs to better ensure, and be seen as ensuring, that pedestrian safety is an ongoing focus. My motion is summarized as follows:

Council directed staff to provide a report which provides:

- An understanding of how HRM focuses and performs on all factors related to pedestrian safety - HRM engineering, public education, law enforcement, public engagement and evaluation:
- HRM pedestrian safety statistics and how HRM statistics compare relative to other municipalities; and
- -A short-term HRM action plan to address pedestrian safety and any impacts on the 2013-2014 budget.

consideration by Regional Council, a long-term comprehensive HRM pedestrian safety action plan to help ensure, and to be seen as ensuring, overall pedestrian safety for HRM citizens based on:

- -The analysis of factors which may be contributing to pedestrian accidents;
- Options considering both process and organization structure that focuses on engineering, education, enforcement, public engagement, such as a Crosswalk Safety Advisory Committee, overall evaluation, policy and legislation, interagency/ departmental coordination and cooperation elements;
- A mechanism for continuous reporting and evaluation of the foregoing; and
- Ongoing budget impacts to the proposed action plan.

HRM and HRM Partners in Policing have recently launched a pedestrian safety campaign. The campaign, "Distractions Kill", aims at bringing awareness to drivers and pedestrians about the importance of being cautious, focused and attentive when driving and when crossing the street.

In 2012, HRM saw an increase in pedestrian-vehicle collisions and the highest rate of pedestrian fatalities in five years. Texting, chatting, surfing the internet and listening to music on mobile devices are just some of the distractions for both pedestrians and drivers that lead to inattention. The goal of the campaign is to raise awareness about the dangers of distraction in an effort to change the way people think and act, both when behind the wheel and on foot, when approaching a crosswalk.

The HRP/RCMP Integrated Traffic Unit will continue to focus on enforcement and providing traffic safety education in-person, out on the roads, as well as on social media. For more information visit: facebook.com/HRPTrafficCop or twitter.com/HRPTrafficCop.

Sackville Storm Water/Flooding Issues

In November, I, along with staff from HRM and Halifax Water hosted a public information meeting to address the flooding issues in certain parts of Lower Sackville. The meeting was well attended and a great number of issues and concerns were brought forth. Staff provided excellent information and established a general understanding of stormwater problems in the neighbourhood and reviewed current activities being undertaken. Staff also provided clarification related to flooding issues, such as environmental causes, infrastructure, and how homeowners can better protect themselves against flooding.

On, February 26th 2013, HRM Regional Council approved a proposal to start fixing some flood prone areas of HRM due to storm water. Seven other Councillors and I voted not to have residents pay for any work done in the interim period; however, the majority of Council voted to have residents cover some of the costs depending on the solution.

Staff is now looking at projects and hope to start public meetings sometime in May, with approvals by Regional Council in June. Staff anticipates at least one project will be in Lower Sackville.

As information related to funding possibilities, who will actually be involved in catchment areas, or the process itself becomes available, I will ensure it is made accessible to residents on the HRM District 15 Councillors' webpage.

Acadia Recreation Society Community Garden

Although Acadia Recreation Society had a great campaign for the Aviva Community Fund project, they were not in the top 10 and therefore did not receive the \$150,000 grant for the Inclusive Playpark. They are however, forging ahead. They have 3 more grant proposals in the works, and now have a tax number so anyone wishing to donate to the redevelopment can do so. Pending results of the grant application, it may be possible that a play structure can be purchased and installed this summer.

In the garden section they are looking for people in the community to purchase trees, large bushes, picnic tables, park benches, garbage recycling centres, etc. either in memory of someone, or sponsored by a business, family, or a person. Help with weeding and planting, or donations of good topsoil, bark mulch, crusher dust, or sods are always welcomed.

School Board Boundary Review

On March 28, 2012, the Halifax Regional School passed the following motion:

That the Board recommend to staff a grade reconfiguration for the Sackville and Millwood Families of schools as follows: the high schools accommodate the 9-12, the middle schools accommodate the 6-8 and the elementary schools accommodate the P-5 effective September 2014, and a boundary review take place for all schools within the Sackville Family of schools taking into account the new grade configurations and the existing inventory of schools as soon as possible.

When schools close or are reconfigured, it can be very emotional for both students and parents, and I understand the impact these changes may have in your everyday lives. Although School Board Reviews are strictly within the jurisdiction of the Province, HRM provides the following information for their consideration:

HRM Development Approvals works closely with the Halifax Regional School Board to ensure they have accurate information regarding development in advance of development happening. Through the subdivision and planning application processes, detailed information regarding future residential growth areas is provided to the Board on a regular basis. This information includes the affected parcel(s), unit type and number of dwelling units. The Board would then use their statistics to determine future demands on schools. When the Board is contemplating major reviews, the Board will typically consult the Municipality to verify and review projected development numbers to ensure their numbers are accurate.

Kinsmen Splash Pad

A primary goal of the Kinsmen Club of Sackville is to install a water park (Splash Pad) in Kinsmen Park, Lower Sackville to enhance community strength, promote health, recreation and family activities. The goal is to have the project started this year. On behalf of the residents of Lower Sackville, I was happy to donate an additional \$10,000 from the District 15 Capital Funds for the splash pad project.

The Splash Pad is proposed for the beach side of Kinsmen Park next to the playground area. It will provide for all ages and will include a large base pad incorporating several age specific areas and water fixtures. This project will improve the recreational facilities for our community, promoting healthy living and exercise. A splash pad is an area for water play that has no standing water (pool). This is said to eliminate the need for lifeguards or other supervision, as there is practically no risk of drowning.

Volunteer Appreciation

Congratulations and heartfelt thanks to all volunteers being recognized in upcoming volunteer award events. Winners of these awards will be identified in the next newsletter.
