Parcel D
Douglas Avenue, Halifax, Nova Scotia

All that certain parcel of land being on the eastern side of Douglas Avenue, Halifax, Nova Scotia shown as Parcel D on a plan titled "Street Closure: Plan of Survey of Parcel D, Lands of Halifax Regional Municipality, Portion of Douglas Avenue, To Be Closed, Halifax, Halifax County, Nova Scotia" bearing Servant, Dunbrack, McKenzie & MacDonald Ltd. Plan No. 7-1263-O, dated and certified by Terrance R. Doogue, N.S.L.S. on November 30, 1999. Parcel D is more particularly described as follows:

Beginning at a proposed point of curvature on the eastern street line of Douglas Avenue. Said point being distant 325.39 feet on a bearing of S 84° 26' 25" E from Nova Scotia Coordinate Monument Number 4919;

thence N 15° 45' 25" E along the eastern street line of Douglas Avenue, 32.76 feet to a deflection therein;

thence N 19° 38' 34" W along the eastern street line of Douglas Avenue, 32.76 feet to a proposed point of curvature thereon;

thence southerly along the proposed eastern street line of Douglas Avenue following the arc of a curve to the right having a radius of 102.64 feet, 63.41 feet to the point of beginning.

The above described Parcel D contains an area of 108 square feet.

Bearings are based on Zone 5, Central Meridian 64°30' West, of the Nova Scotia 3rd Modified Transverse Mercator Projection of NAD27 Geodetic Datum (1968 adjustment).
