- 12.1.1 Follow-up Review 2019 Audits

Evangeline Colman-Sadd, Auditor General, presented the Follow-Up Review of the 2019 Audits. Topics included:

- Payroll Management Follow-up Review
 - 56% of recommendations implemented
- Purchasing Card Program Follow-up Review

- o 100% of recommendations implemented
- Road and Sidewalk Asset Management Follow-up Review
 - o 40% of recommendations implemented
- Upcoming Follow-up Reviews
 - LED Streetlight Conversion Project
 - o HRM'S New Website Project
 - Fleet Vehicle Use, Car Allowances and Mileage Audit

Evangeline Colman-Sadd responded to questions of clarification from members of the Committee regarding scope of the follow-up reviews and methods of prioritization for road and sidewalk construction projects.

Evangeline Colman-Sadd outlined the follow-up review process. The Auditor General's Office outlines all recommendations that were agreed to, asks for key contacts on each of the recommendations from the Business Unit, and a management self-assessment takes place to determine which recommendations were completed. The Auditor General's Office reviews this assessment and determines what needs to be done to complete a review level of assurance, and then follows up with the Business Unit to share their findings. Evangeline Colman-Sadd noted that the Audit and Finance Standing Committee could request an implementation plan from the Business Unit that was the subject of an audit a month or two following its completion, and that this would aid in the review process.
